8 (b) The duty to exercise reasonable skill and care in providing brokerage services to you.

9 (c) The duty to provide you with accurate information about market conditions within a reasonable time if you request

10 it, unless disclosure of the information is prohibited by law.

11 (d) The duty to disclose to you in writing certain Material Adverse Facts about a property, unless disclosure of the

12 information is prohibited by law (see lines 42-51).

13 (e) The duty to protect your confidentiality. Unless the law requires it, the Firm and its Agents will not disclose your

14 confidential information or the confidential information of other parties (see lines 23-41).

15 (f) The duty to safeguard trust funds and other property held by the Firm or its Agents.

16 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the

17 advantages and disadvantages of the proposals.

18 Please review this information carefully. An Agent of the Firm can answer your questions about brokerage services,

19 but if you need legal advice, tax advice, or a professional home inspection, contact an attorney, tax advisor, or home

20 inspector. This disclosure is required by section 452.135 of the Wisconsin statutes and is for information only. It is a

26 Firm is no longer providing brokerage services to you.

30 report on the property or real estate that is the subject of the transaction.

32 list that information below (see lines 35-41) or provide that information to the Firm or its Agents by other means. At a

33 later time, you may also provide the Firm or its Agents with other information you consider to be confidential.

43 party, that it affects or would affect the party's decision to enter into a contract or agreement concerning a transaction

44 or affects or would affect the party's decision about the terms of such a contract or agreement.

46 generally recognizes will significantly and adversely affect the value of the property, significantly reduce the structural

47 integrity of improvements to real estate, or present a significant health risk to occupants of the property, or information

49 contract or agreement made concerning the transaction.
