5	brokerage services to you. Whenever the broker is providing brokerage services to you, the broker owes you, the customer, the
6	following duties:
7	The duty to provide brokerage services to you fairly and honestly.
8	The duty to exercise reasonable skill and care in providing brokerage services to you.
9	The duty to provide you with accurate information about market conditions with a reasonable time if you request it, unless
10	disclosure of the information is prohibited by law.
11	The duty to disclose to you in writing certain material adverse facts about a property, unless disclosure of the information is
12	prohibited by law (See Lines 47-55).
13	• The duty to protect your confidentiality. Unless the law requires it, the broker will not disclose your confidential information or the
14	confidential information of other parties (See Lines 22-39).
15	The duty to safeguard trust funds and other property the broker holds.
16	• The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and
17	disadvantages of the proposals.

49	is generally recognized by a competent licensee as being of such significance to a reasonable party, that it affects or would affect
50	the party's decision to enter into a contract or agreement concerning a transaction or affects or would affect the party's decision
51	about the terms of such a contract or agreement. An "adverse fact" is defined in Wis. Stat. § 452.01 (1e) as a condition or occurrence
52	that a competent licensee generally recognizes will significantly and adversely affect the value of the property, significantly reduce
53	the structural integrity of improvements to real estate, or present a significant health risk to occupants of the property; or information
