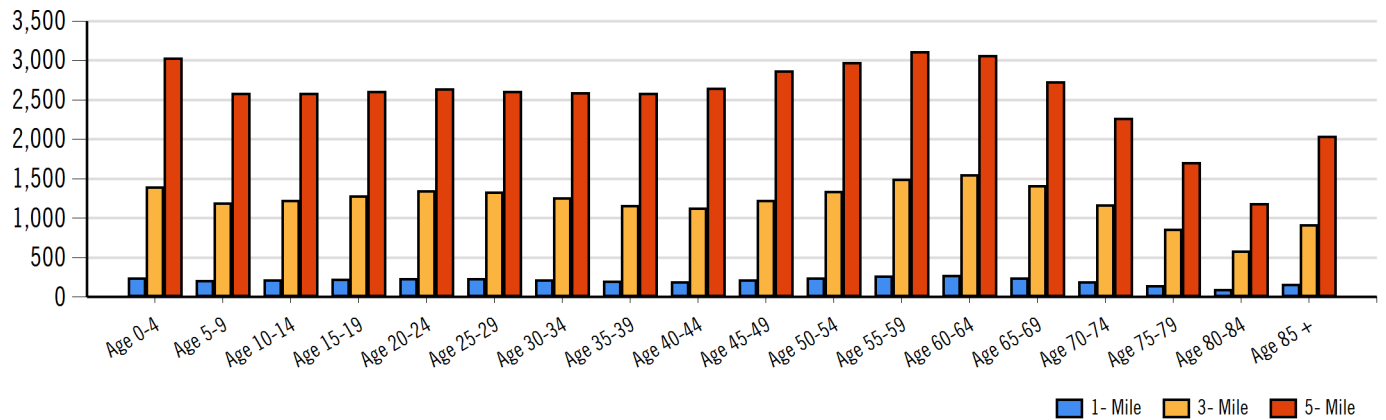

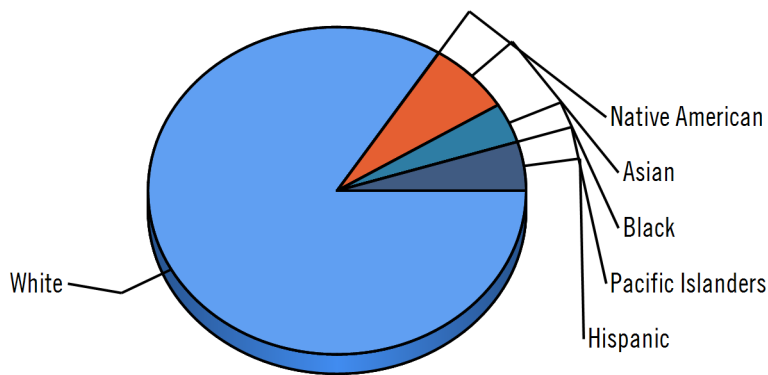

Population by Distance and Age (2018)

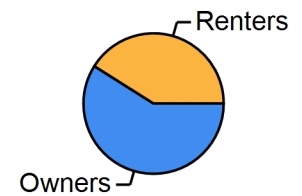


Ethnicity within 5 miles

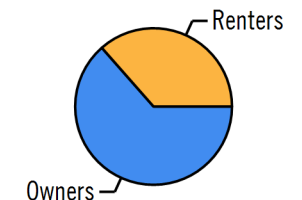

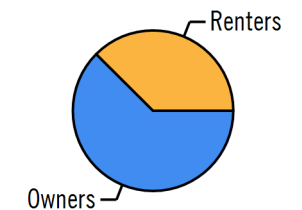
Home Ownership 1 Mile

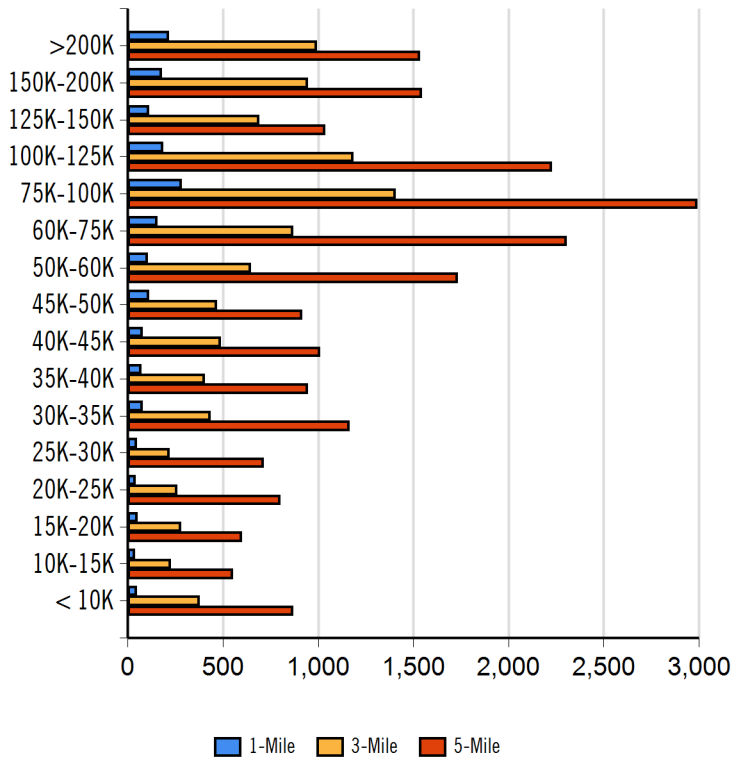
