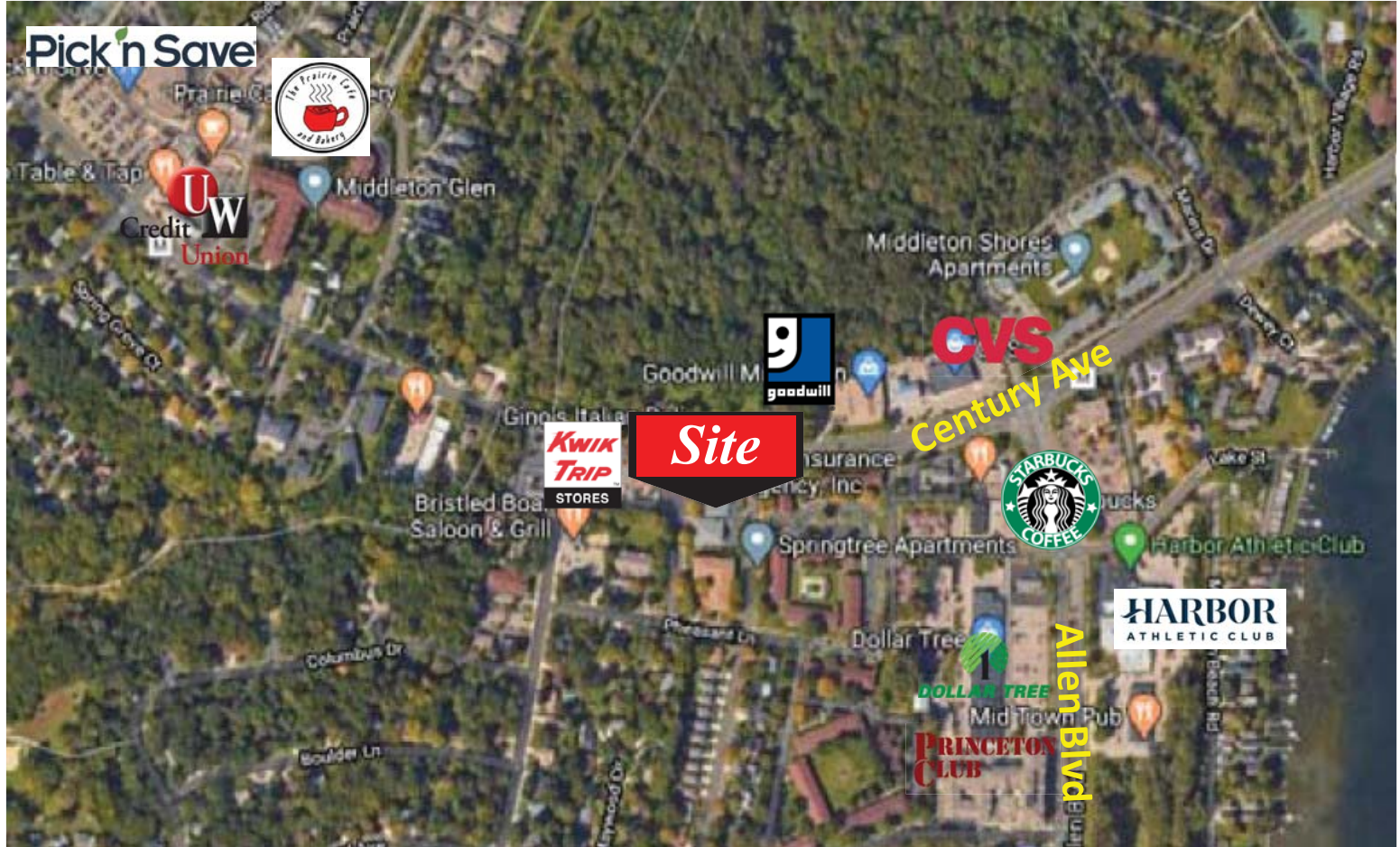

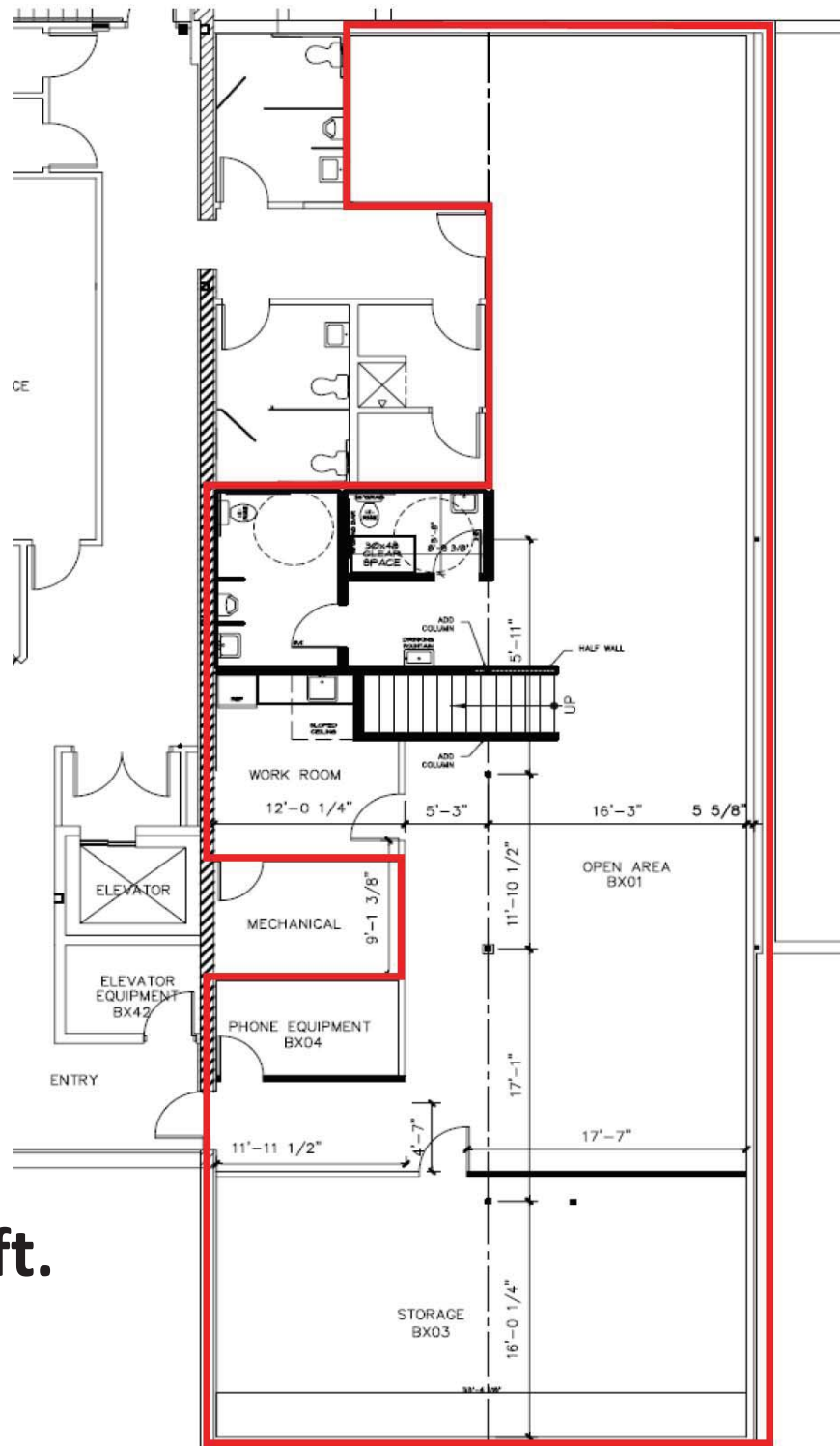

Lower Level (aka: Suite 002) Floorplan

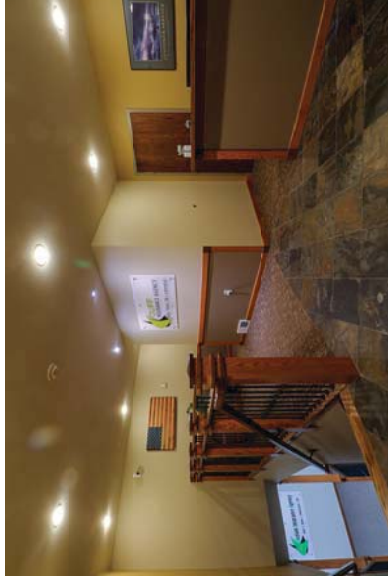
