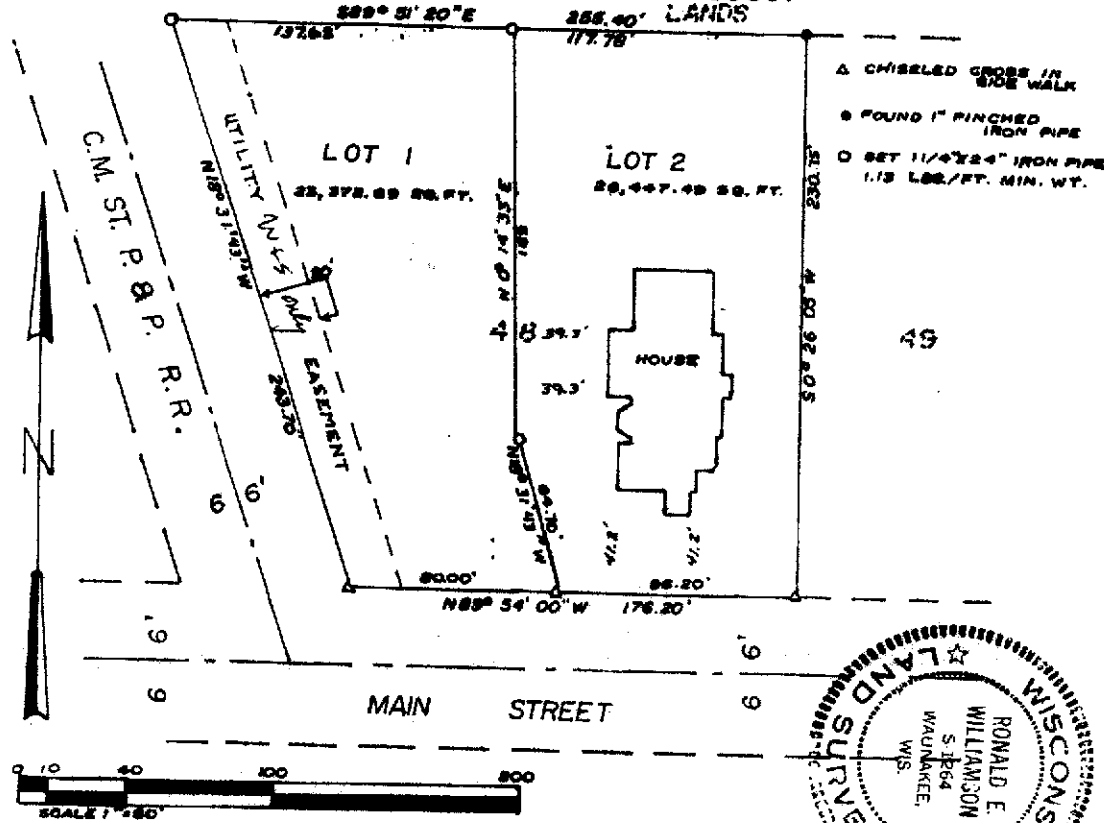

AND AMENDMENTS TO THE ZONING MAP
FOR THE VILLAGE OF ARLINGTON

RECITALS:

WHEREAS, the Village of Arlington Board of Trustees is responsible for examining, reviewing, verifying, and approving the Official Village of Arlington Zoning Map, and

WHEREAS, after examination and approval of the Zoning Map at the March and April, 2018 Village Board meetings;

NOW, THEREFORE, BE IT RESOLVED, the Village Board Trustees made the following corrections/amendments to the Village Zoning Map to show the following effective immediately;

- Reagles Street house number 218 should be corrected to read 214
- Reagles Street house number 301/303 should include lots 100 and 101 and is zoned M2 Family Duplex
- Reagles Street house number 102/104 is zoned M2 Family Duplex
- * Main Street house number 415 is zoned R3 Heavy Density Single Family and includes CUP approved at the November 14, 1977 Village Board meeting allowing for small offices and/or a beauty shop.
- Santa Maria Drive Duplex numbers should read 501 and 504.
- Pierce Street south side house number 119 should be corrected to 118.
- Correct spelling error of Santa Maria Drive on the map.

BE IT FURTHER RESOLVED, the Village Clerk-Treasurer is hereby authorized and directed to make these adjustments to the Village Zoning Map.
