

### PROPERTY OVERVIEW

213, 215, 217, 219 Deer Valley Rd is a two building multi-family investment. Each building has 8-two bedroom, one bathroom apartments. The buildings are adjacent and have a shared parking area which consists of 24 spaces. The 217/219 building has owner paid boiler heat and hot water. 213/215 has individual gas forced air furnaces and individual water heaters. All units have sleeve AC units for cooling, and electric ranges. All windows have been replaced in the past 5-15 years and the parking lot and roofs are in good condition.

Landscaping is exceptional with many flowering plants, large shade trees, raised gardens and a lawn sprinkler system. The buildings are fully occupied and have averaged around 3 months of vacancy annually (98%+ occupancy) in recent years. The present owner is hands-on and meticulous with the buildings and well known to the tenants. A 24-camera security system and locked entrances insure a safe environment for tenants.


