# Aerial Map / Notable Area Retailers



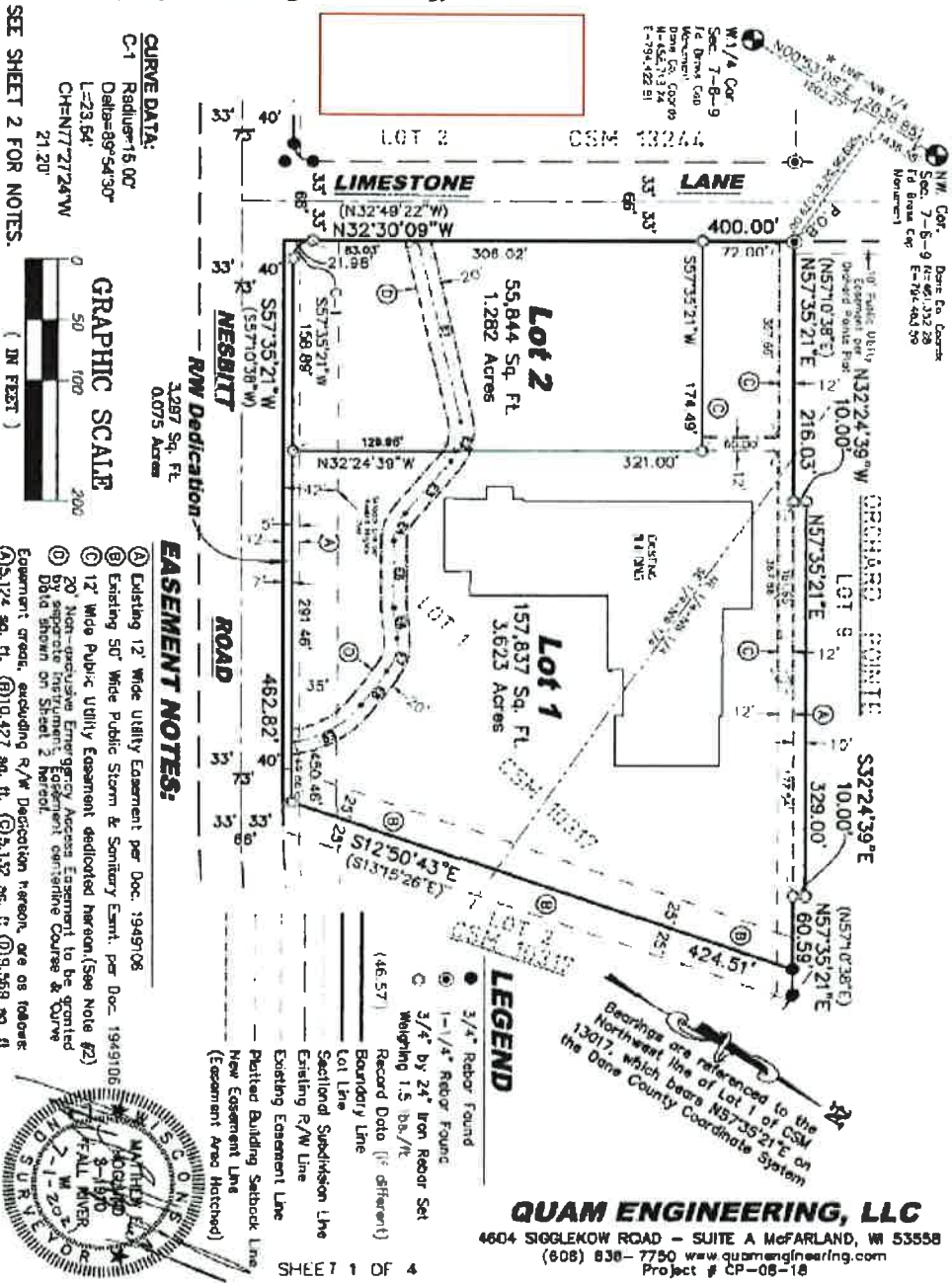

**DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS**
