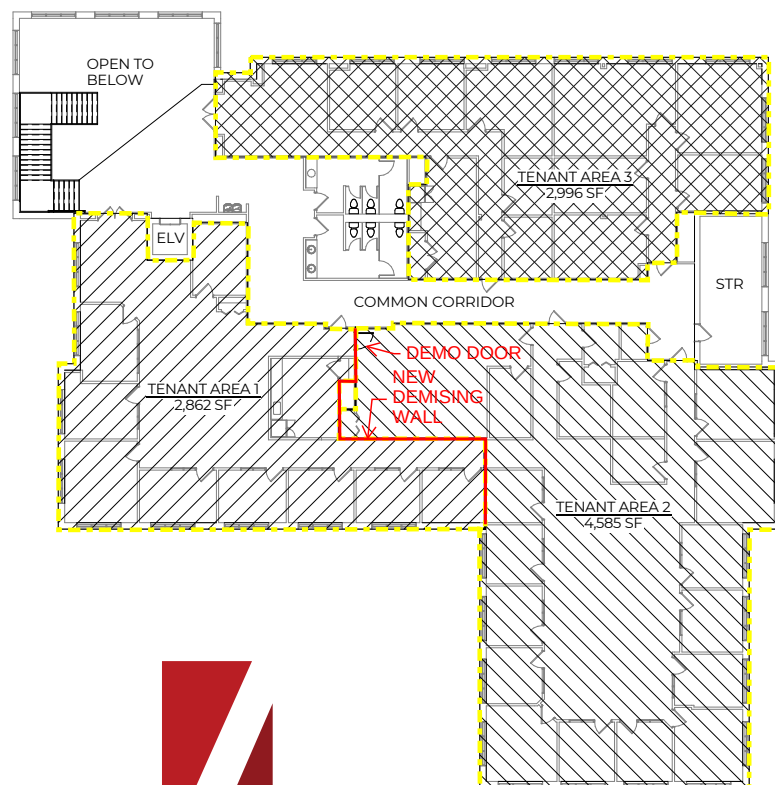

FLOOR PLAN



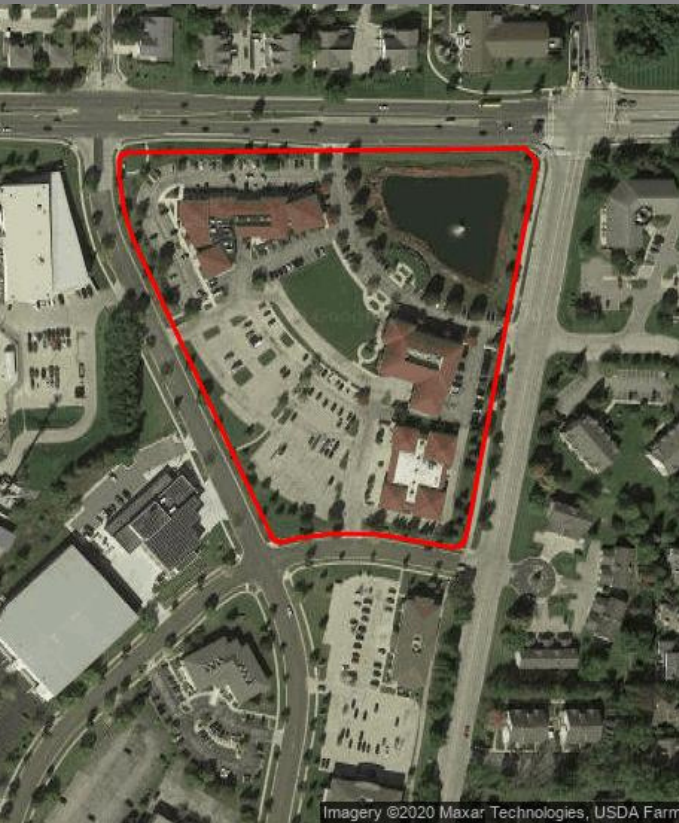
