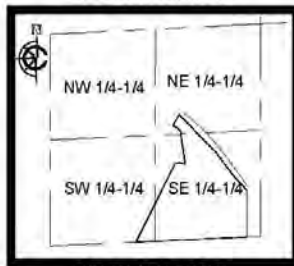

LOCATION MAP

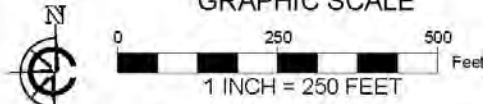

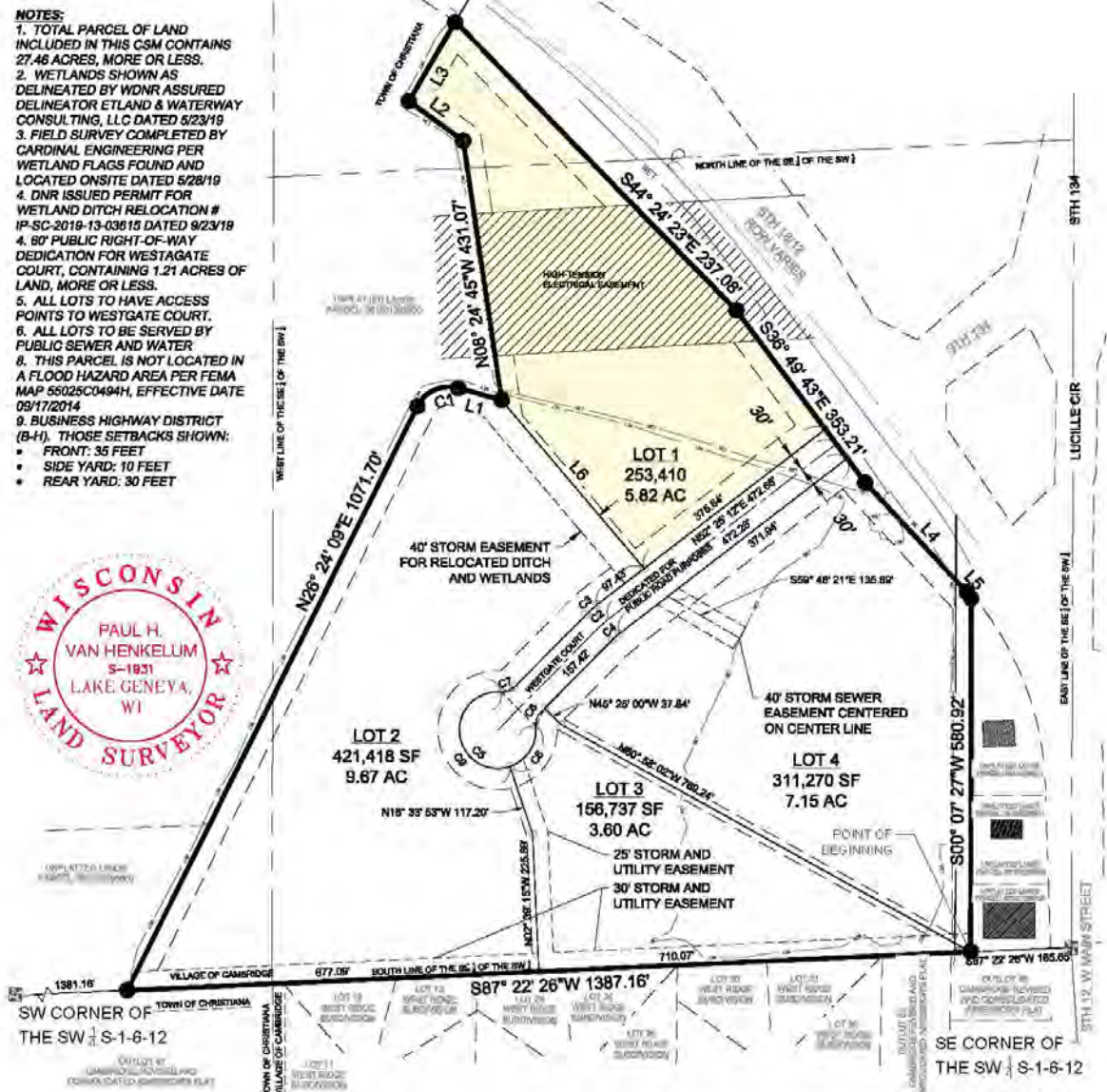

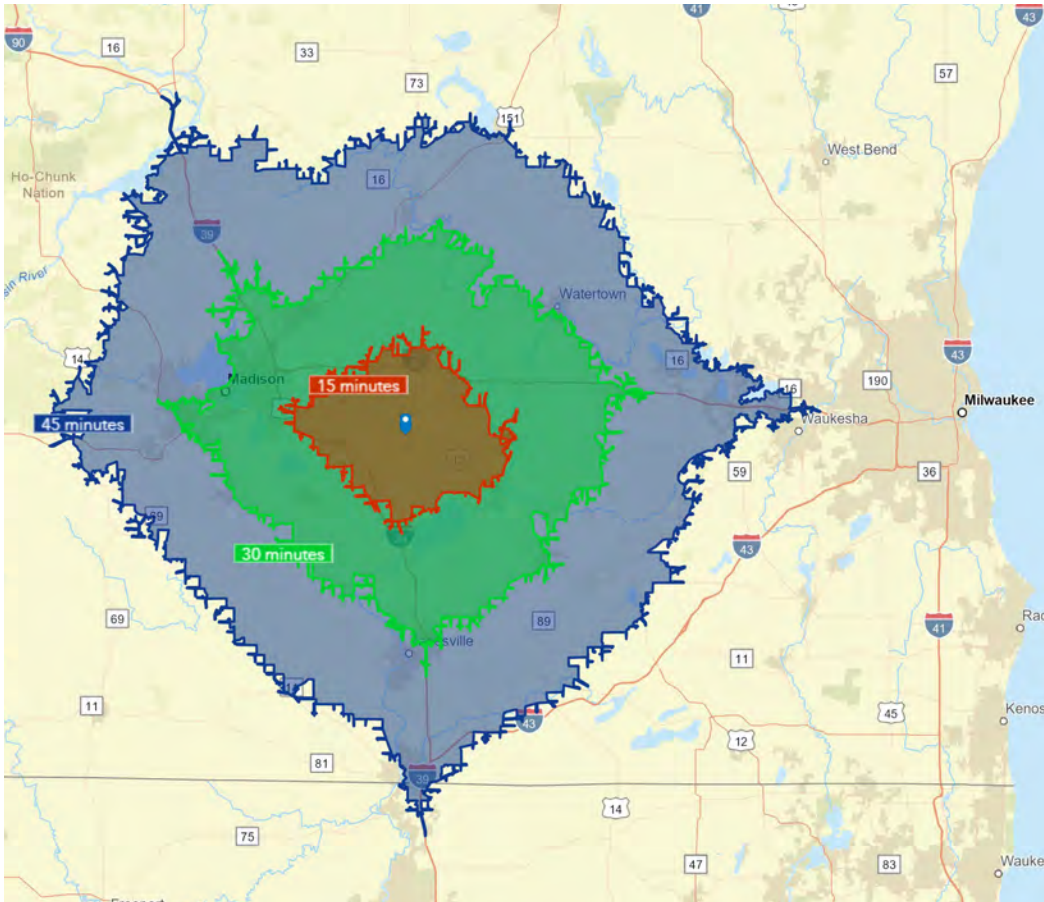
