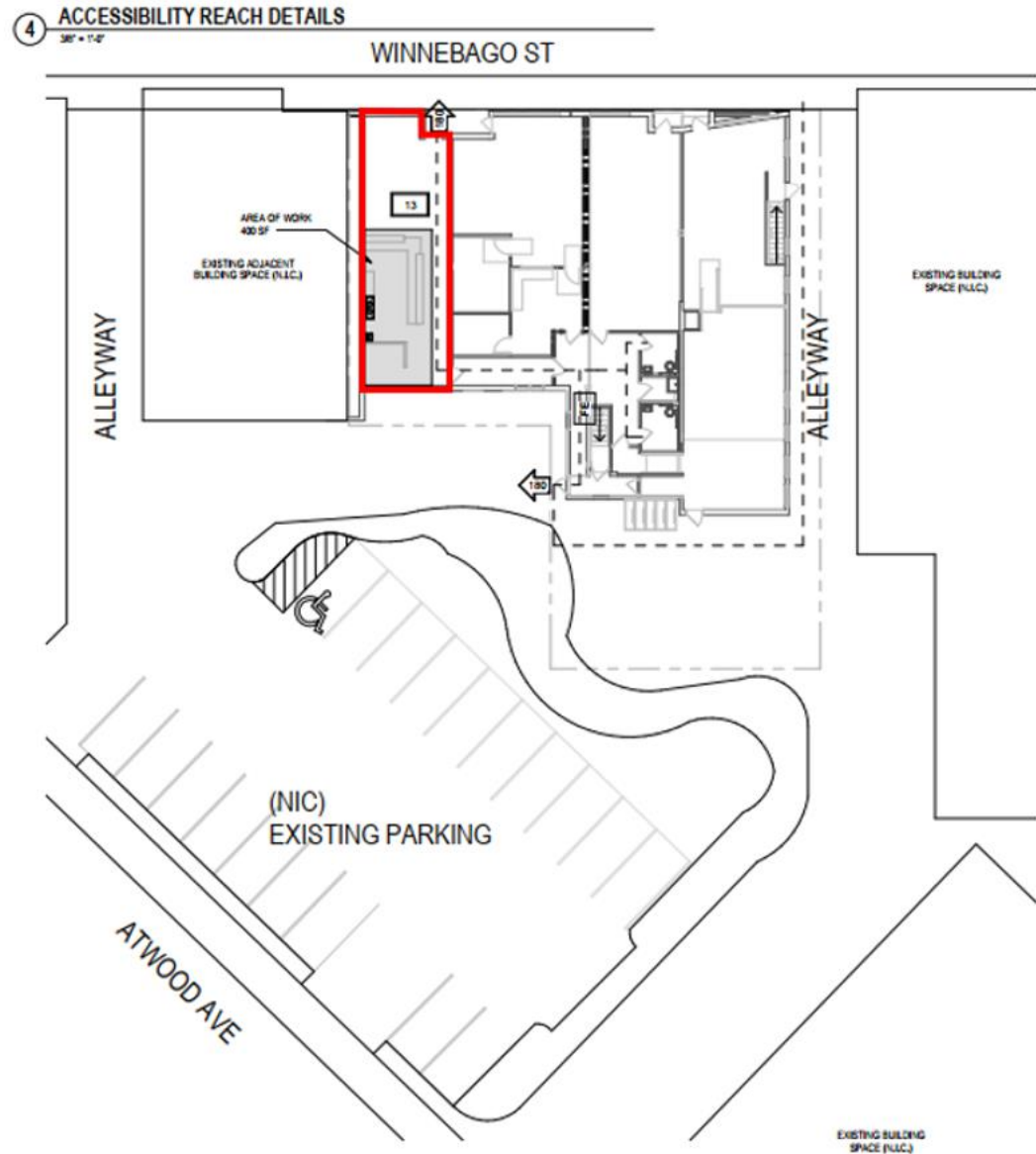
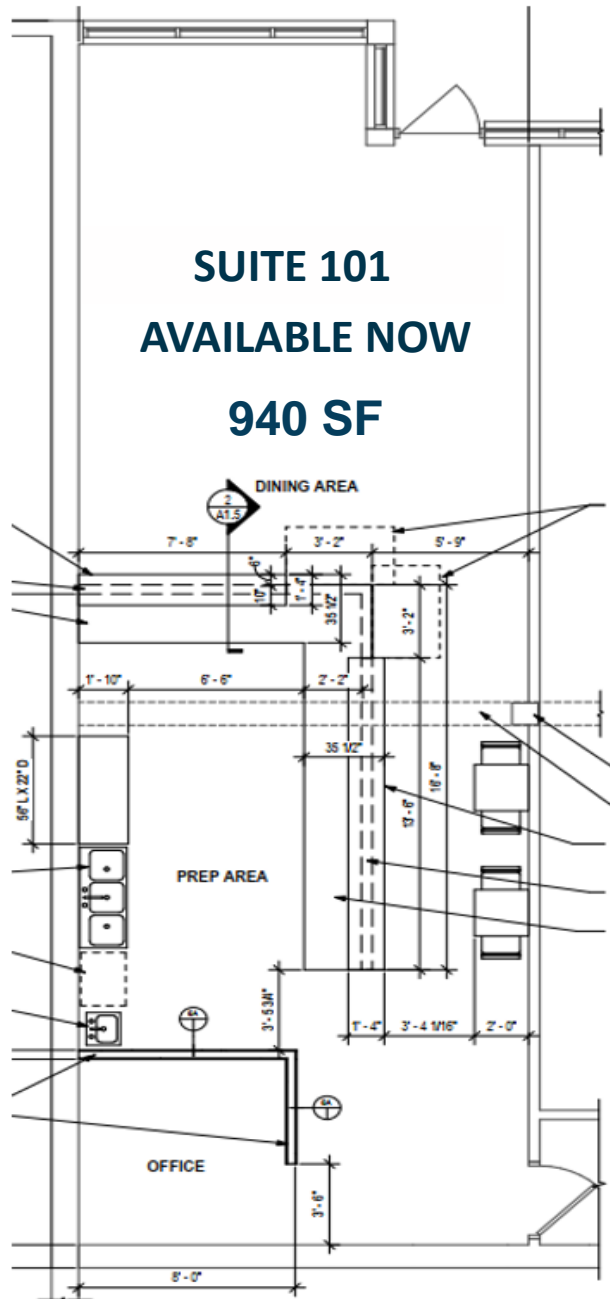

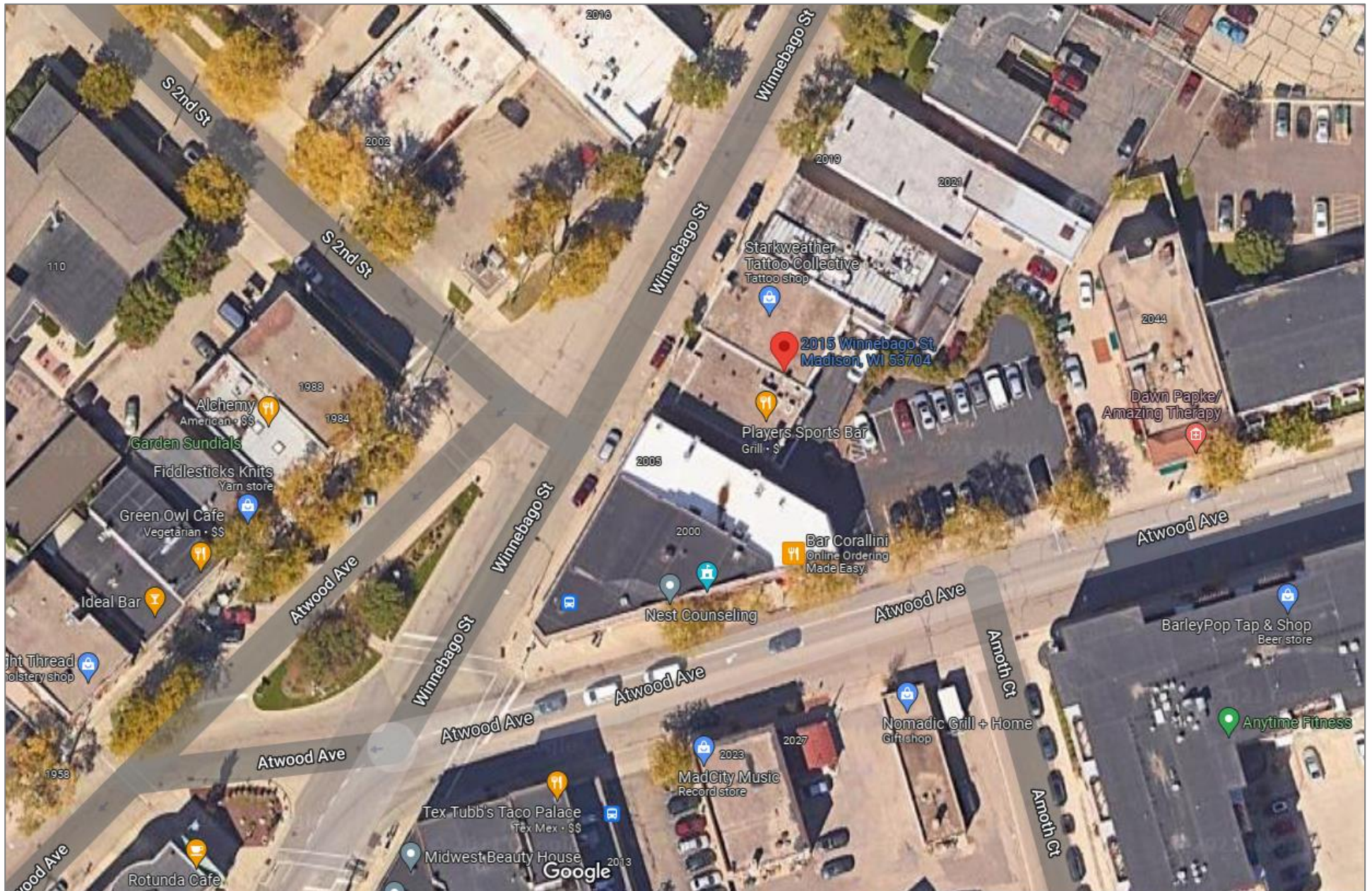

**DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS**

- 8 (a) The duty to provide brokerage services to you fairly and honestly.
- 9 (b) The duty to exercise reasonable skill and care in providing brokerage services to you.
- 10 (c) The duty to provide you with accurate information about market conditions within a reasonable time if you request
- 11 it, unless disclosure of the information is prohibited by law.
- 12 (d) The duty to disclose to you in writing certain Material Adverse Facts about a property, unless disclosure of the
- 13 information is prohibited by law (see lines 42-51).
- 14 (e) The duty to protect your confidentiality. Unless the law requires it, the Firm and its Agents will not disclose your
- 15 confidential information or the confidential information of other parties (see lines 23-41).
- 16 (f) The duty to safeguard trust funds and other property held by the Firm or its Agents.
- 17 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the
- 18 advantages and disadvantages of the proposals.

**DEFINITION OF MATERIAL ADVERSE FACTS**

- 43 A "Material Adverse Fact" is defined in Wis. Stat. § 452.01(5g) as an Adverse Fact that a party indicates is of such
- 44 significance, or that is generally recognized by a competent licensee as being of such significance to a reasonable
- 45 party, that it affects or would affect the party's decision to enter into a contract or agreement concerning a transaction
- 46 or affects or would affect the party's decision about the terms of such a contract or agreement.
- 47 An "Adverse Fact" is defined in Wis. Stat. § 452.01(1e) as a condition or occurrence that a competent licensee
- 48 generally recognizes will significantly and adversely affect the value of the property, significantly reduce the structural
- 49 integrity of improvements to real estate, or present a significant health risk to occupants of the property; or information
- 50 that indicates that a party to a transaction is not able to or does not intend to meet his or her obligations under a
- 51 contract or agreement made concerning the transaction.
