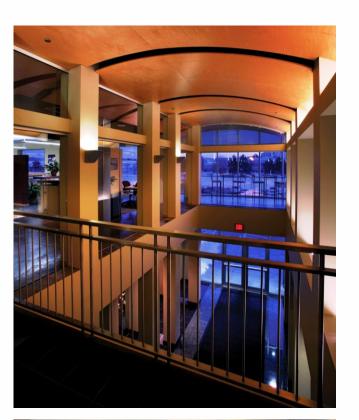

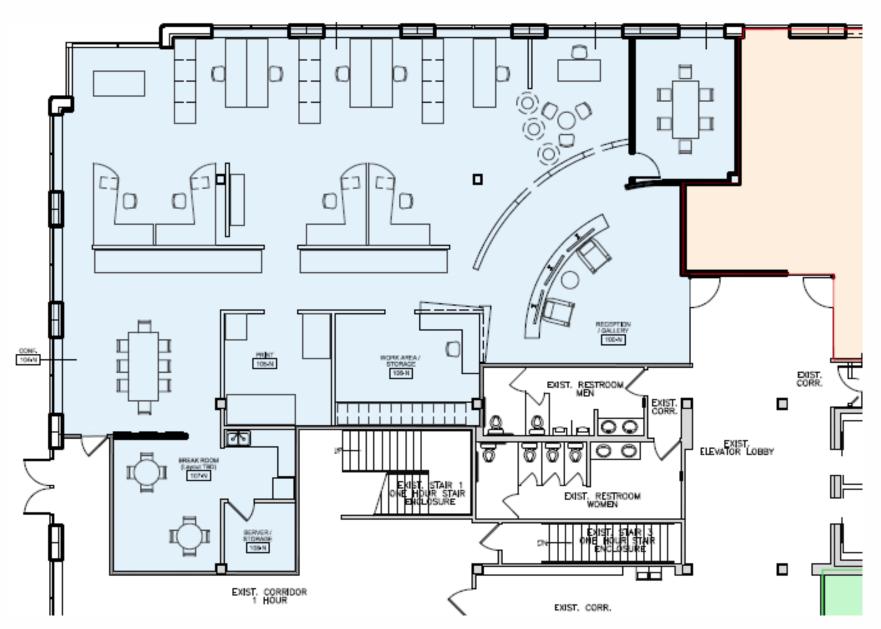

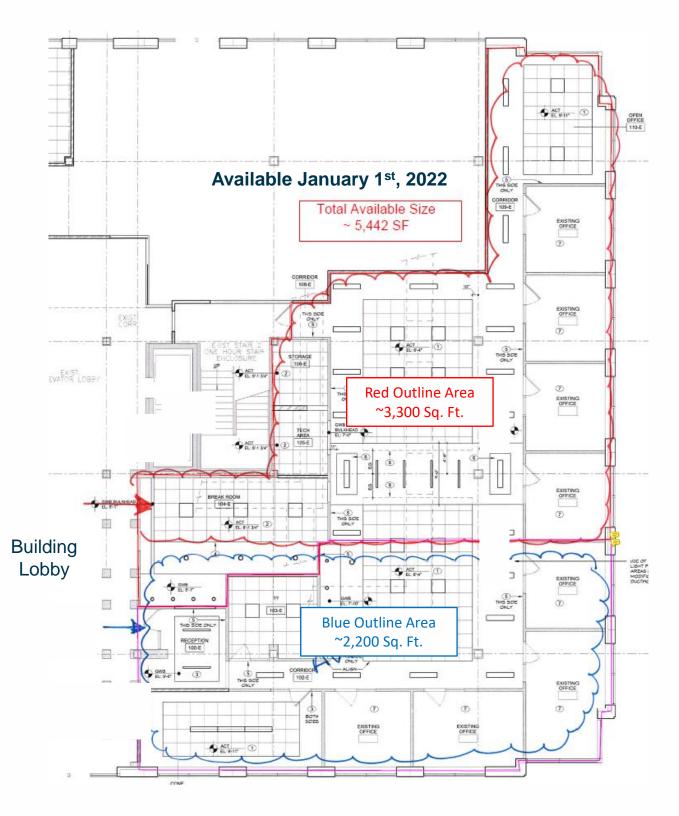


Floor Plan
