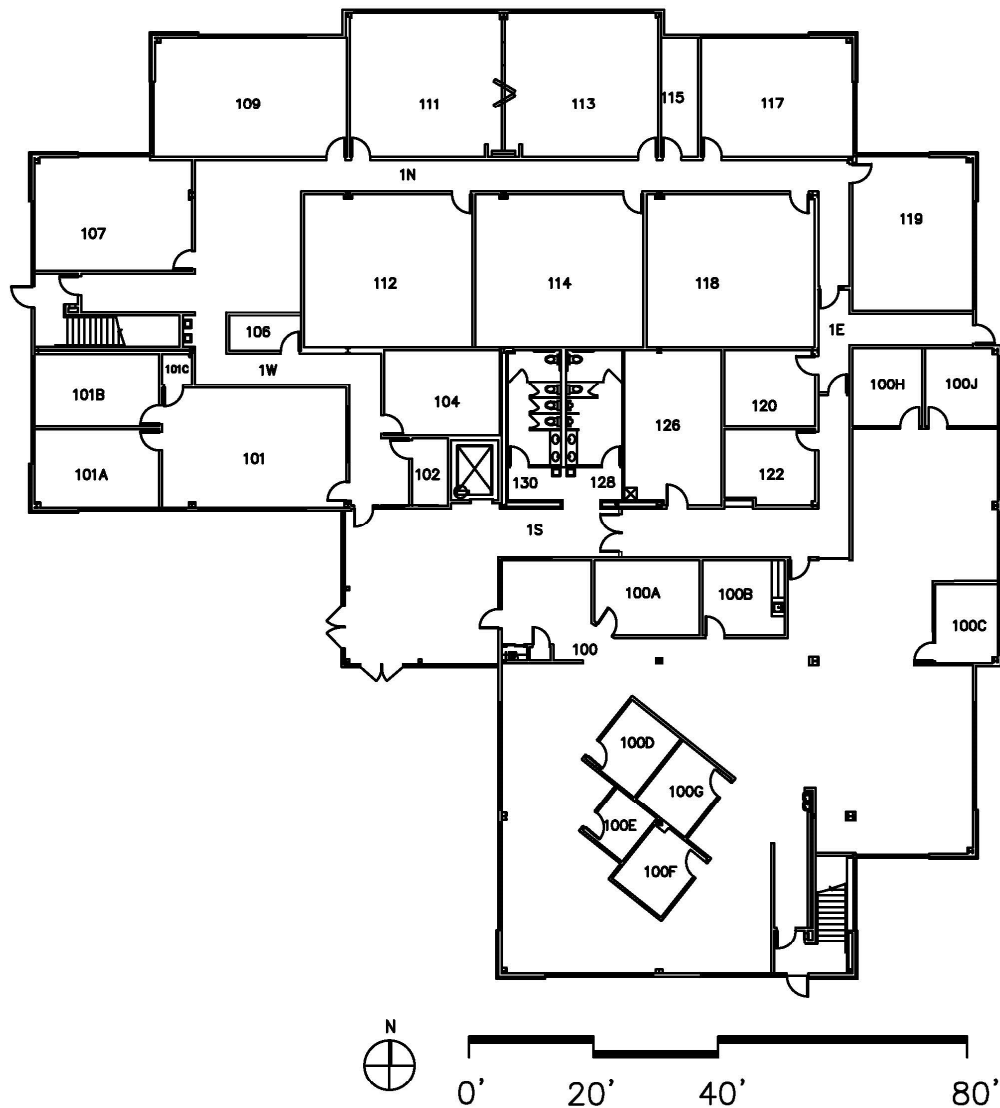

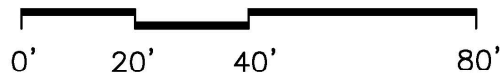

18 advantages and disadvantages of the proposals.

46 or affects or would affect the party's decision about the terms of such a contract or agreement.
