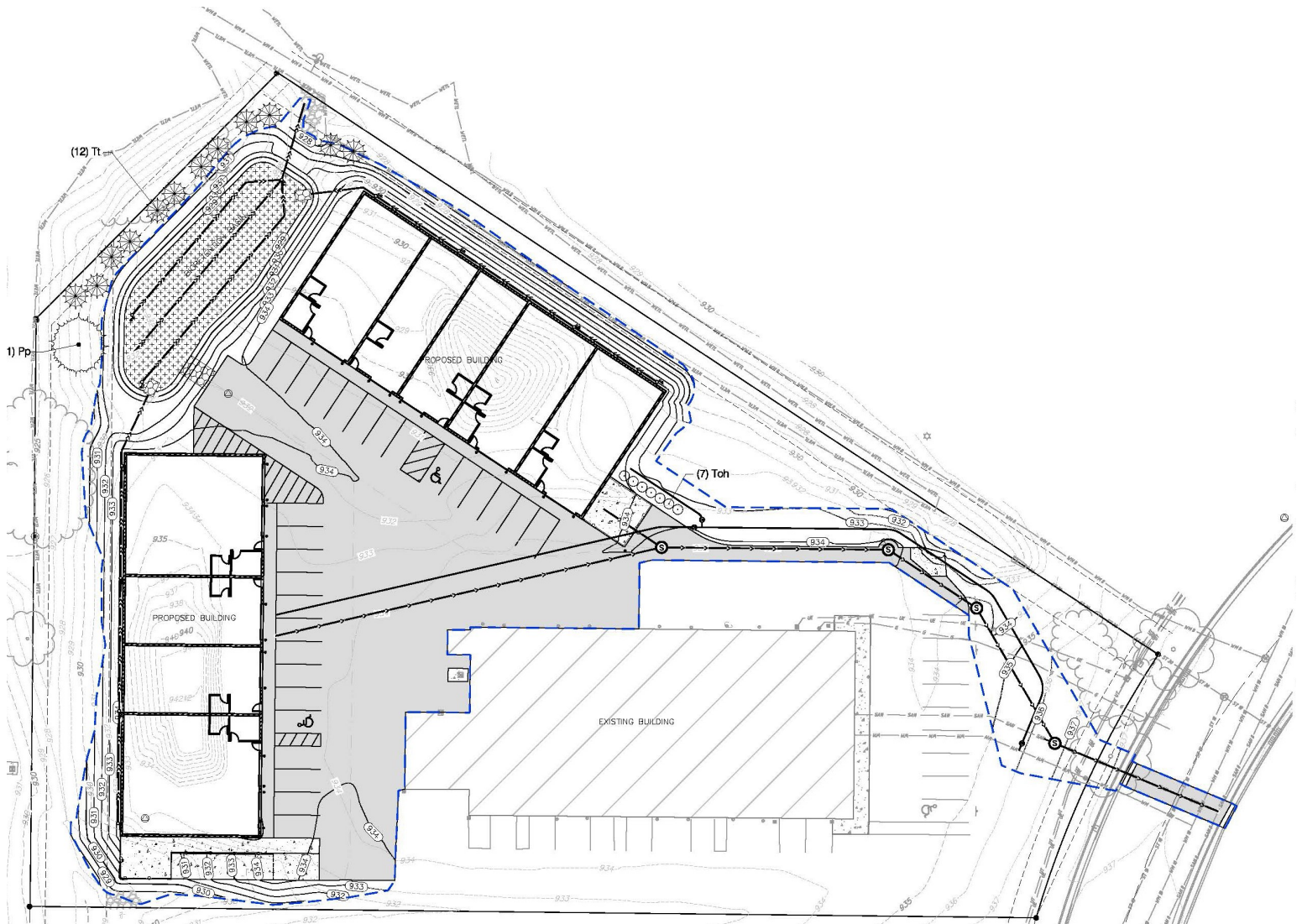

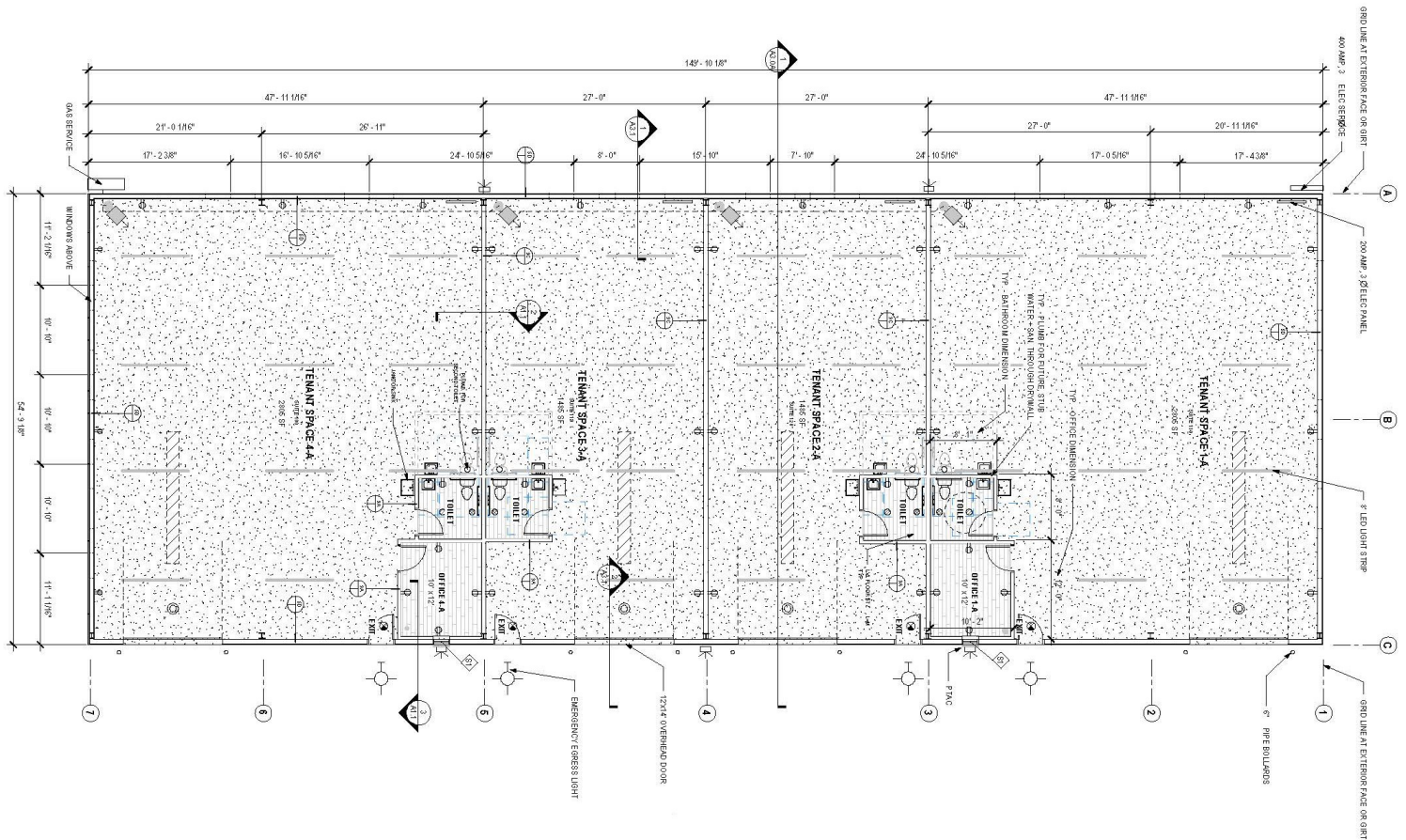

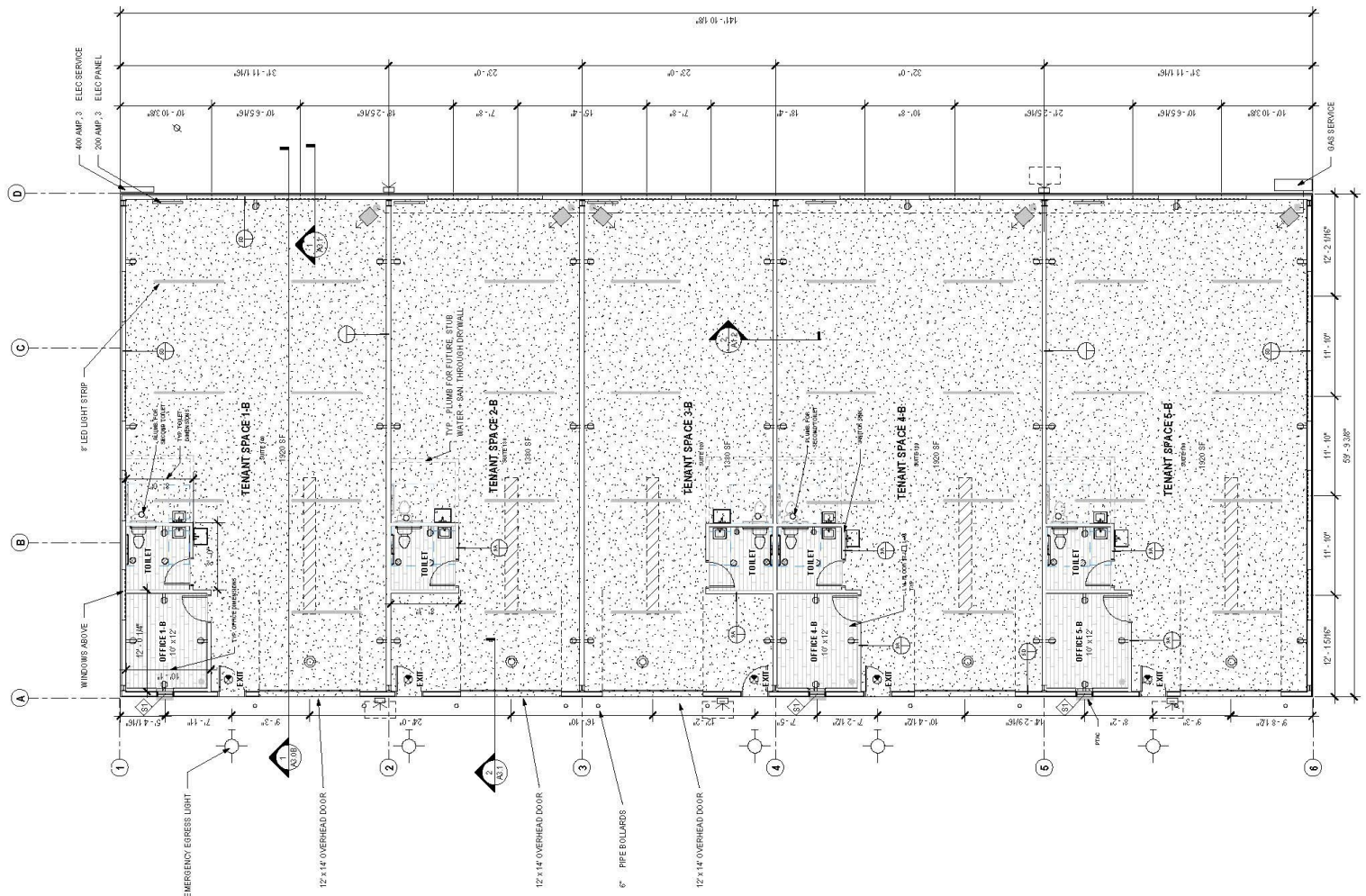

BROKER DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

BROKER DISCLOSURE TO CUSTOMERS

- 15 ■ The duty to safeguard trust funds and other property the broker holds.
- 16 ■ The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.
