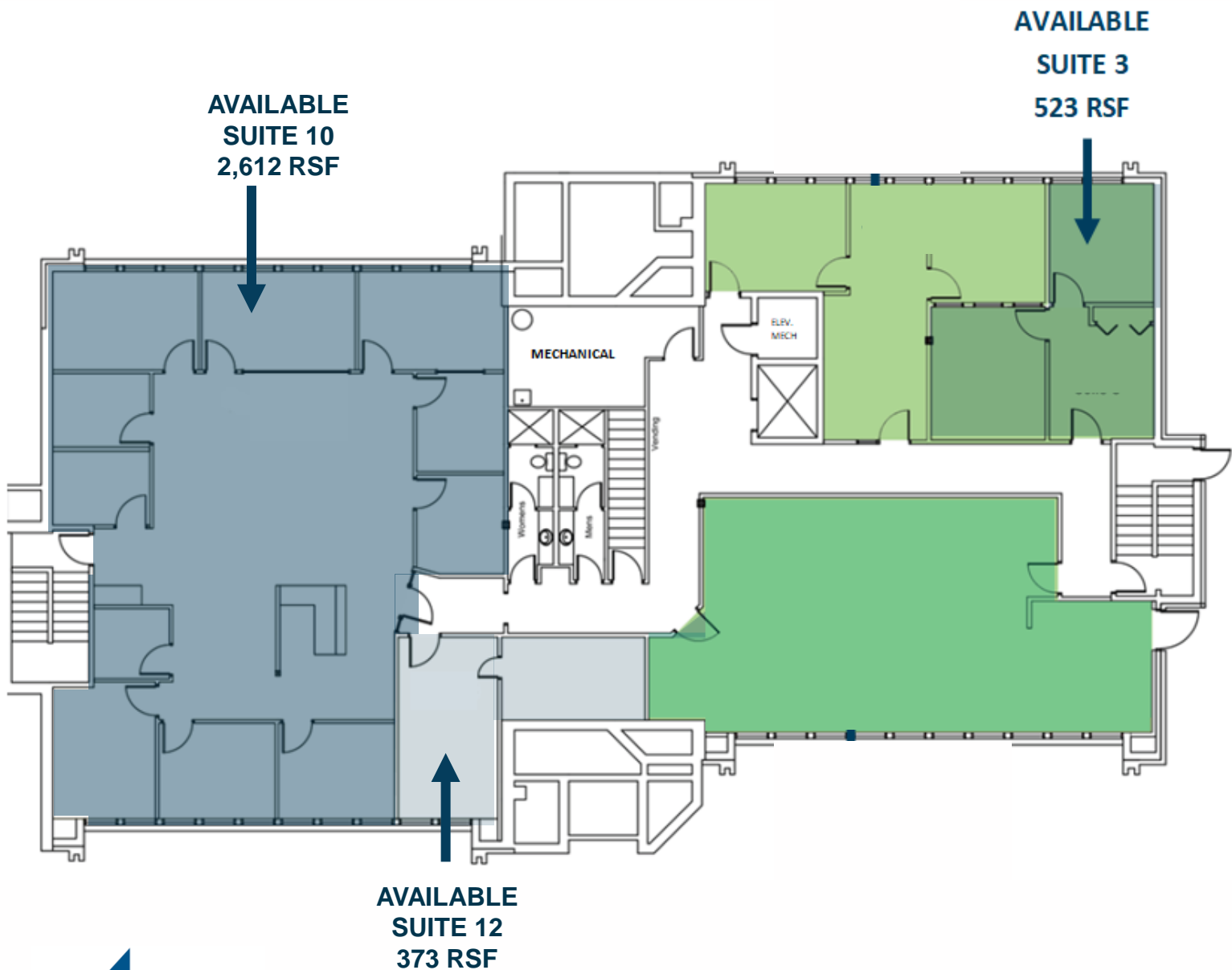






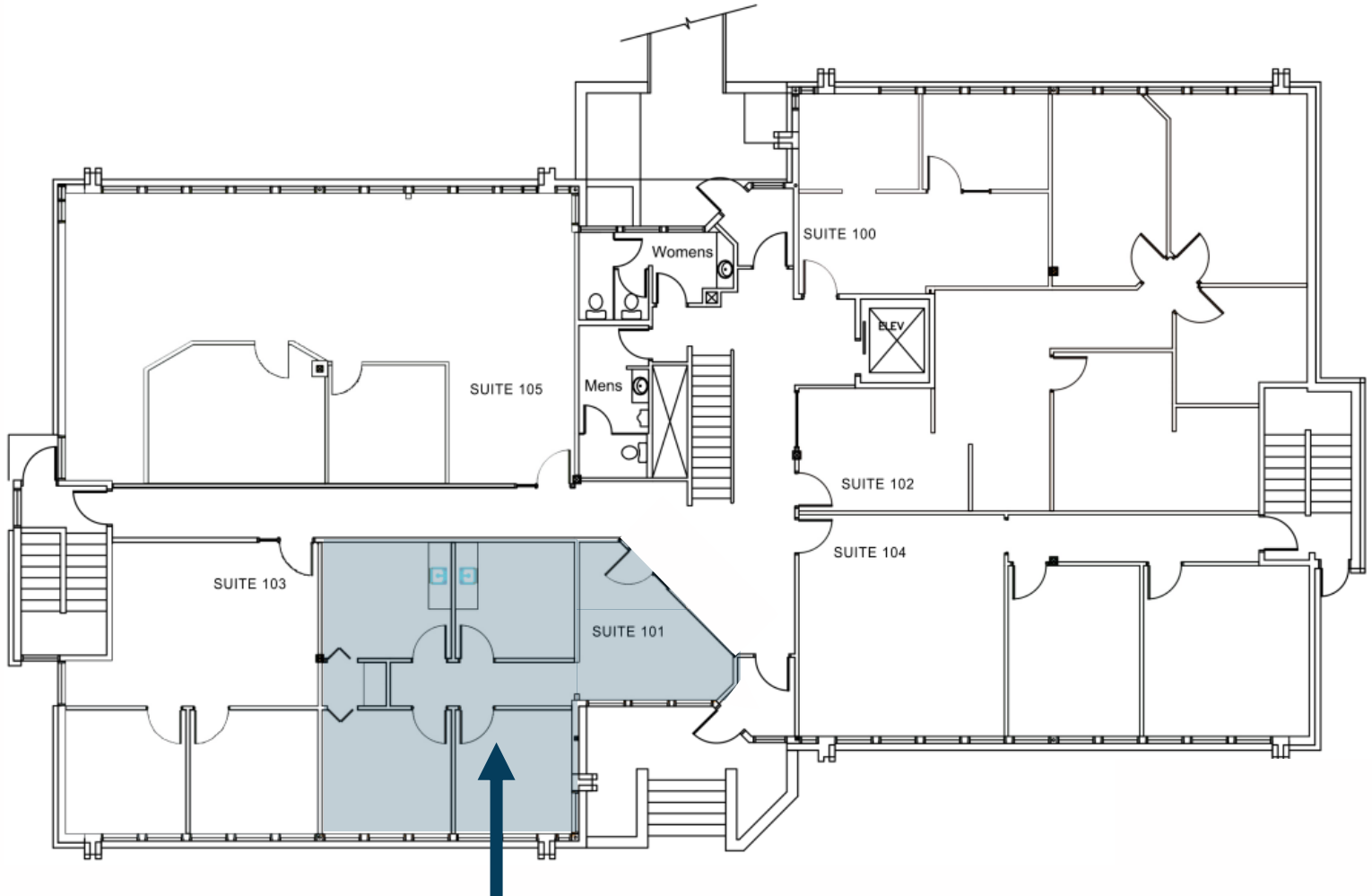


# Floor Plan

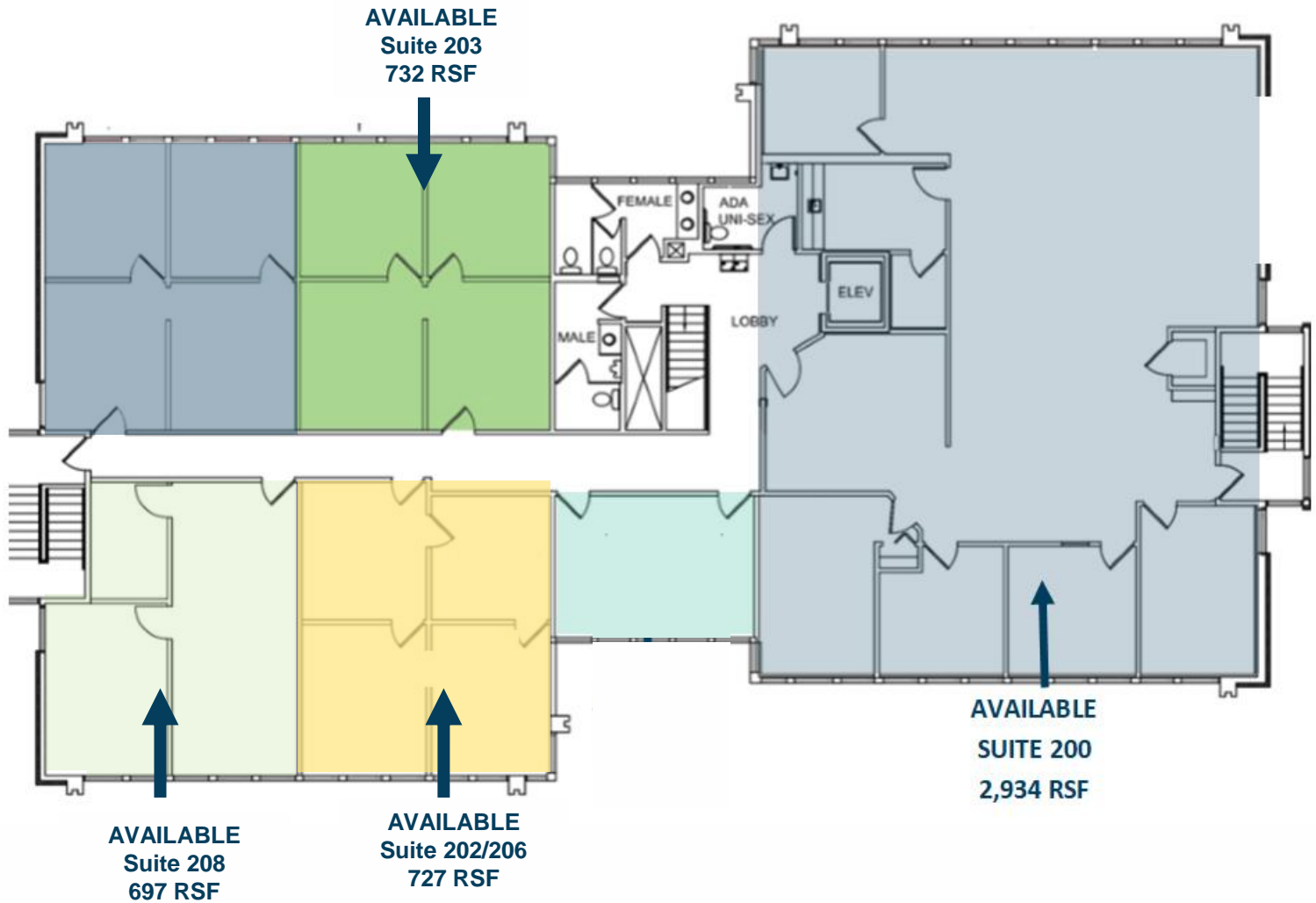
