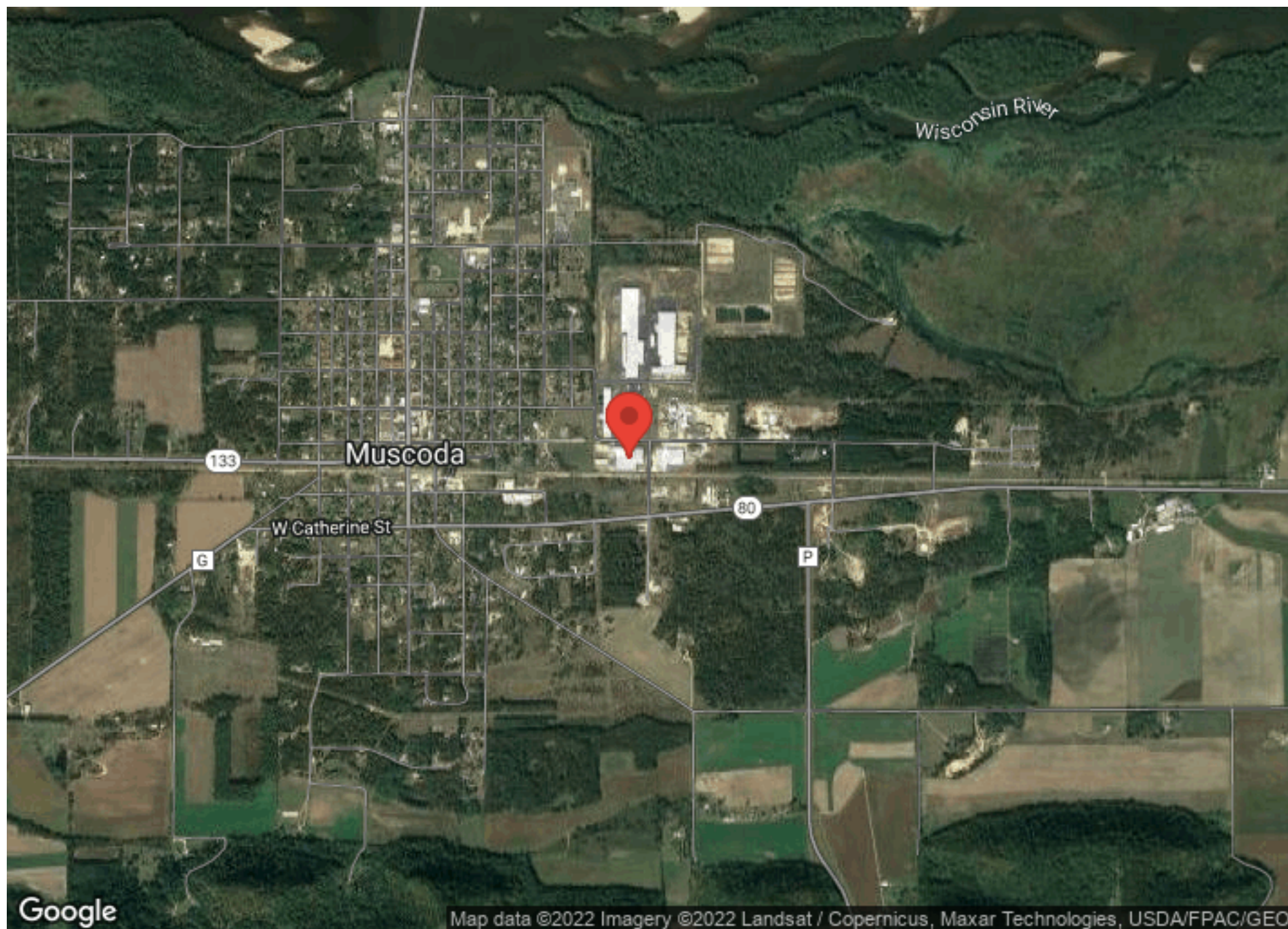




PLANT LAYOUT 2
