

# **BROKER DISCLOSURE**

#### Non-Residential Customers

- The duty to safeguard trust funds and other property the broker holds.
- The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.

This disclosure is required by section 452. 135 of the Wisconsin statues and is for information only. ### **Confidentiality Notice to Customers**
