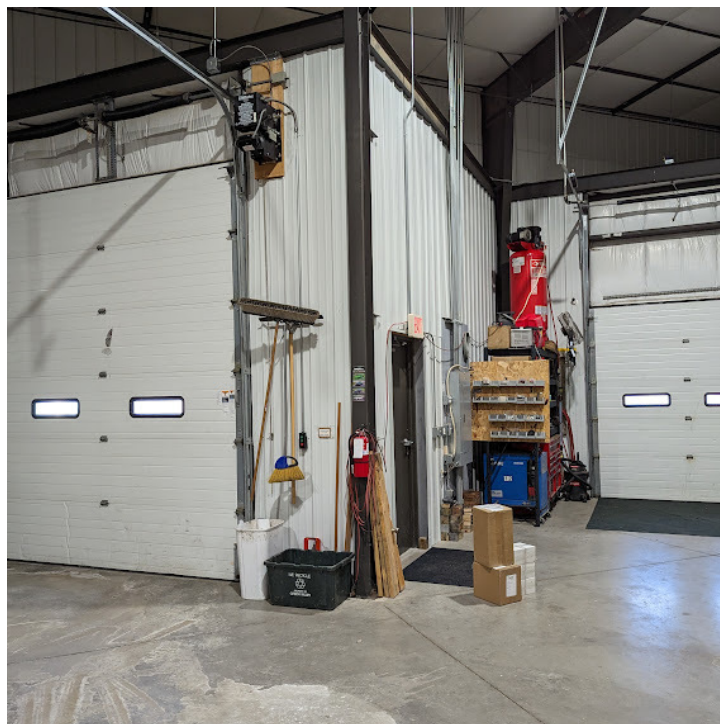

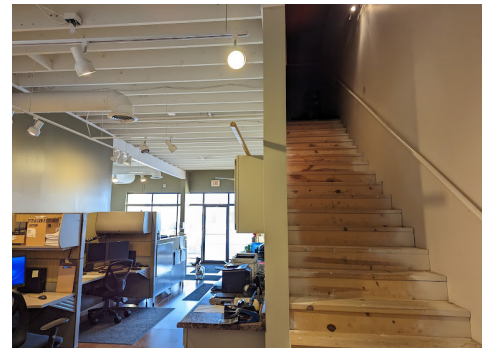

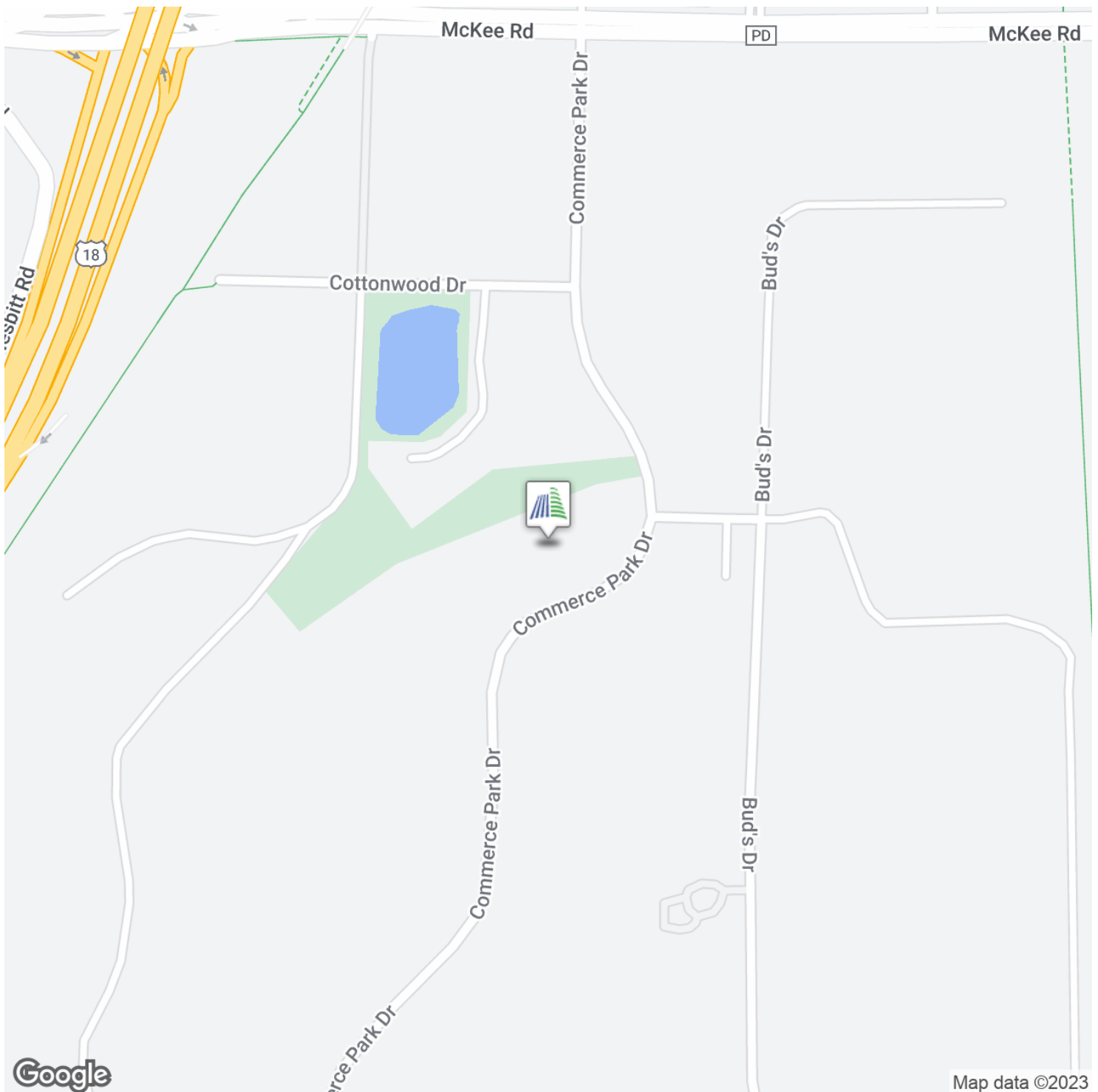

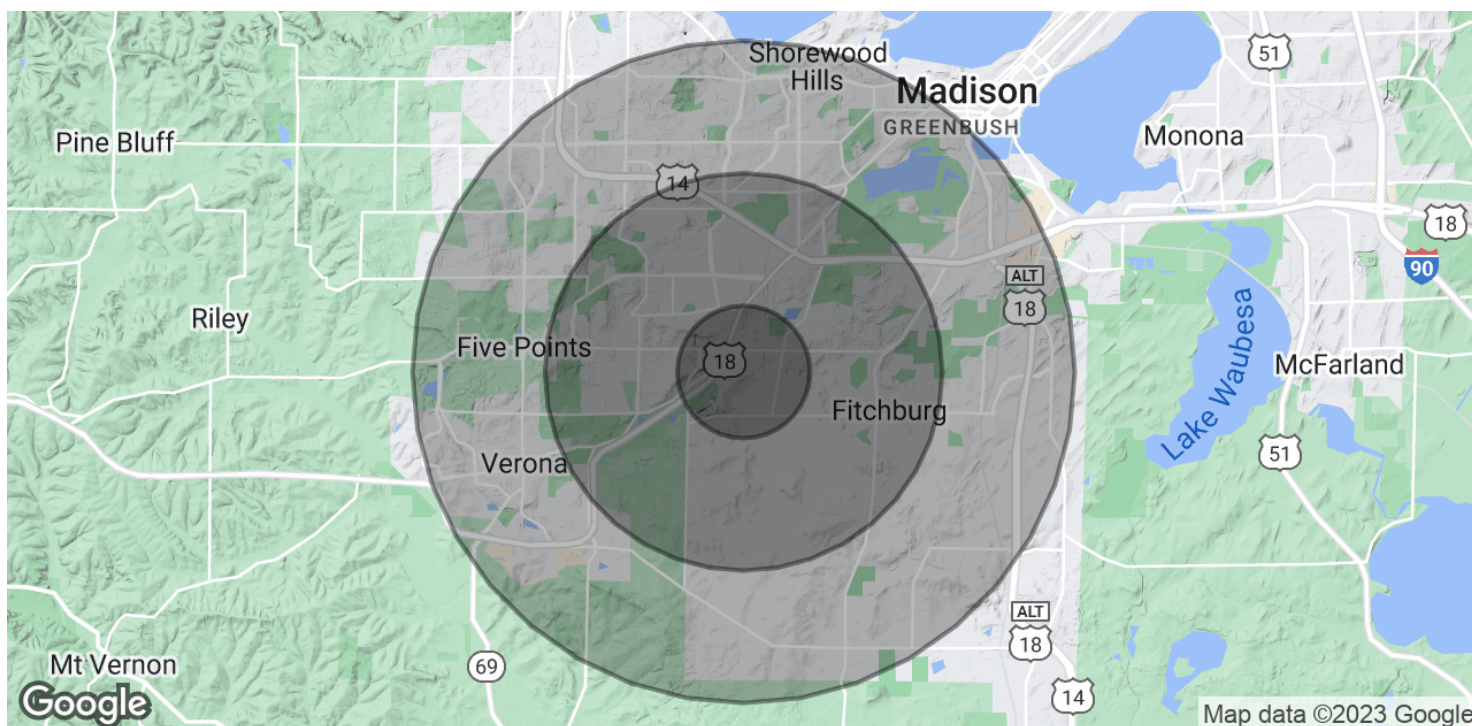
// LOCATION MAP
