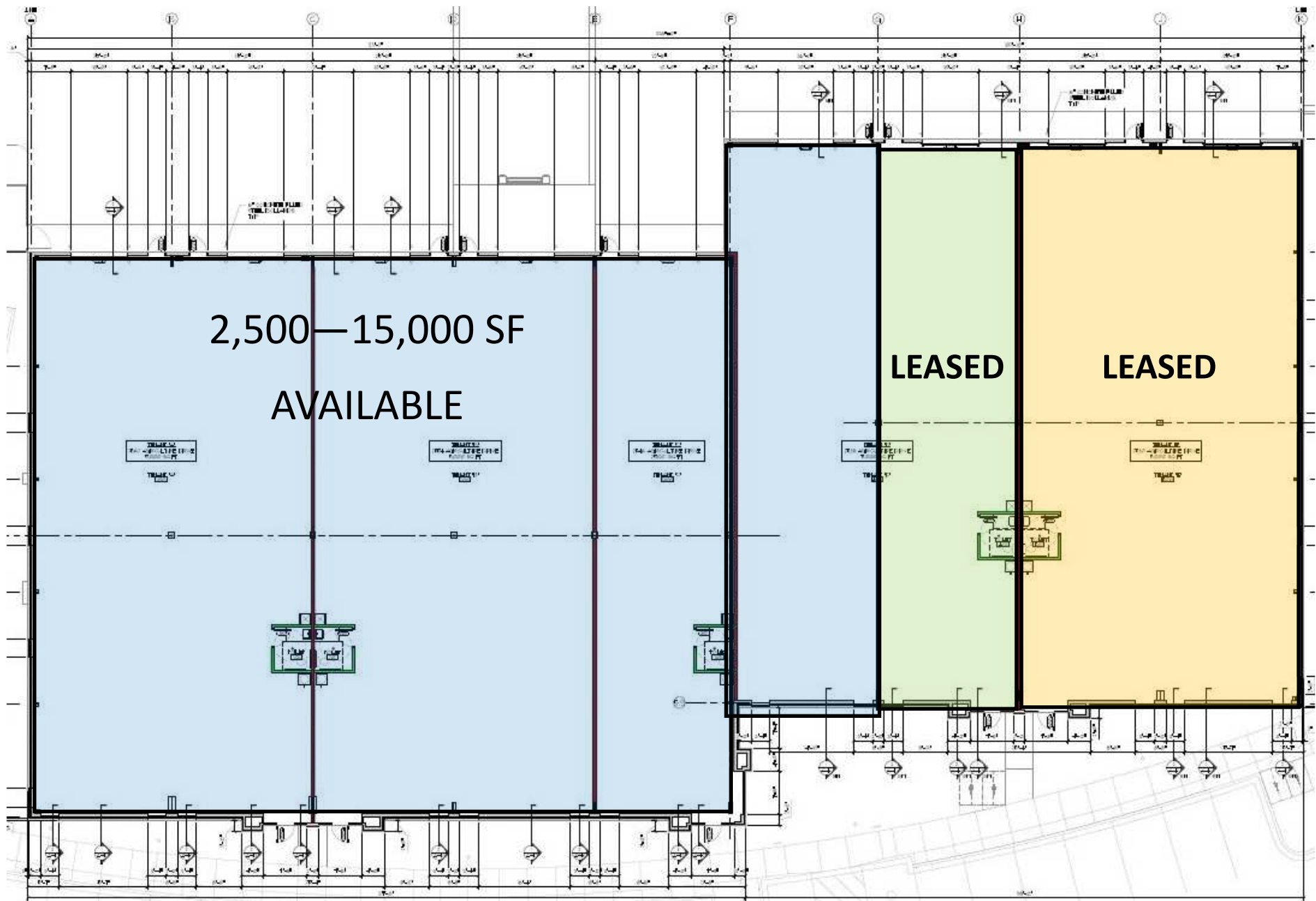

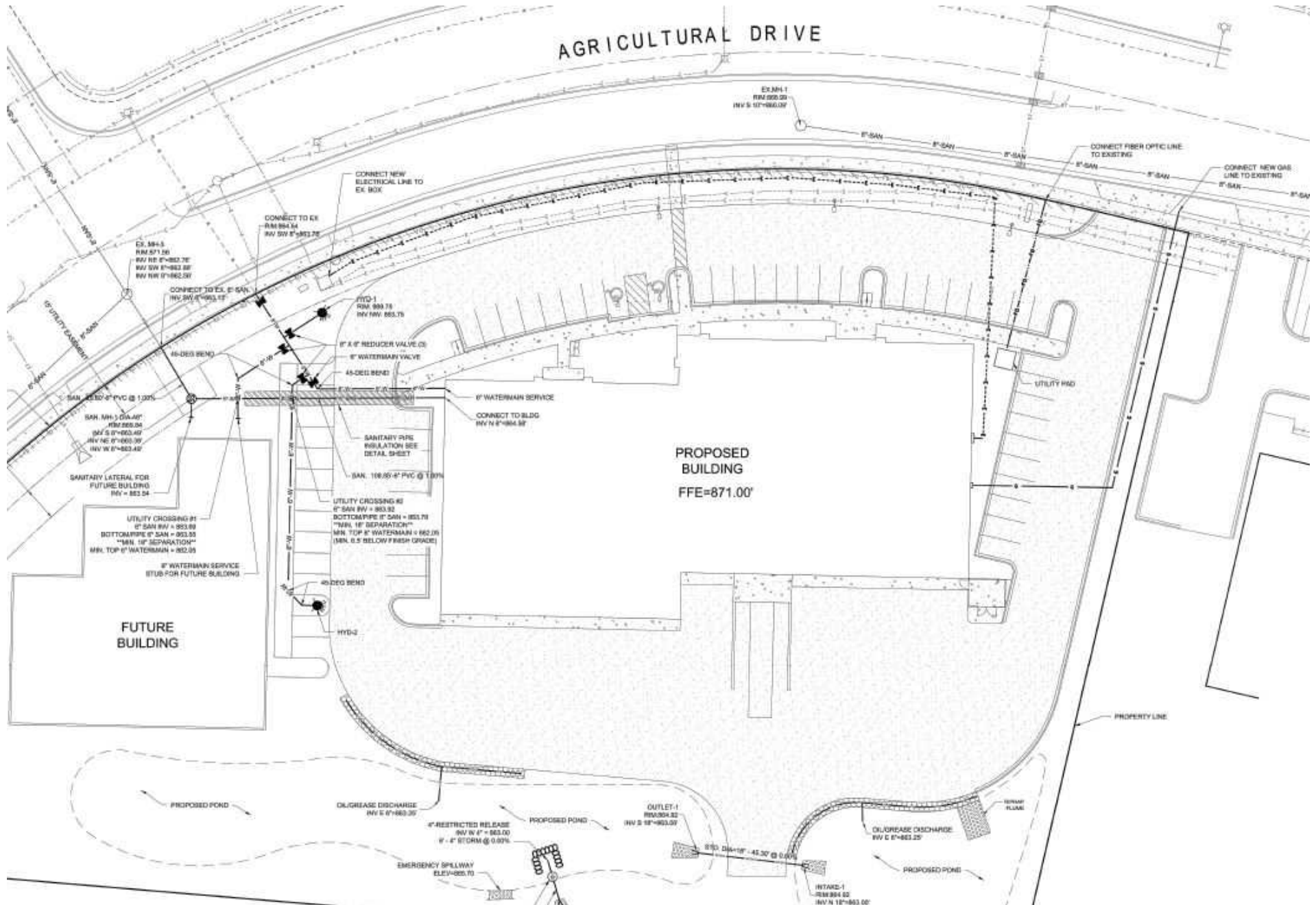

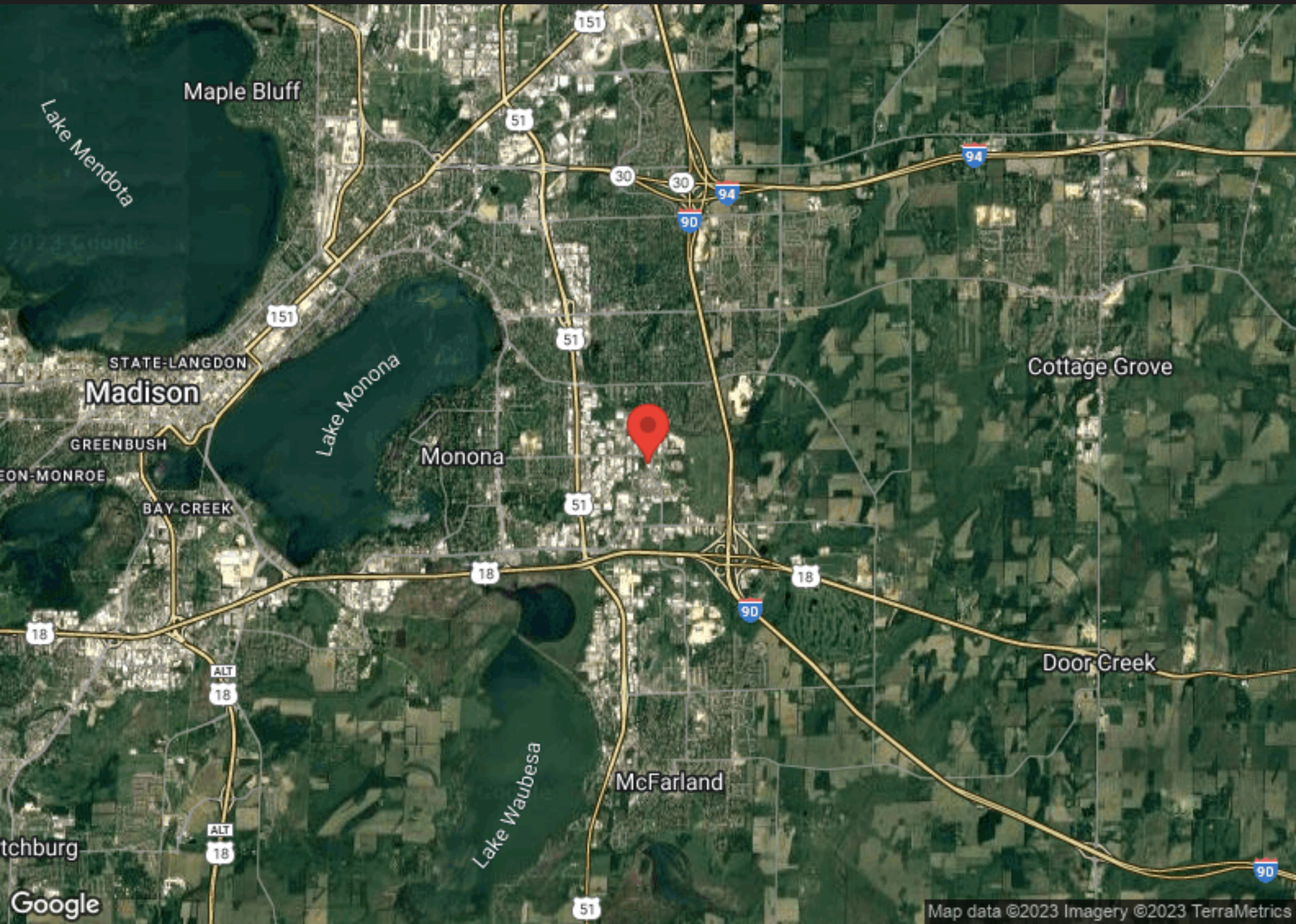




## REGIONAL MAP
