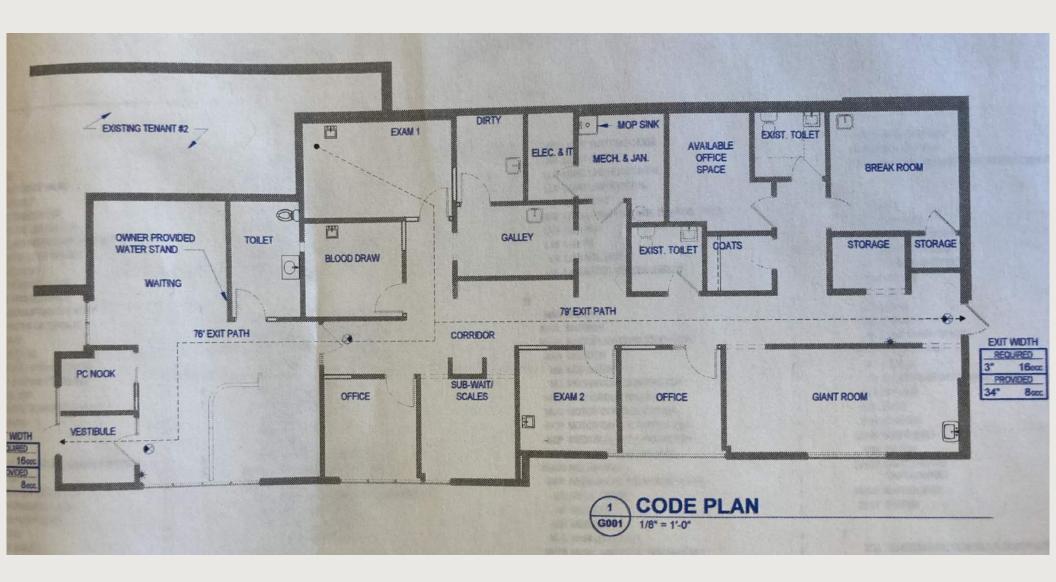

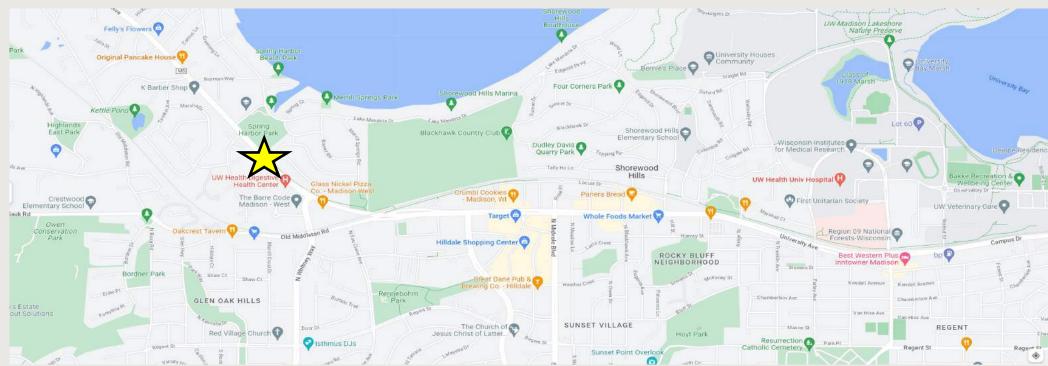




Floor Plan
