Located on the east side of Madison in the American Center Office Park. With easy access to the Beltline and Hwy. 90/94. 10 minutes to downtown/campus.

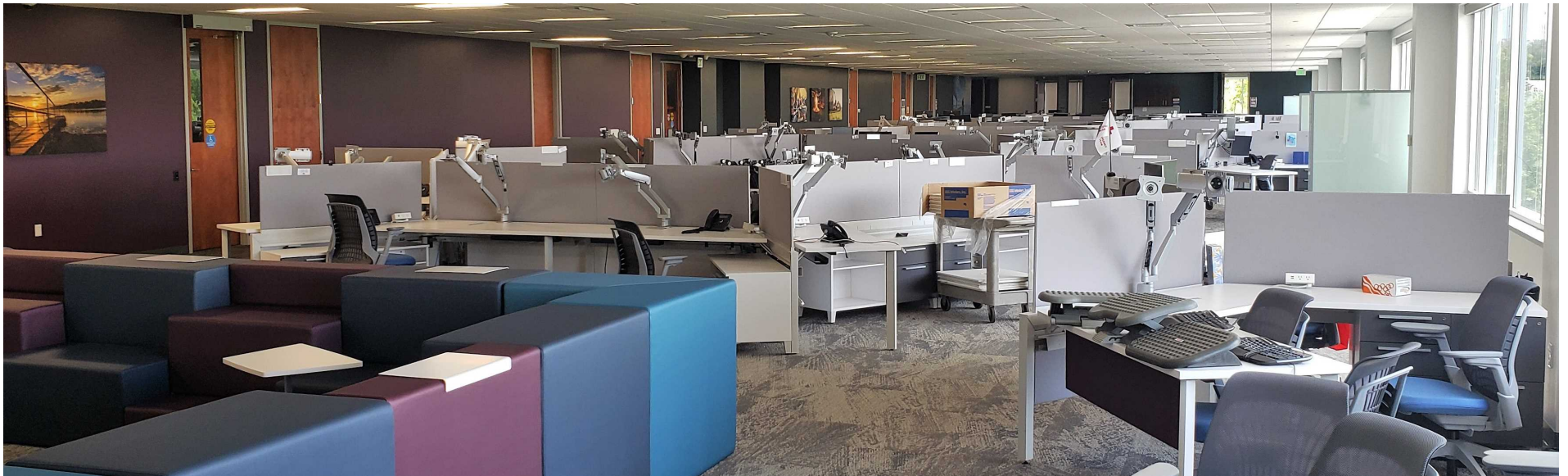

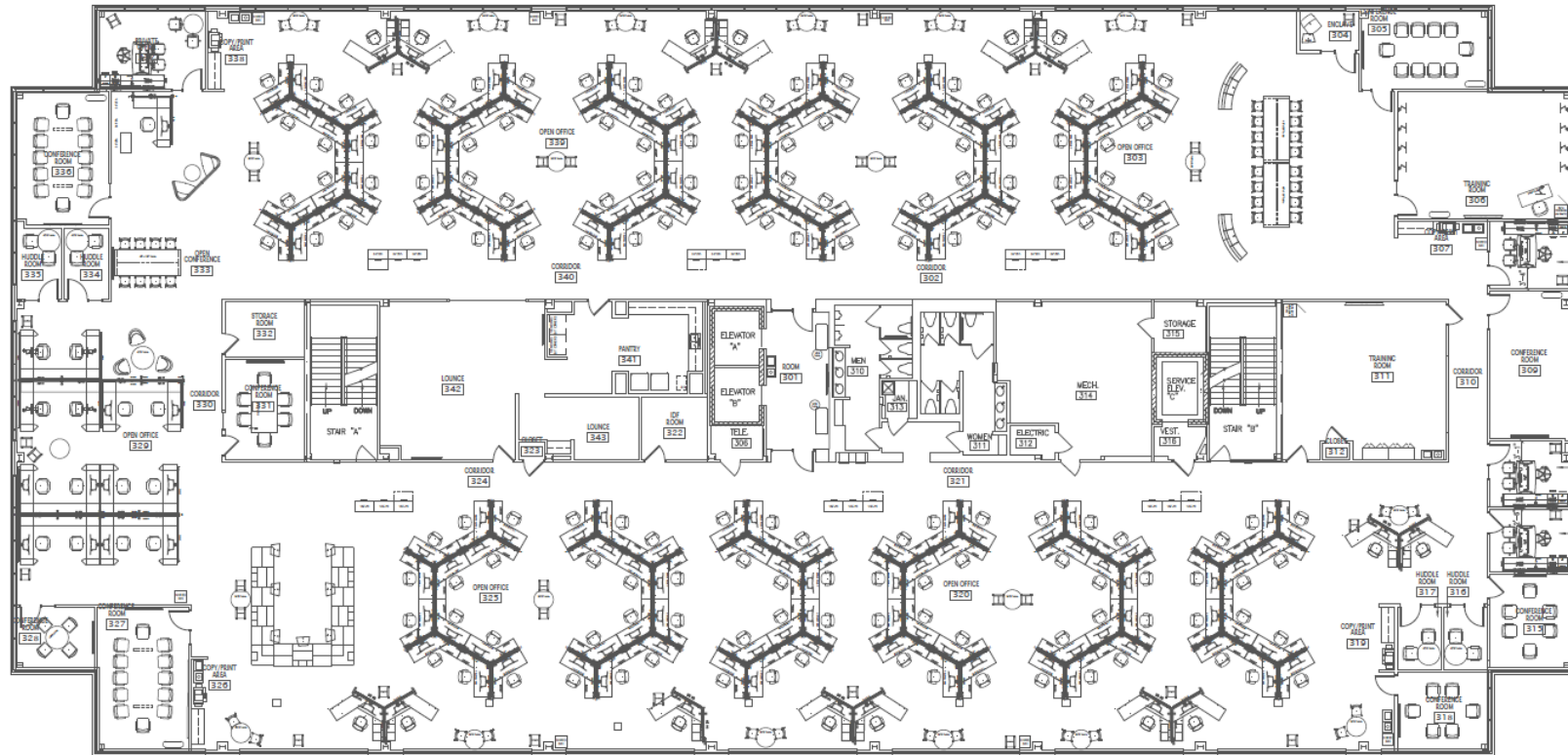
