The property is located in one of the most desirable areas in the Madison, WI market being just due south from West Towne Mall, south of the Beltline Hwy (Hwy 12 & 18) on the Gammon Road exit. If West Towne Mall, Walmart, and Woodman's Market are within minutes of a walk, you know there is something special.
