












### 5534 Medical Cir. - Floorplan








### 5534 Medical Cir. - Map

#### **DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS**

- 16 (f) The duty to safeguard trust funds and other property held by the Firm or its Agents.
- 17 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.
