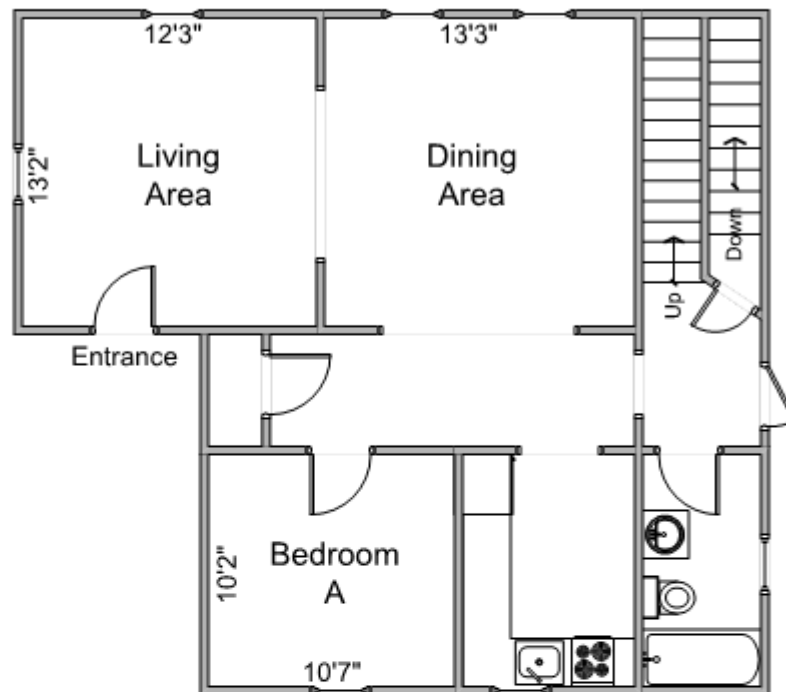

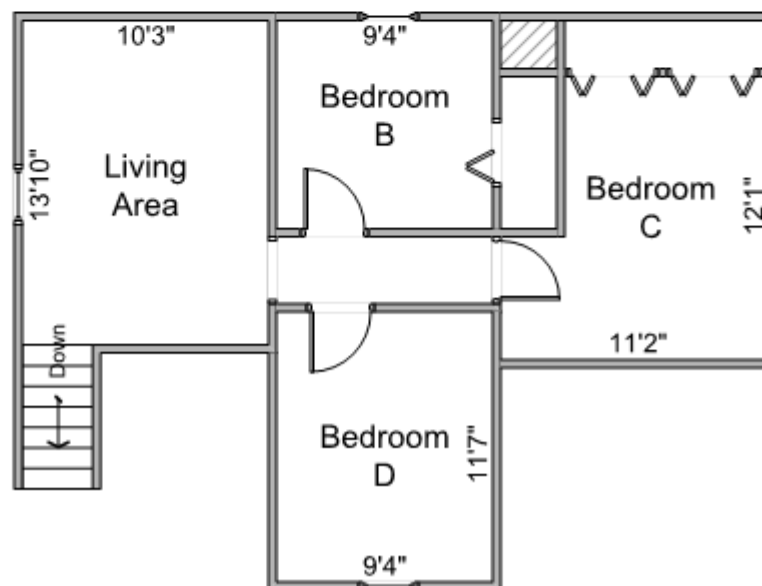

Ave. #2**



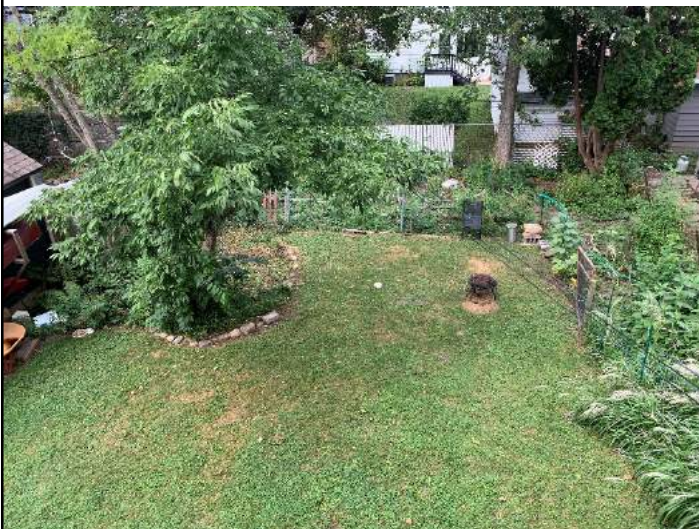
**2<sup>nd</sup> Floor**
