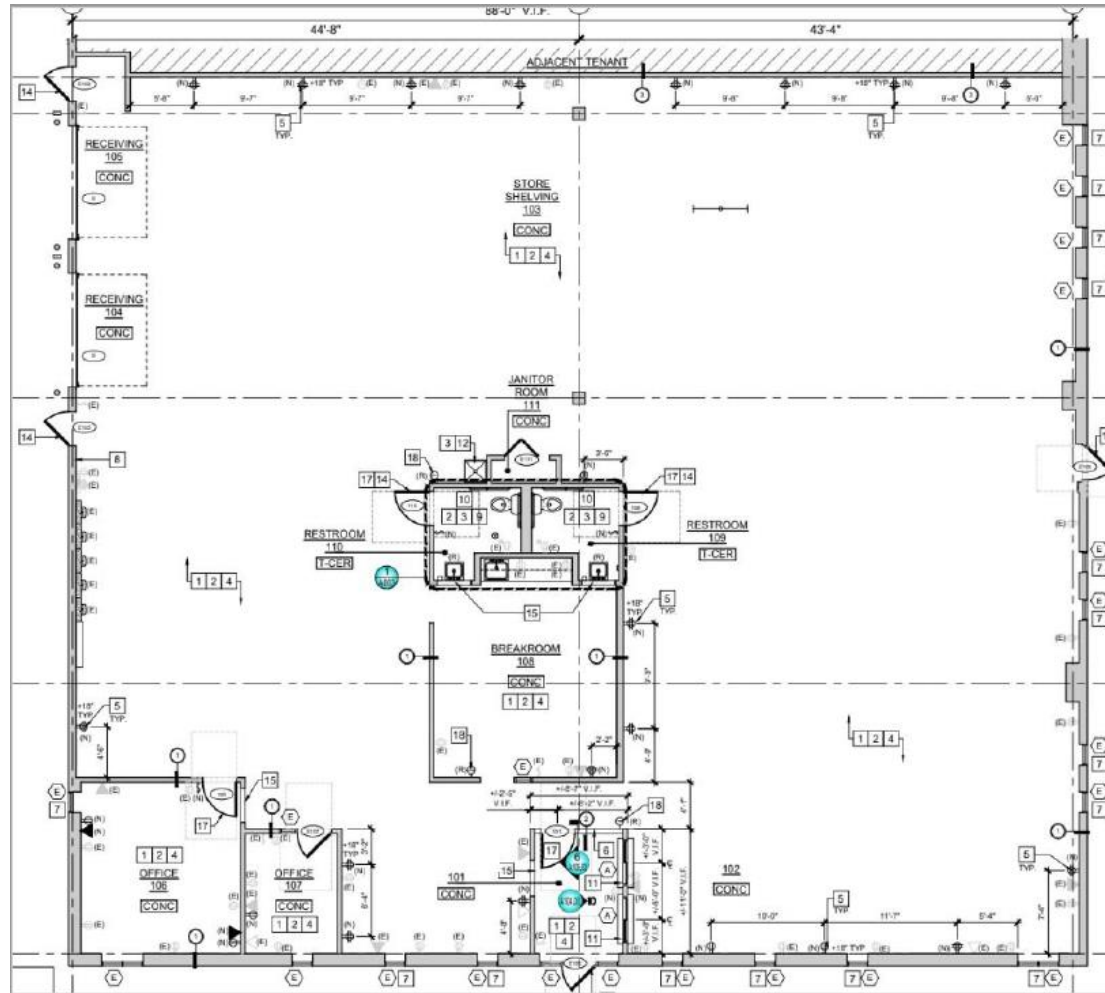

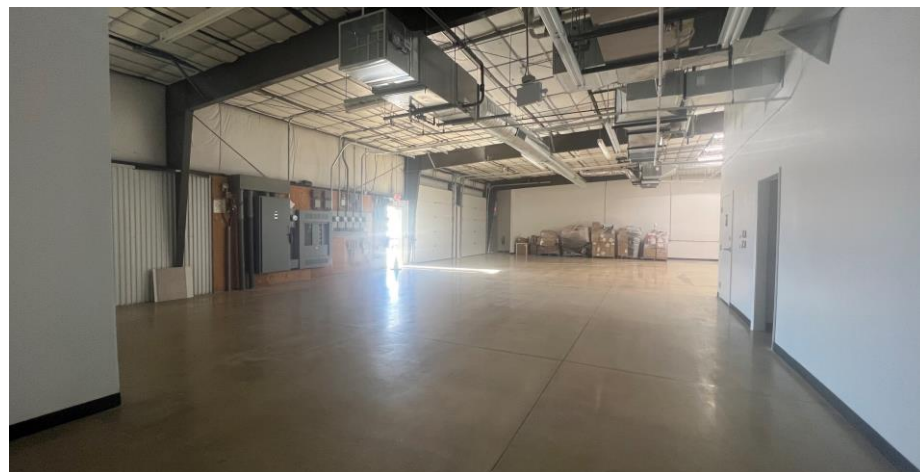
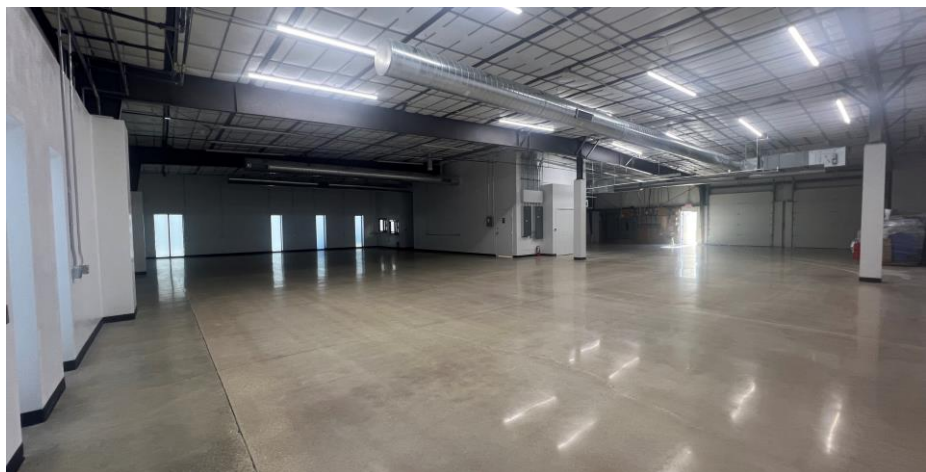

DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

DEFINITION OF MATERIAL ADVERSE FACTS
