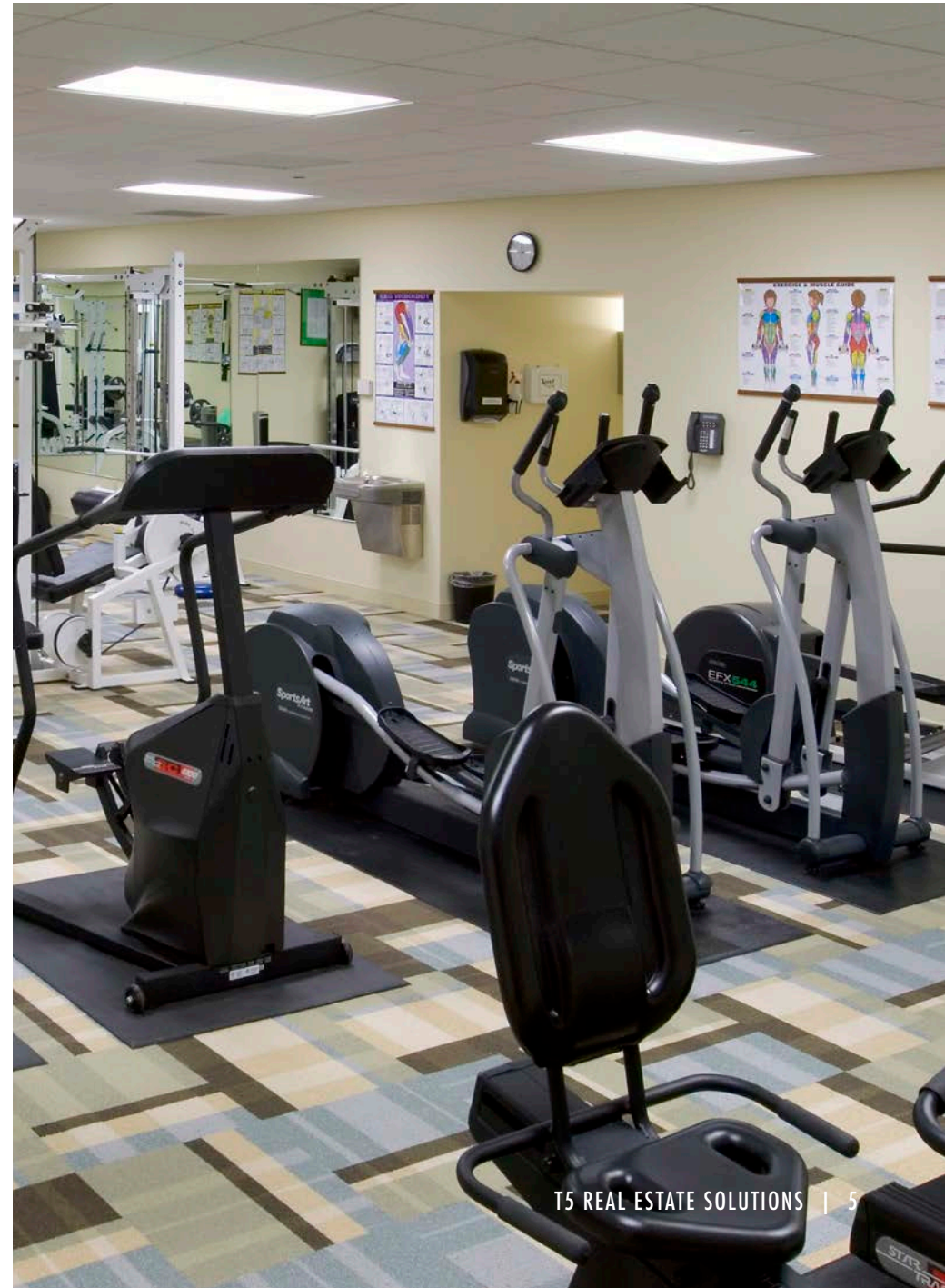

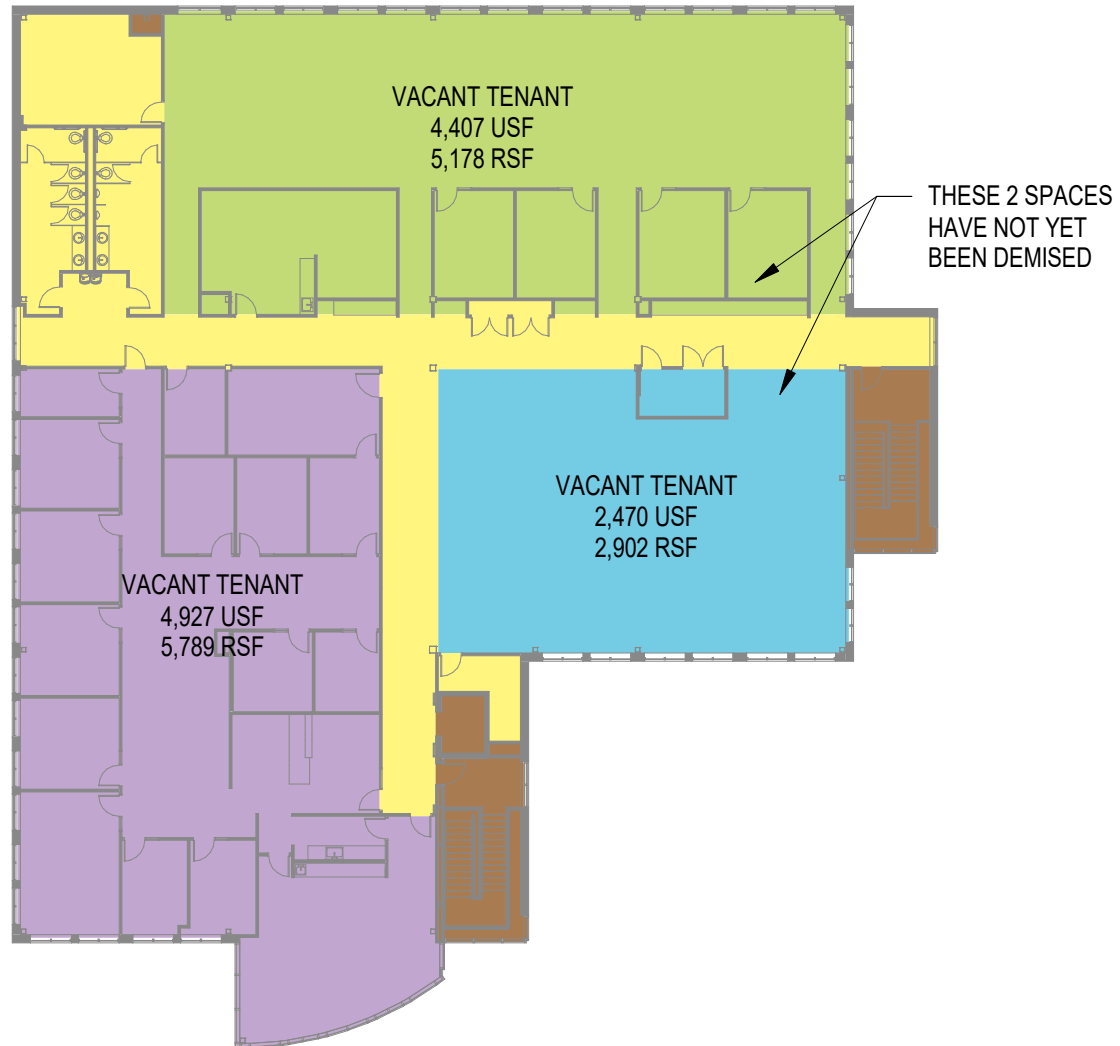

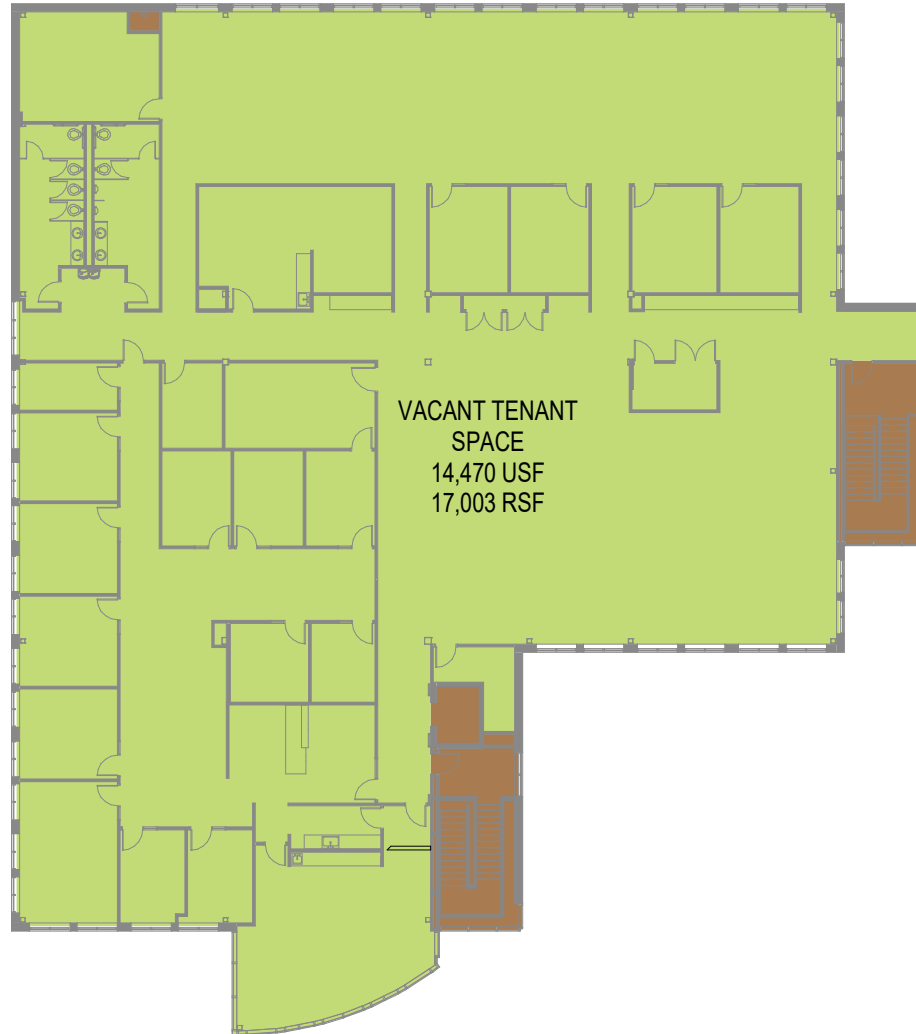




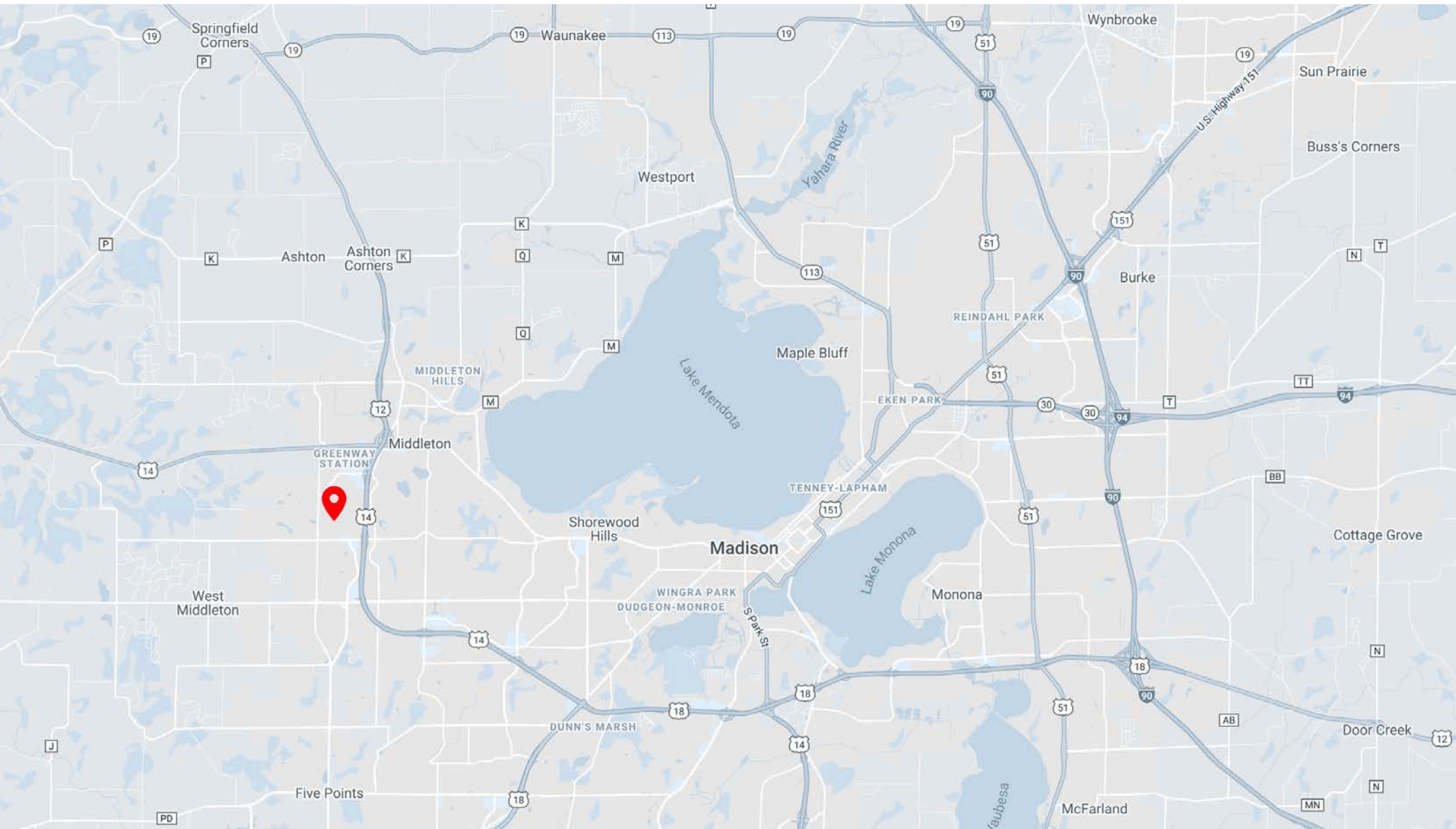
FLOOR PLAN - THIRD FLOOR
