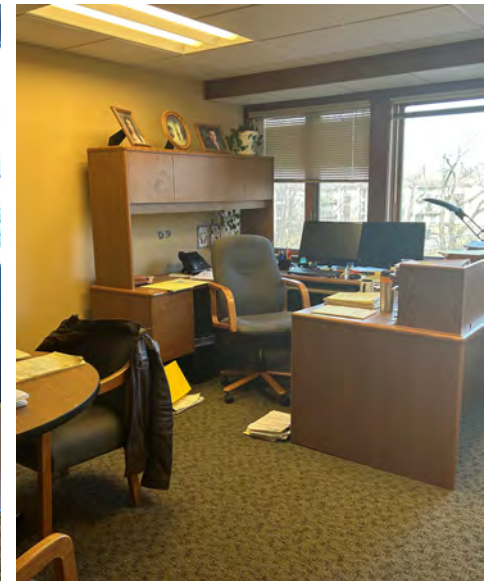
Close to many restaurants and service businesses. Excellent access to East and West via the W. Beltline Highway. Off Mineral Point Road. Monument signage is in place.

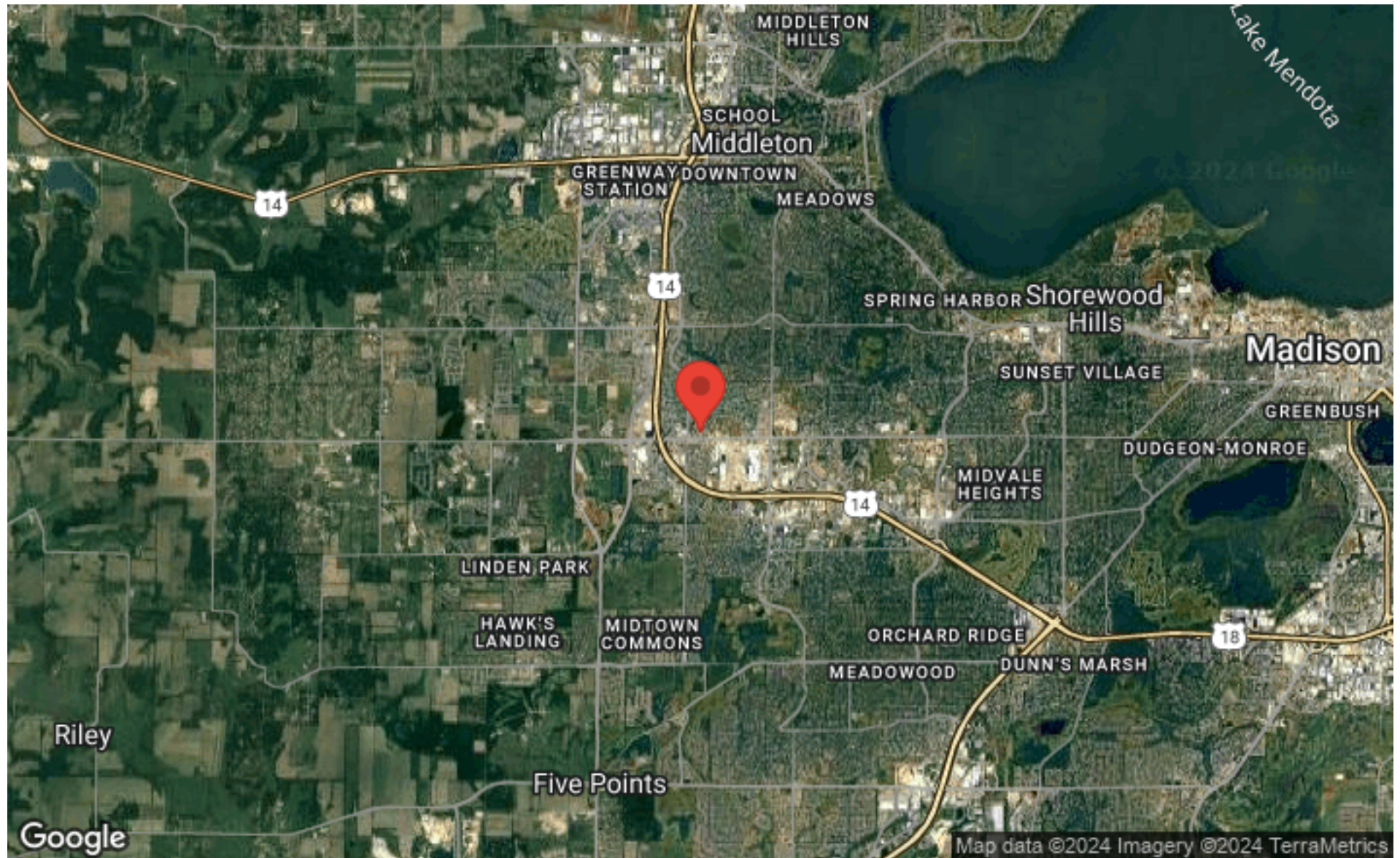

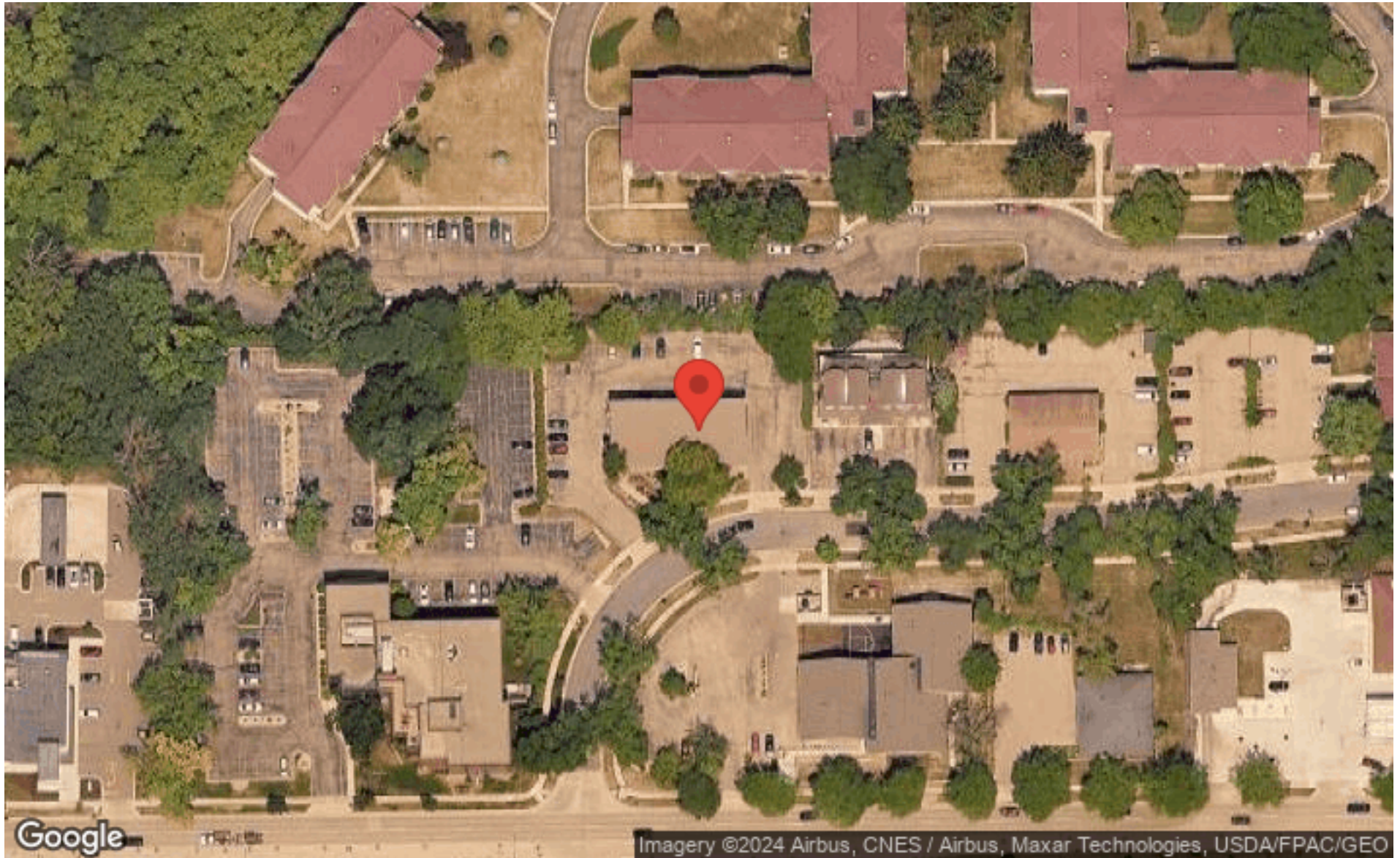

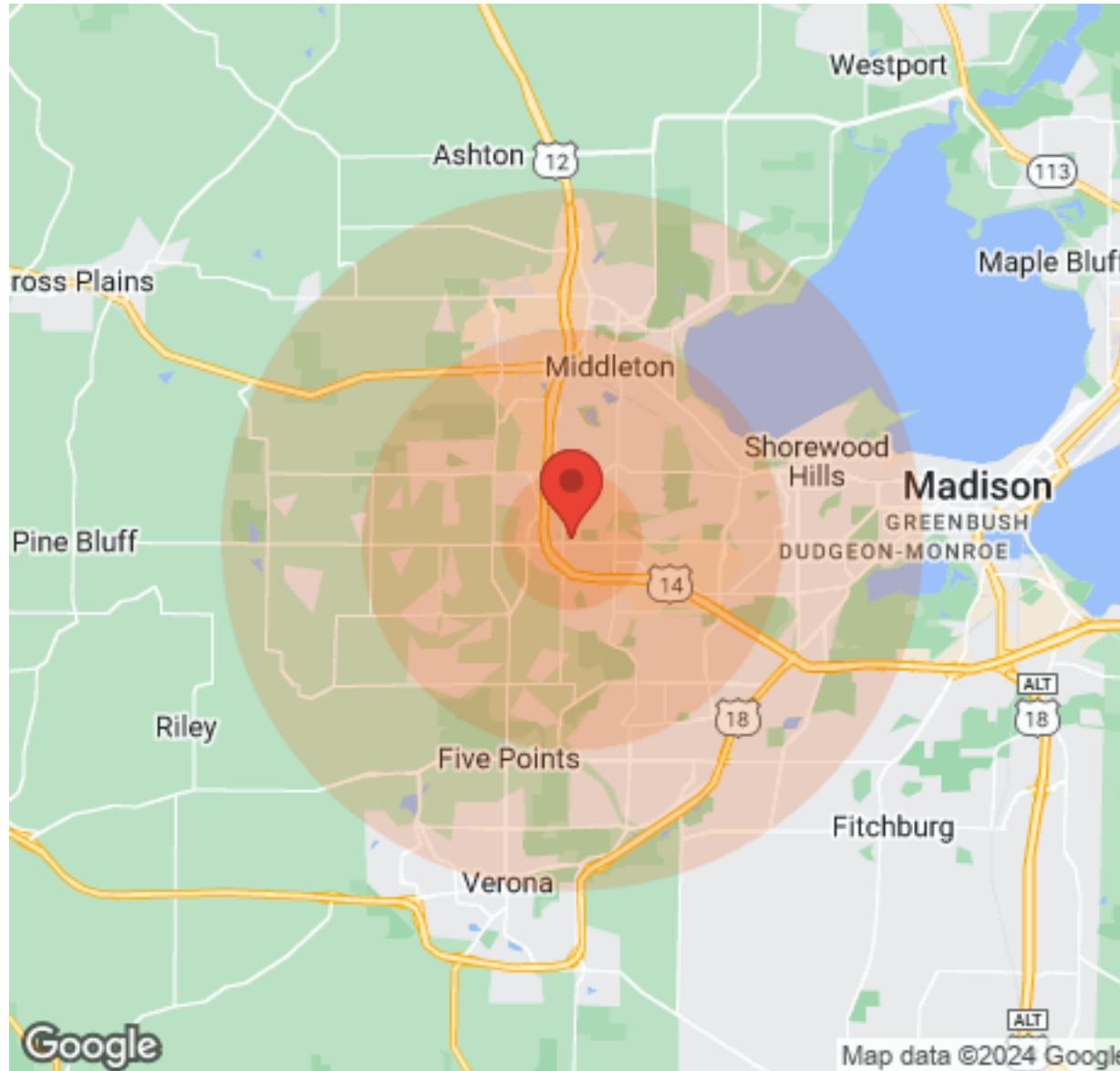
