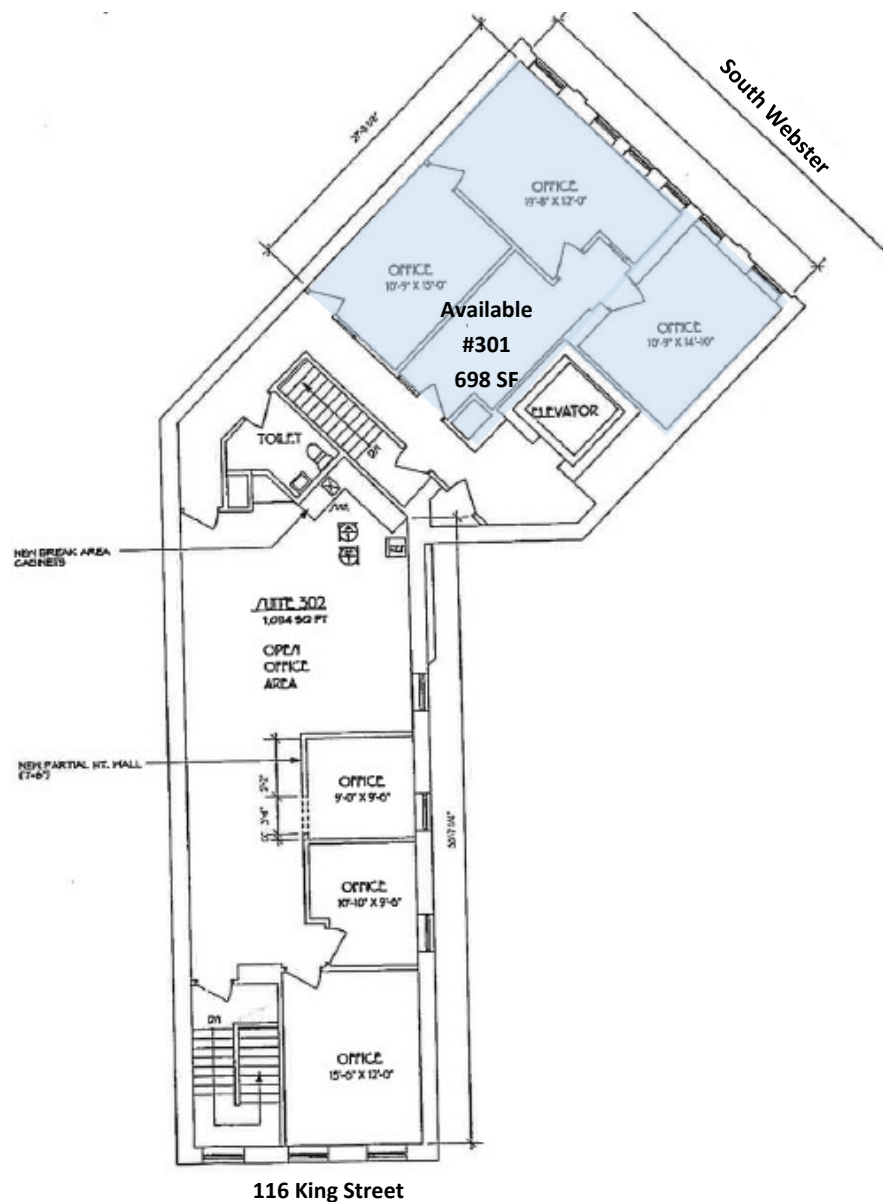
FLOOR PLAN - 116 KING STREET

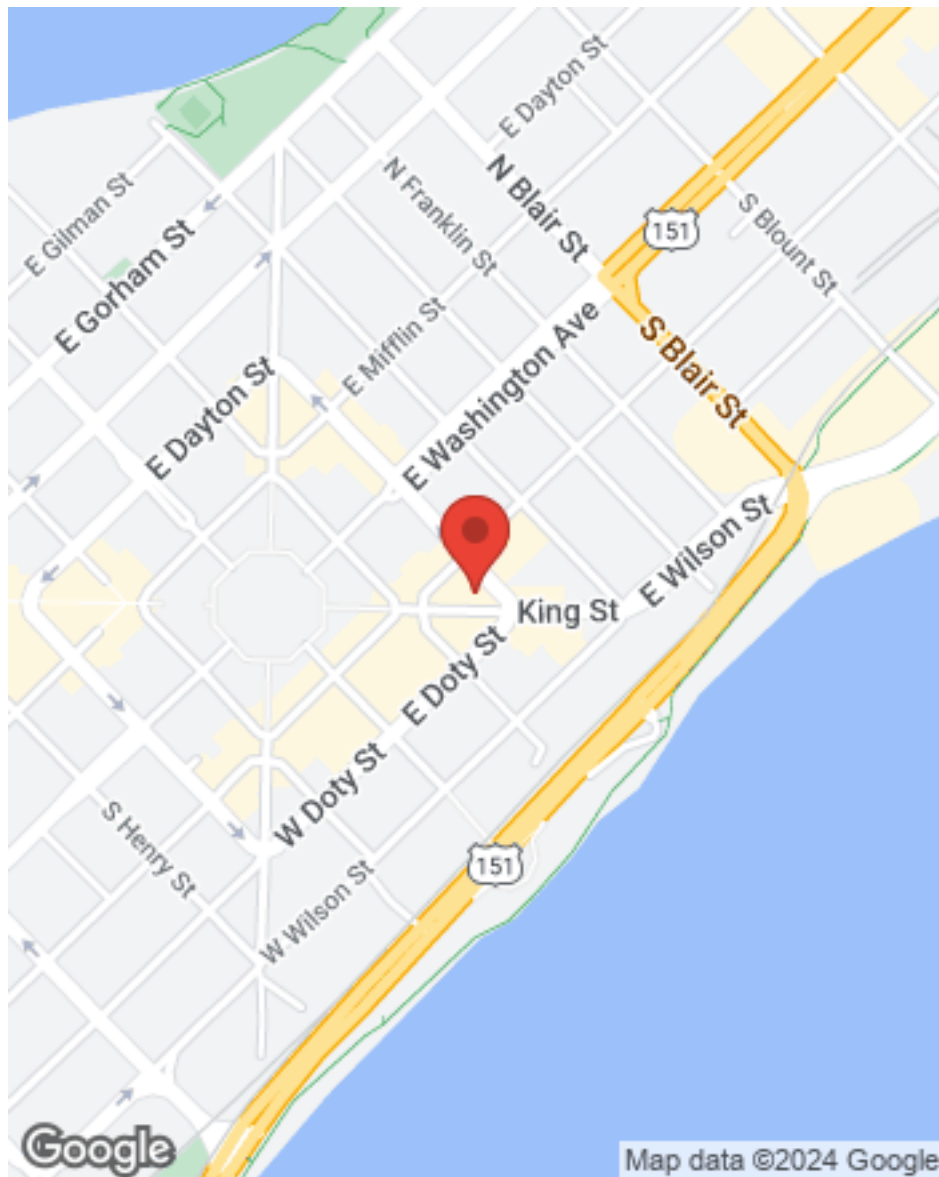
