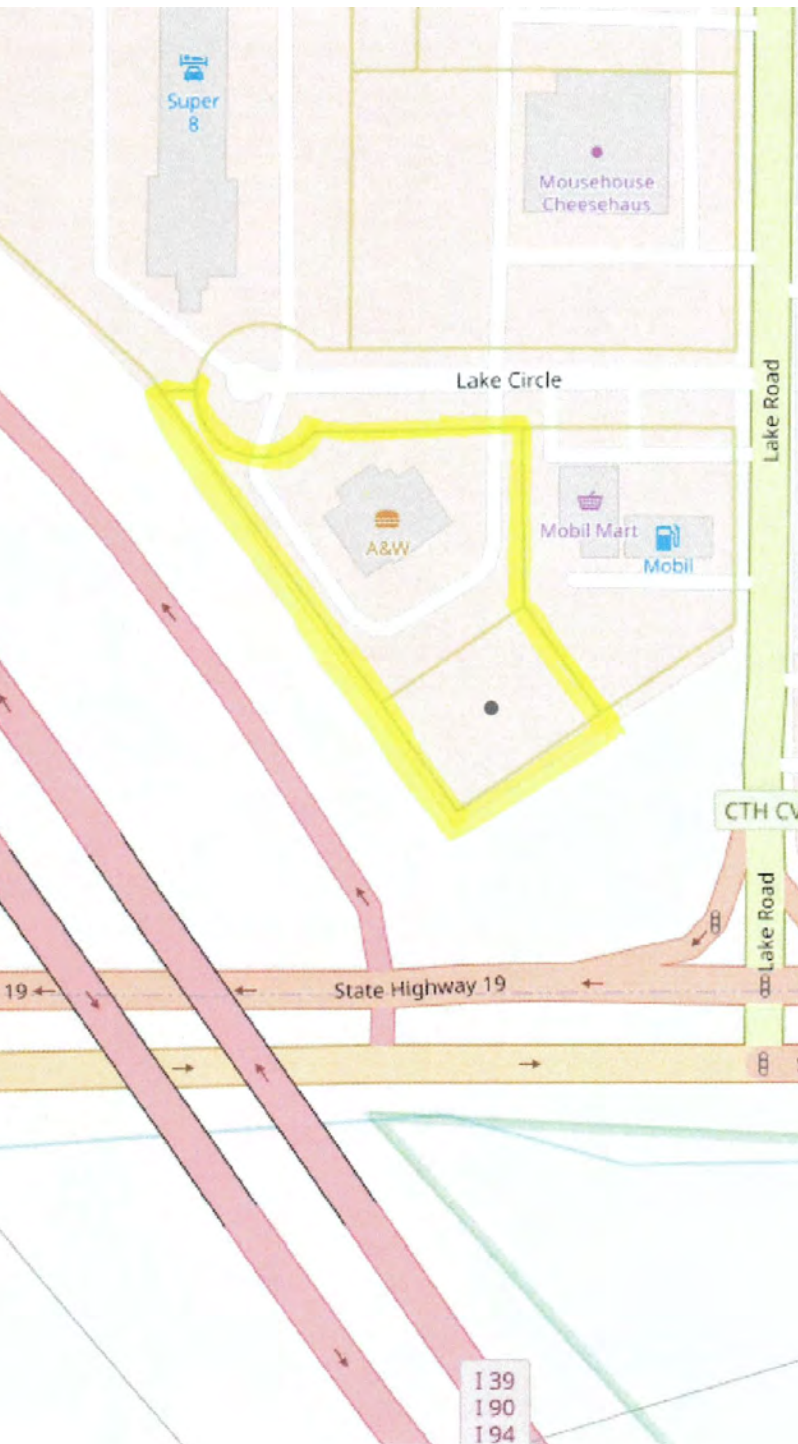

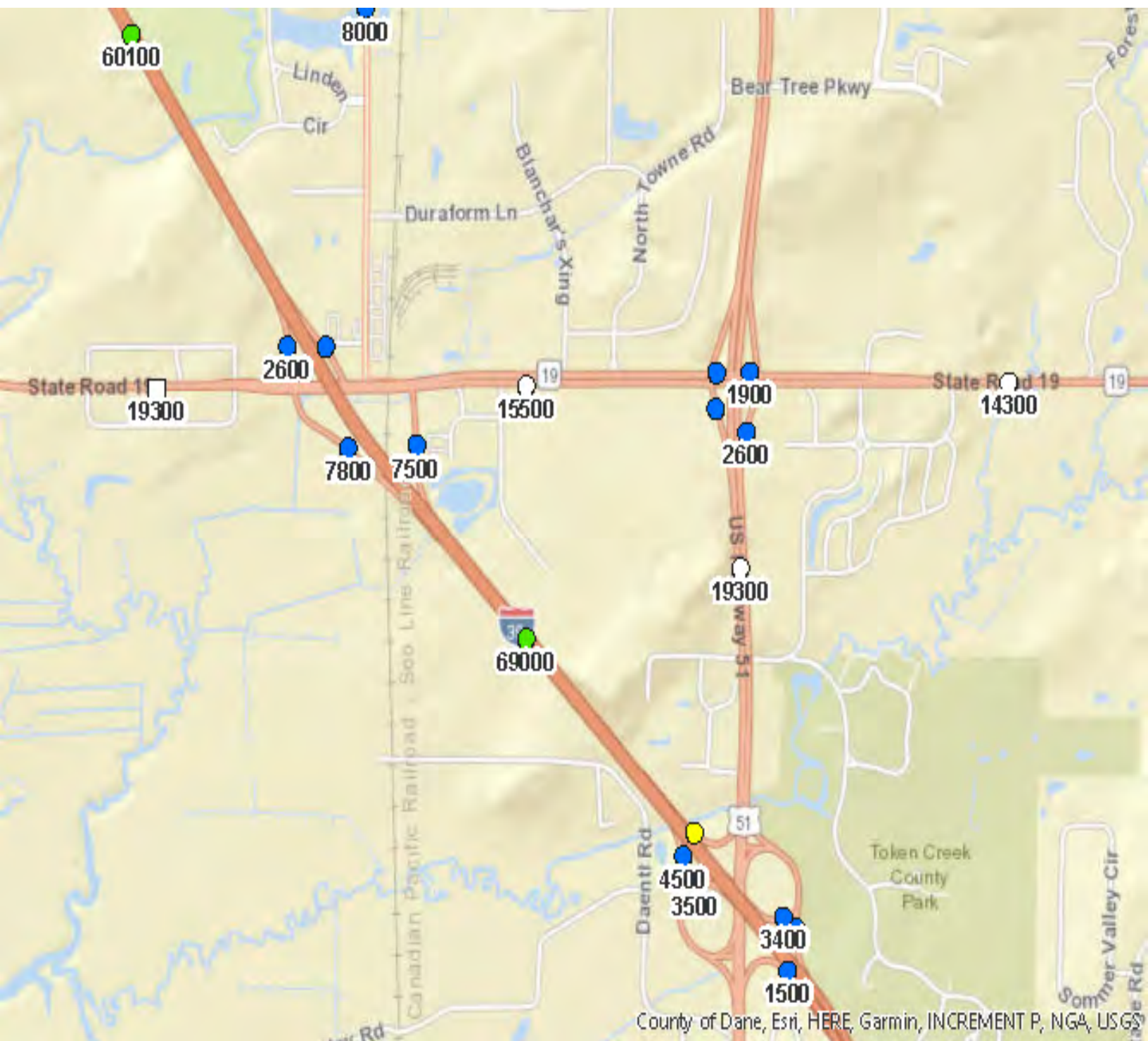
// AERIAL MAP

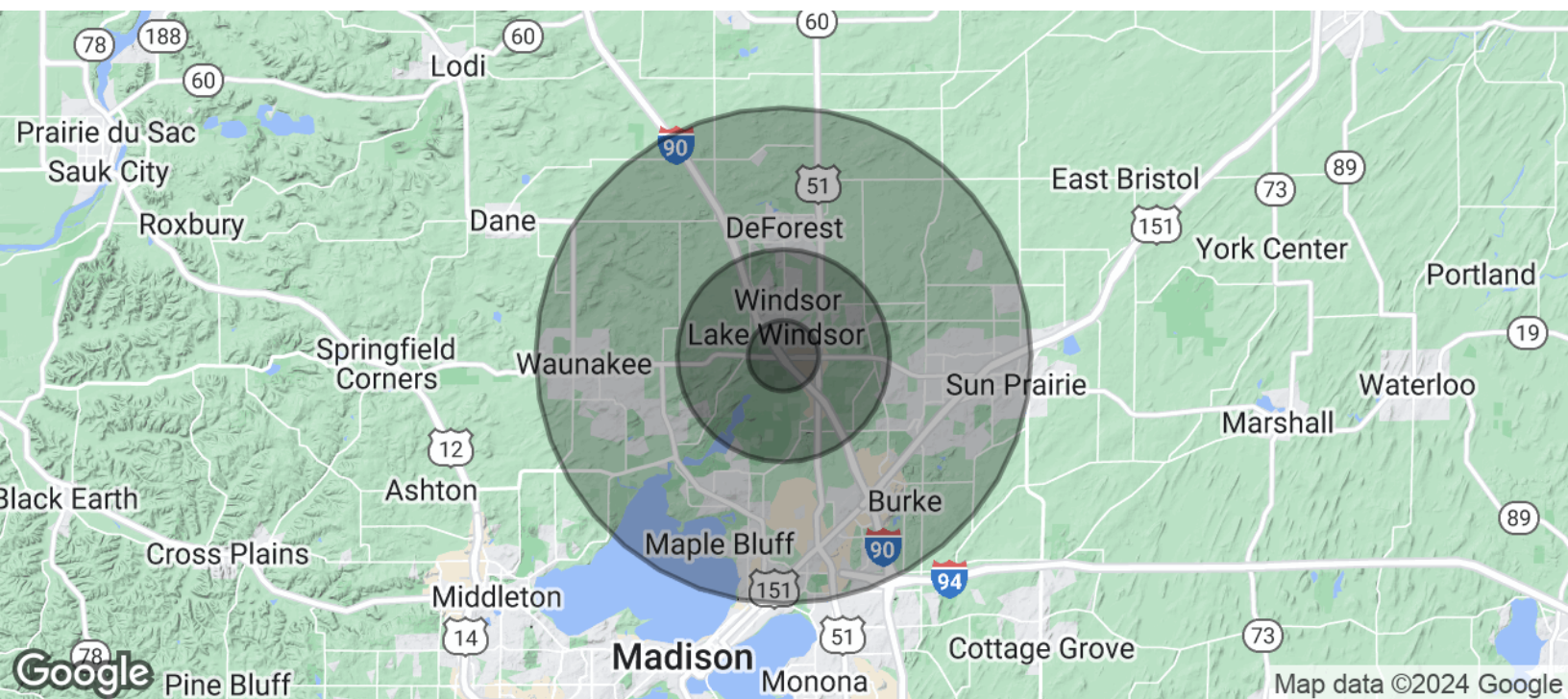
// TRAFFIC COUNT
