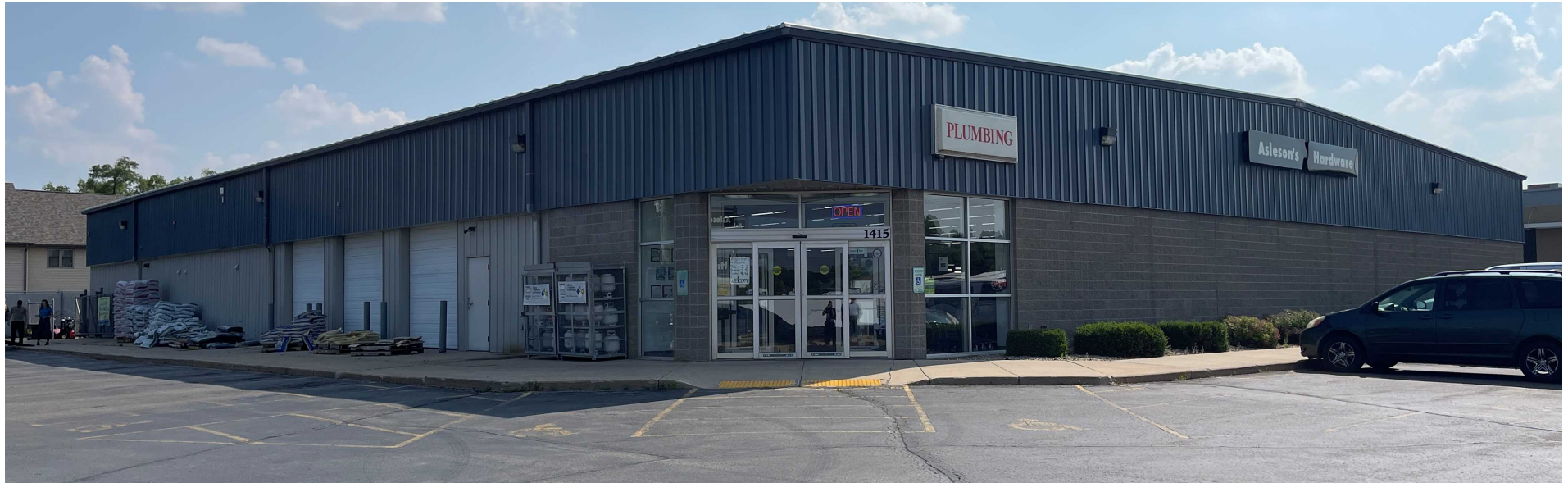

This 18,000 SF flex building currently has 13,000 SF of heated and cooled showroom, 3,960 SF of heated service/storage area with floor drains, and a 1,040 SF area which includes a break room, two restrooms, and two mezzanine level offices. The building has (1) 12'x12' OH Door, (1) 8'x8" OH Door, and (3) 10'x10' OH Doors.

Tenant is additionally responsible for RE Taxes, Insurance, CAM, Utilities, and On-site Maintenance.

Location Overview

1415 US Hwy 51 is located in the heart of Stoughton with premium visibility on Highway 51. Stoughton's main vehicular artery is Highway 51, which drives 12,400 vehicles per day past the building. The site is slightly elevated compared to its eastern neighboring properties, providing additional visibility.

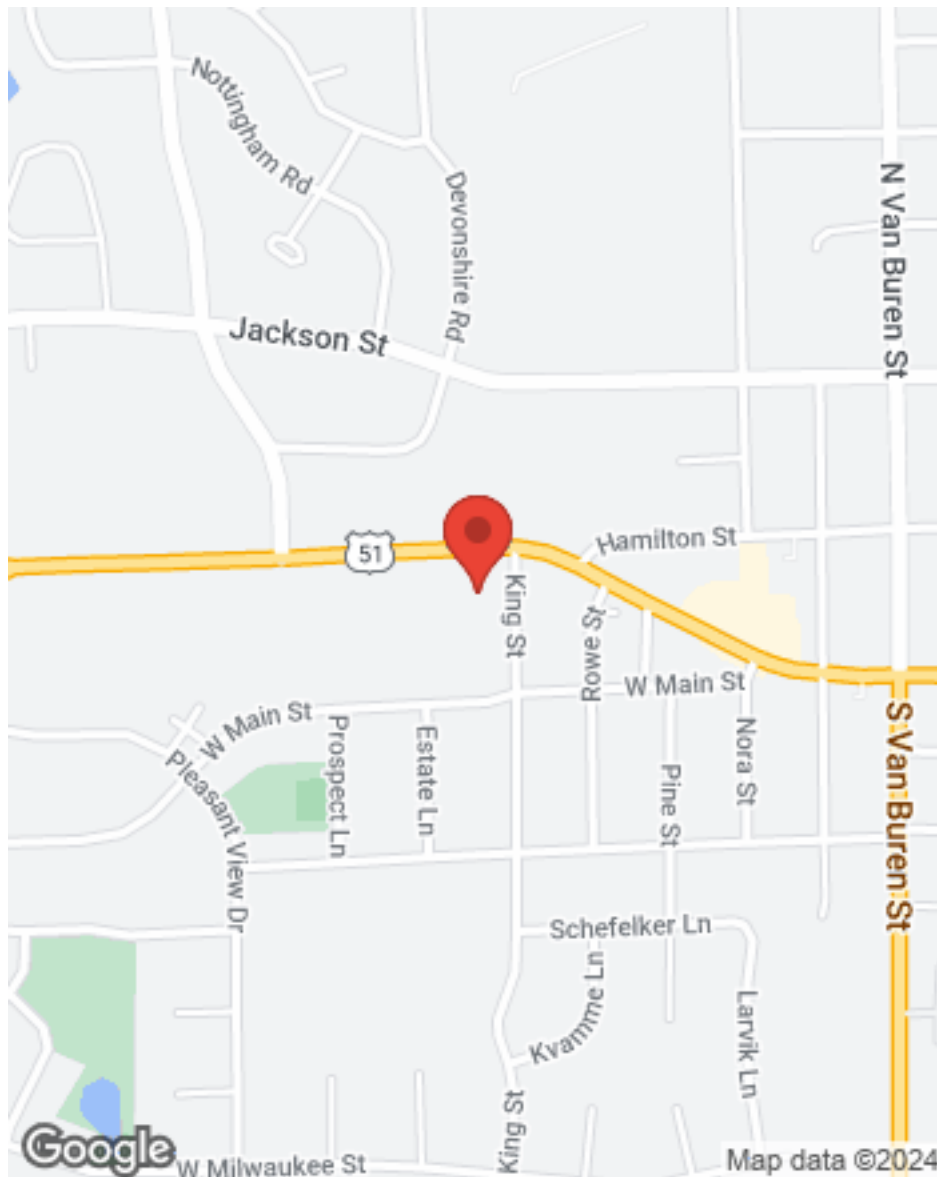

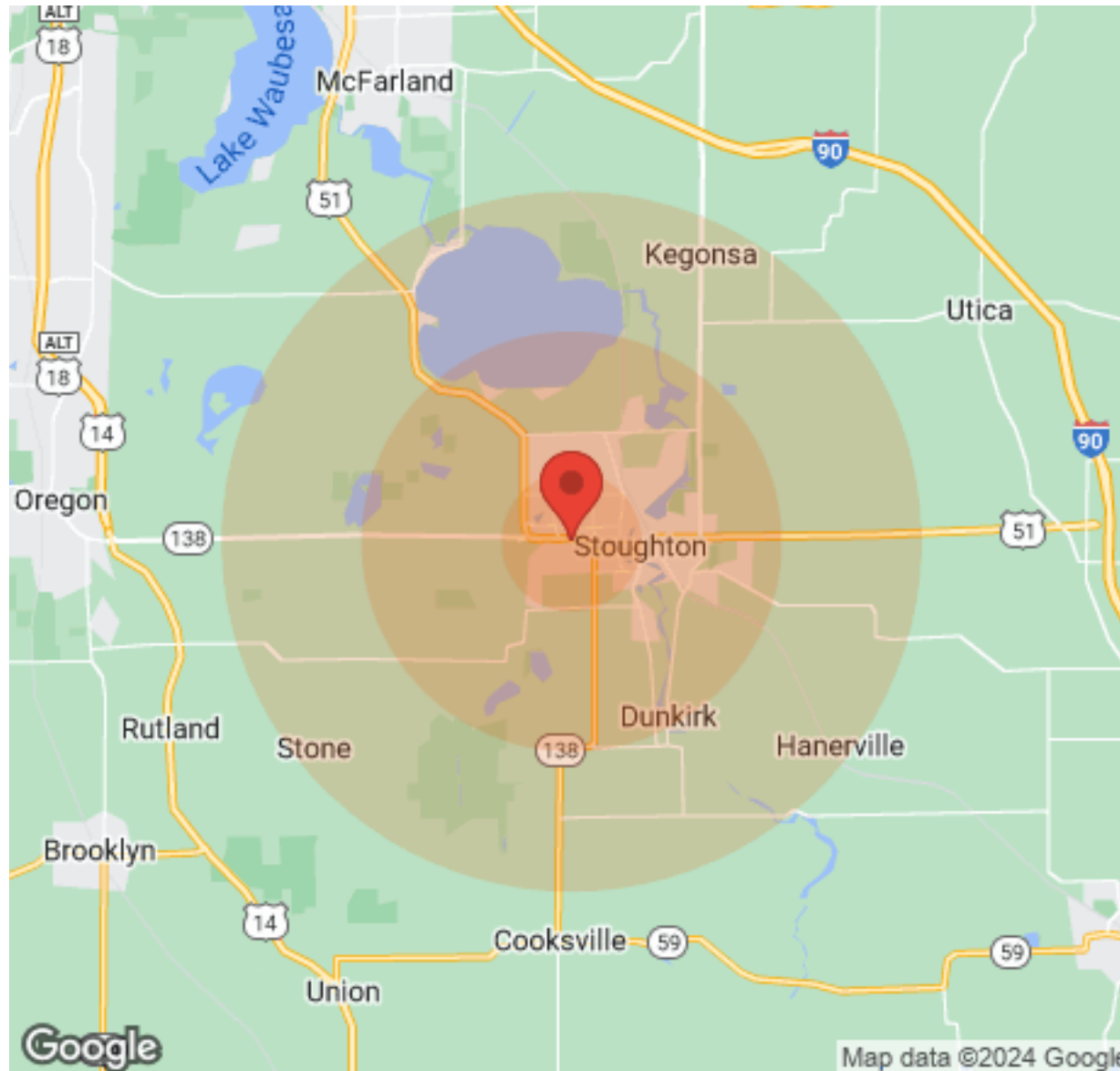
