

Ideally Located ~16 Acre Commercial Property The well-kept ~16 acres is conveniently situated along US 18/151, which the WI DOT has identified as a "Backbone Route", connecting the major Midwest cities of Madison WI and Dubuque IA. Zoned B-3 Heavy Business, the property currently has a Conditional Use Permit for warehouse storage, but the zoning would allow for a wide variety of business possibilities- While the location allows for quick and easy access to US 18/151, the property itself is private and located at the end of a quiet town road. Existing infrastructure includes a large electrical power system utilizing three-phase conductors and a cable system to handle the power load. There are also 3 wells on the property, one of which is high capacity. Also included are a variety of large and small outbuildings and a well-maintained 3 bedroom, 2 bathroom ranch home. An additional 24.246 acres are available for an additional \$240,000. With the 40 acres there is the possibility of changing the zoning back to A-1 and a return to the exclusive agriculture designation. Wellknown institutions and companies with headquarters in the area include the University of WI Madison, Epic Systems in Verona, Duluth Trading Co in Mt Horeb, Lands End in Dodgeville and Vortex Optics in Barneveld. Located in the beautiful Driftless Area of Southwest WI, the property is adjacent to the Military Ridge State Bike Trail and near many other recreational opportunities including state parks, great golf courses, wonderful restaurants and the many entertainment venues this area has to offer. With the purchase of the additional 24 acres it would also include wonderful wildlife habitat and excellent hunting.
