South of the Beltline and east of US Hwy 51 on the southeast side of Madison. Access is via Voges Road, near Marsh Road.

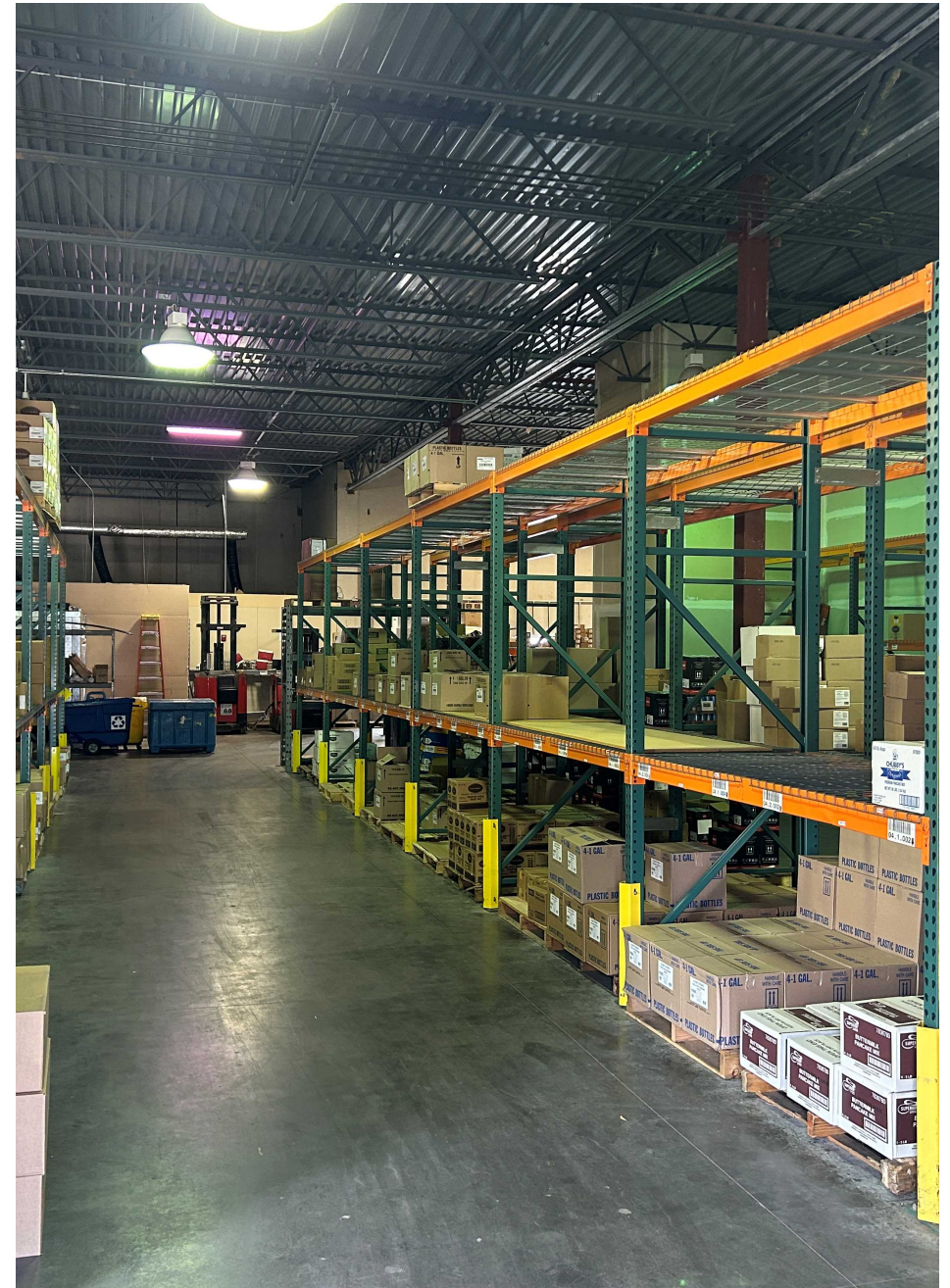

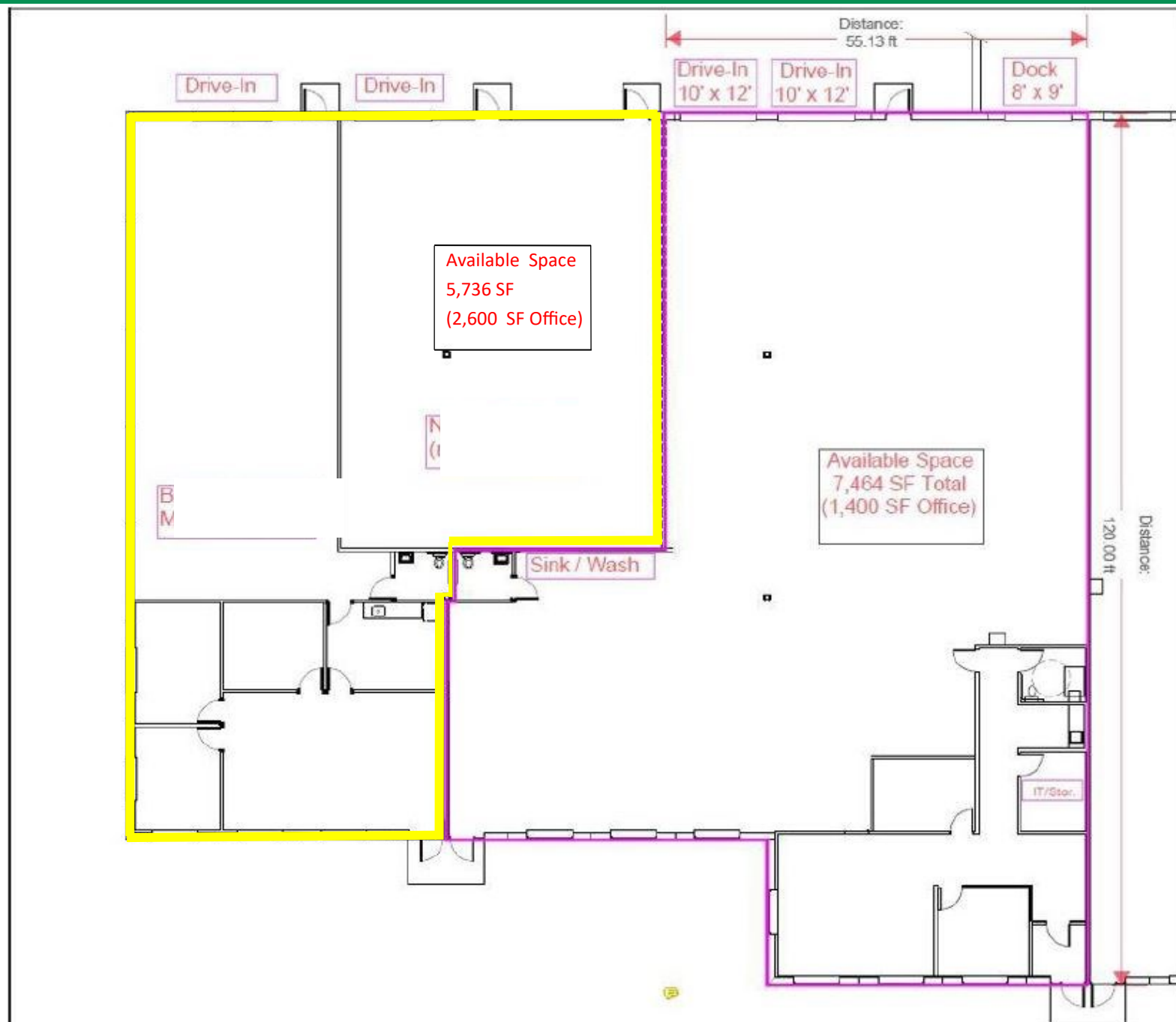

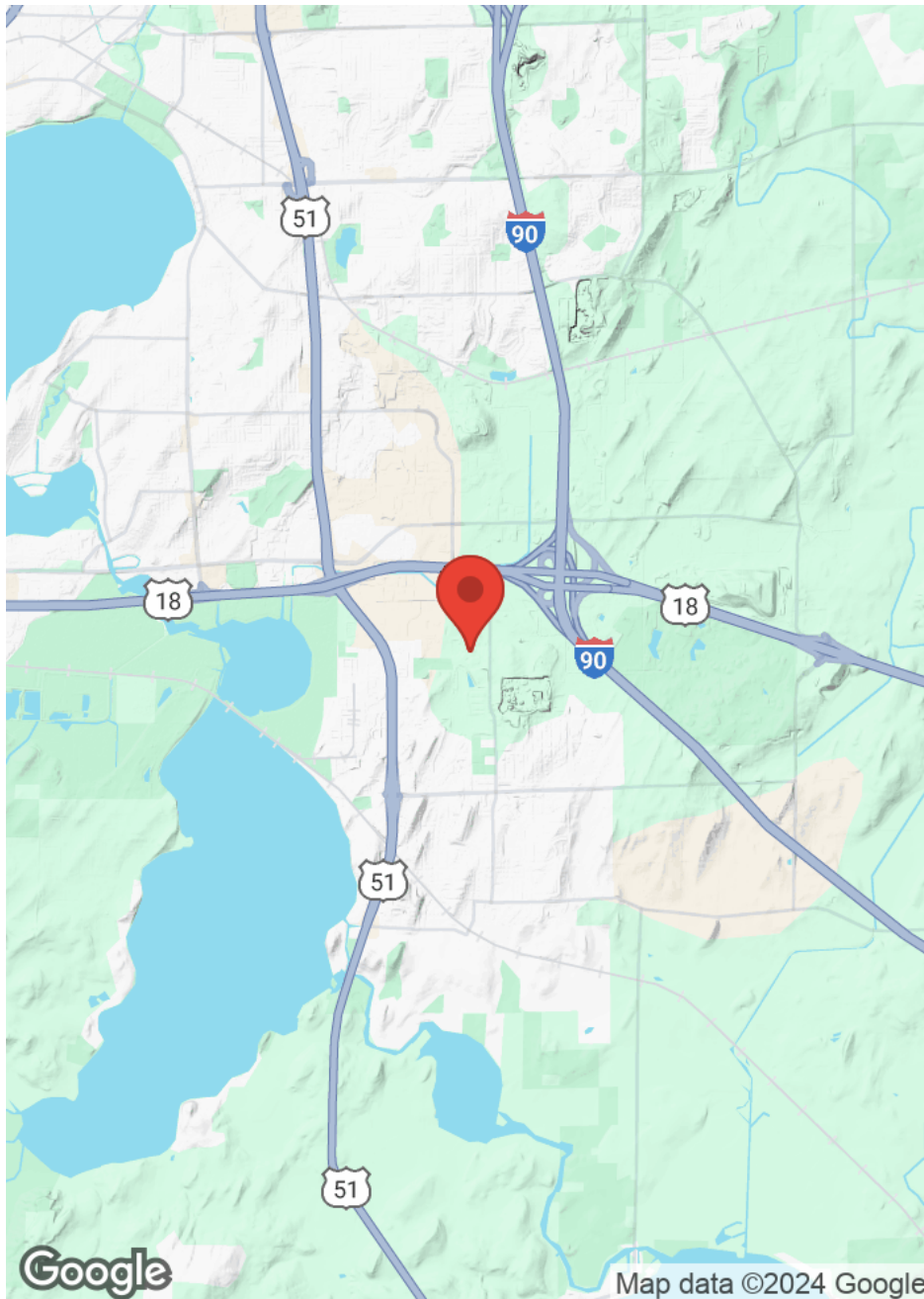

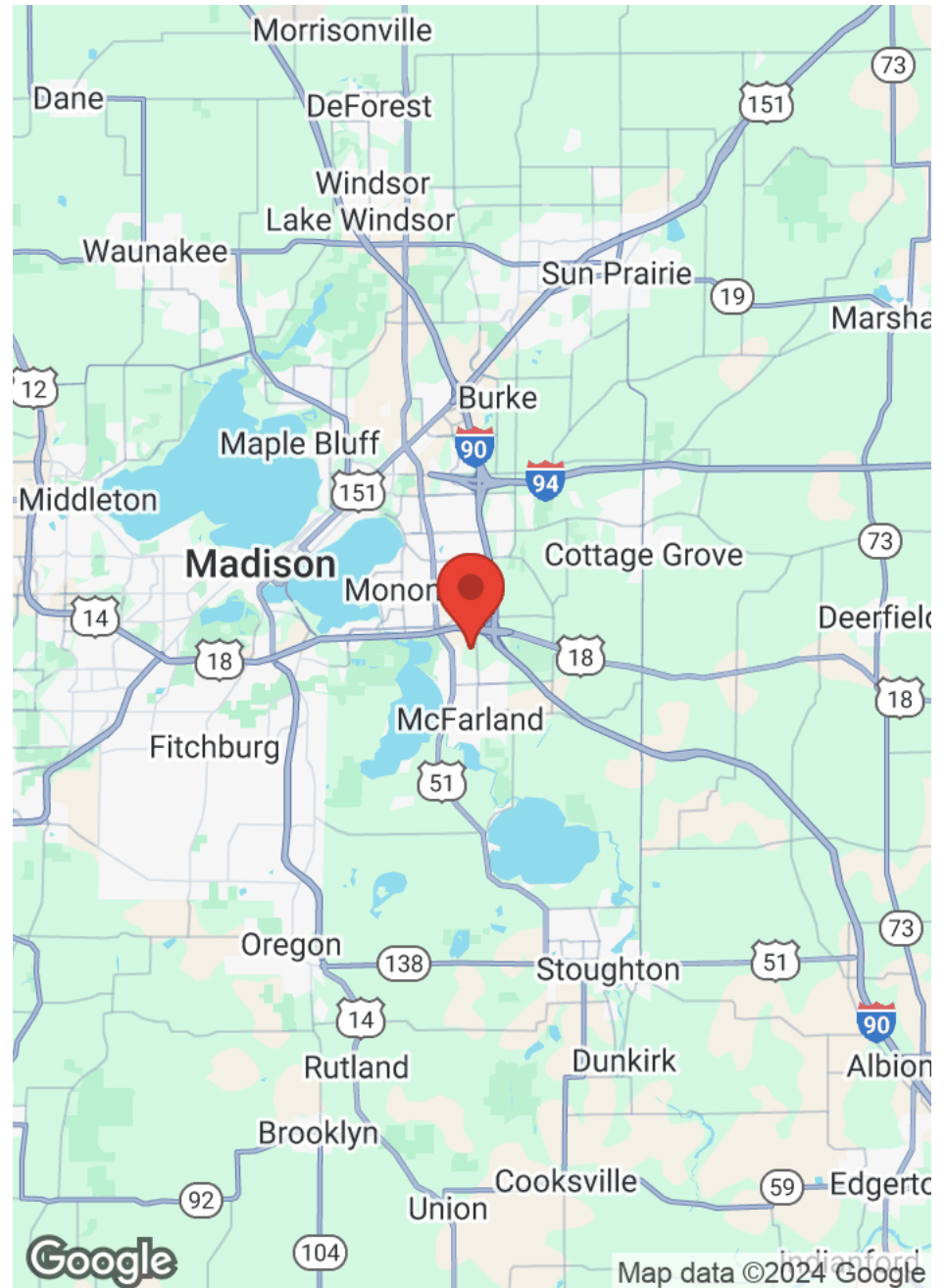
LOCATION MAPS

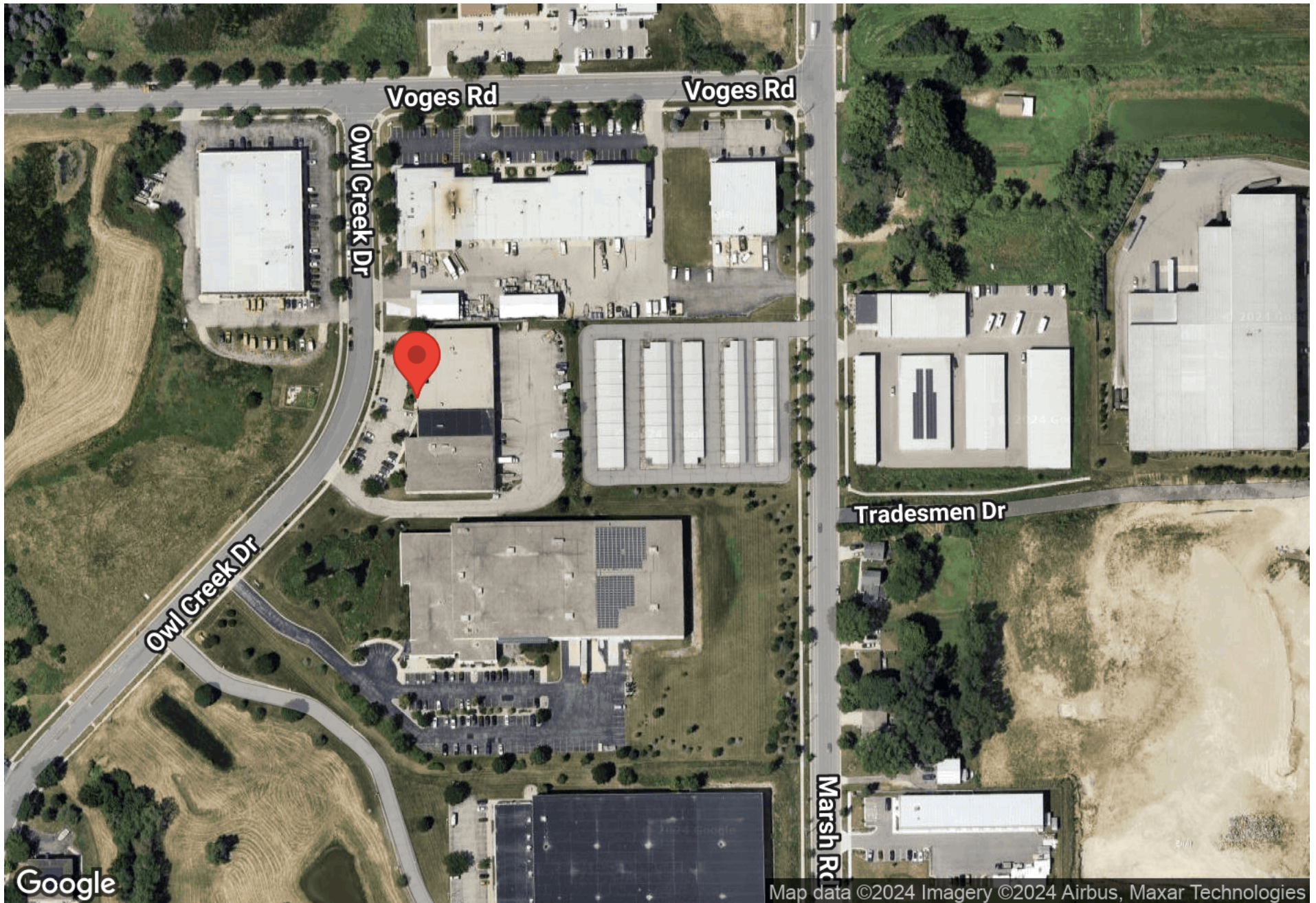
