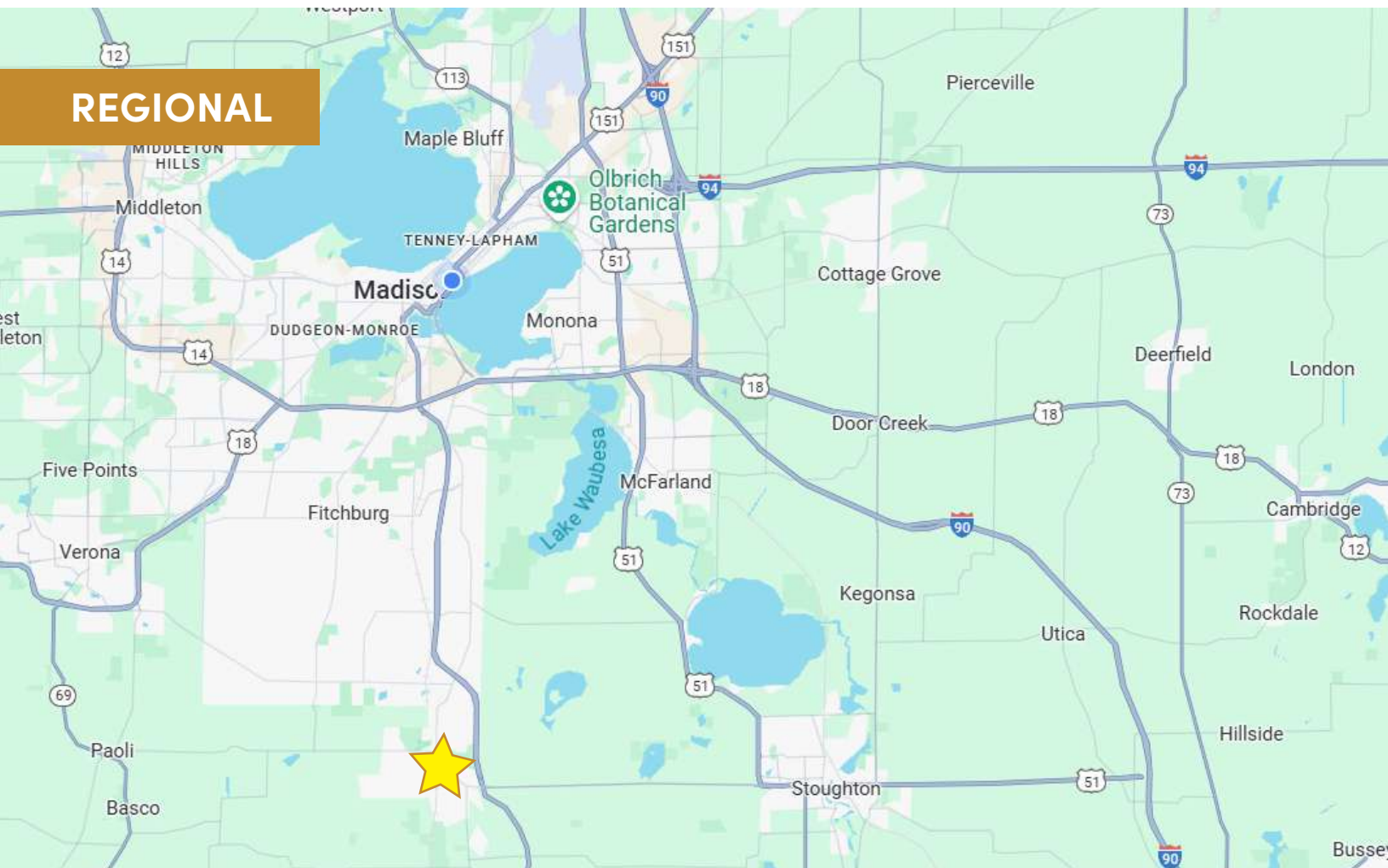




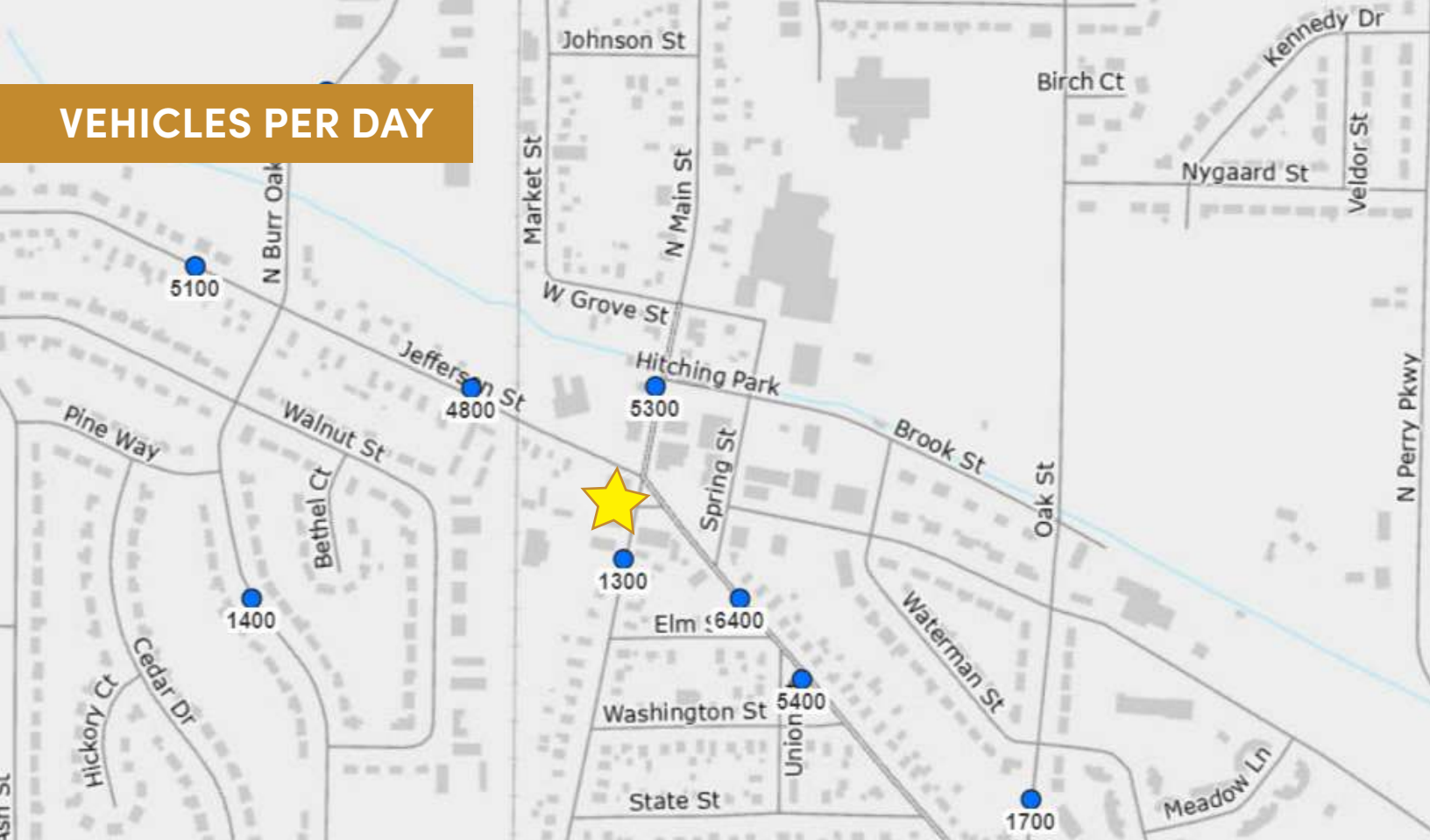
LOCATION



REGIONAL



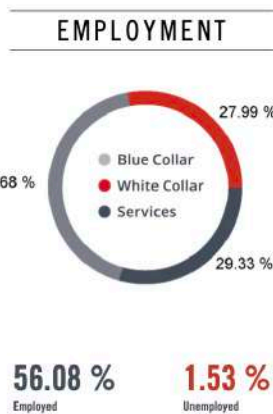
VEHICLES PER DAY

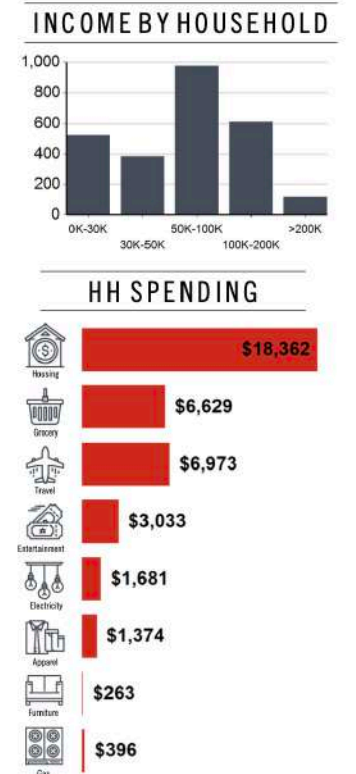
