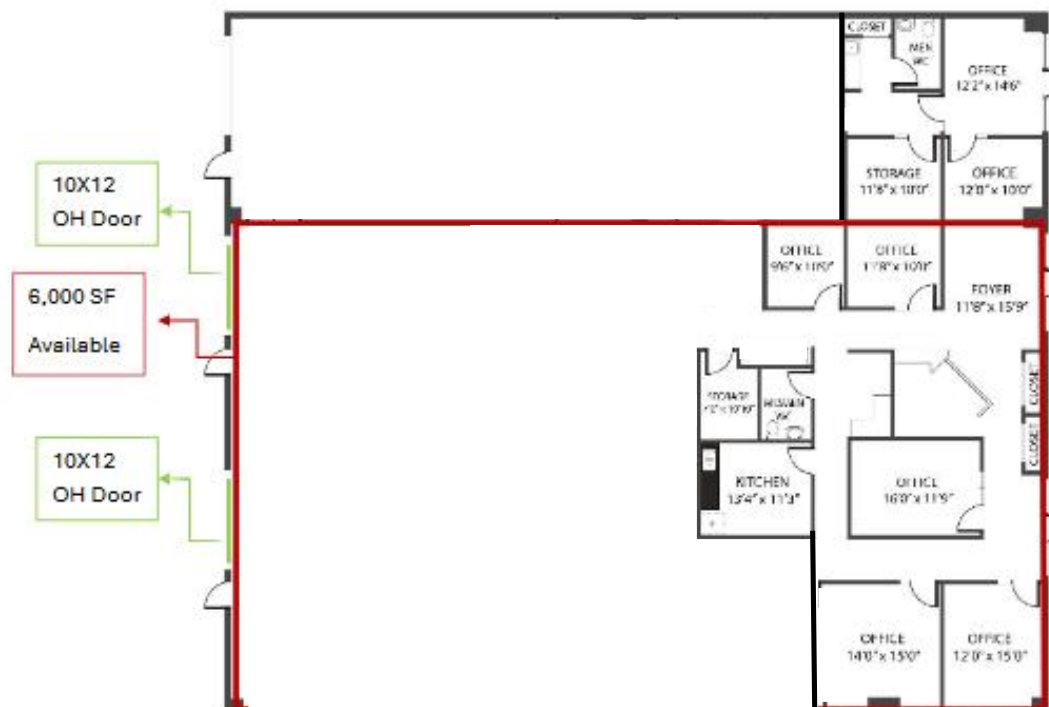

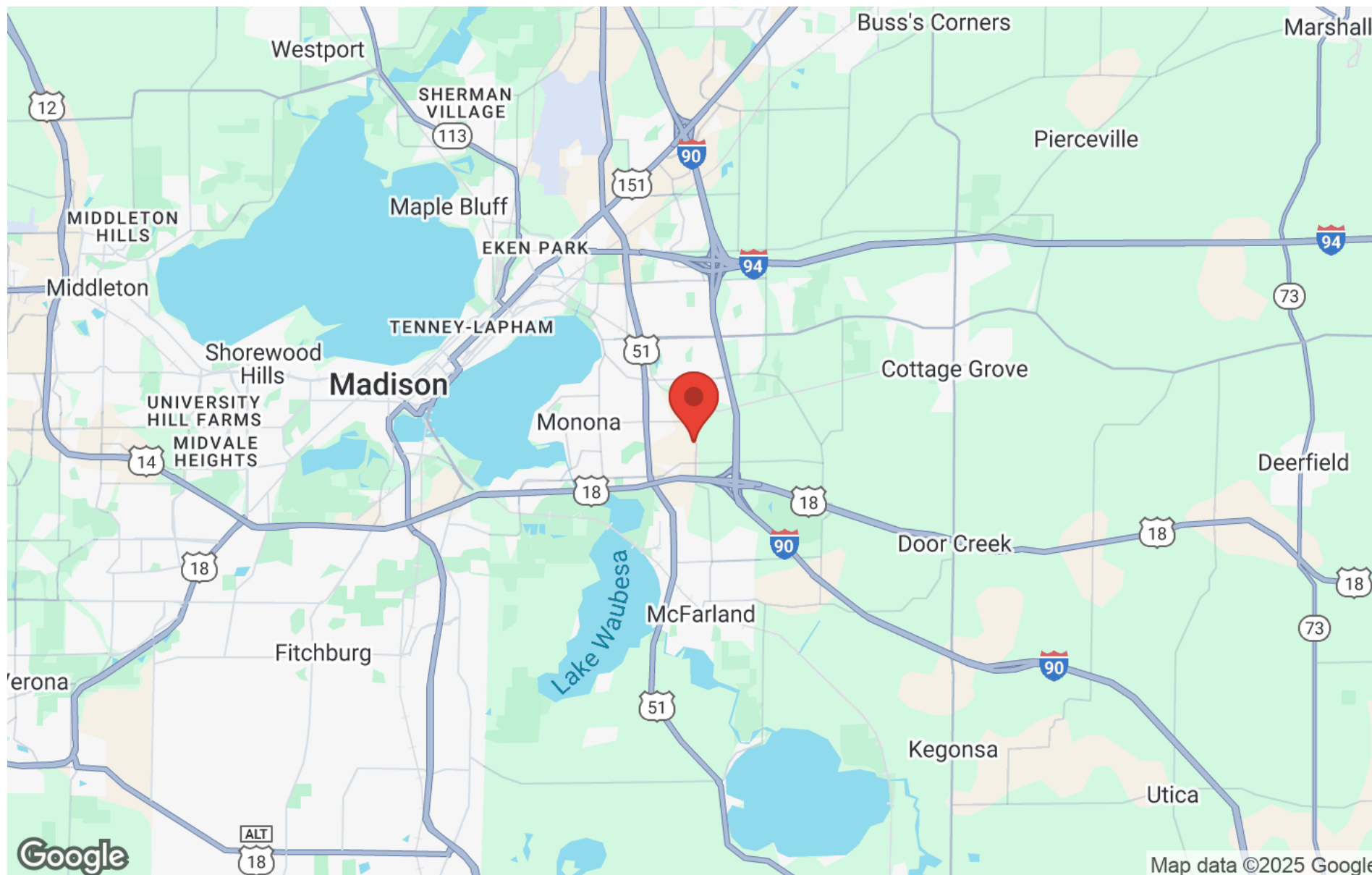

State of Wisconsin - Disclose to Non-Residential Customers
