



DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

3 DISCLOSURE TO CUSTOMERS You are a customer of the brokerage firm (hereinafter Firm). 16 (f) The duty to safeguard trust funds and other property held by the Firm or its Agents.

17 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals. 18
