All measurements are approximate, buyer to verify if material. There's a no compete and a first right of refusal with Gasser's Tru Value.

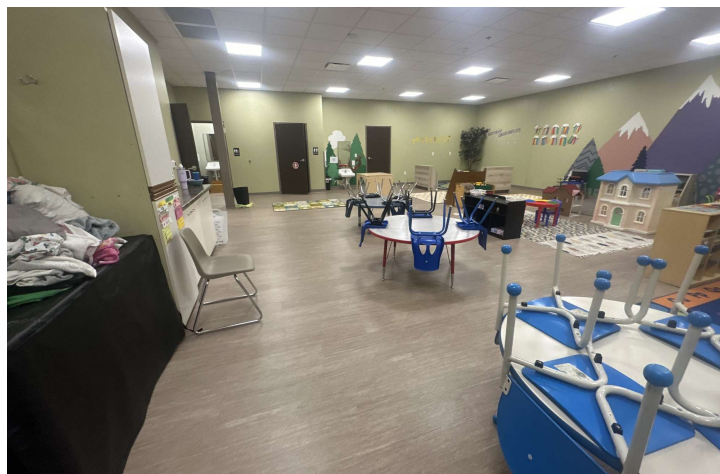
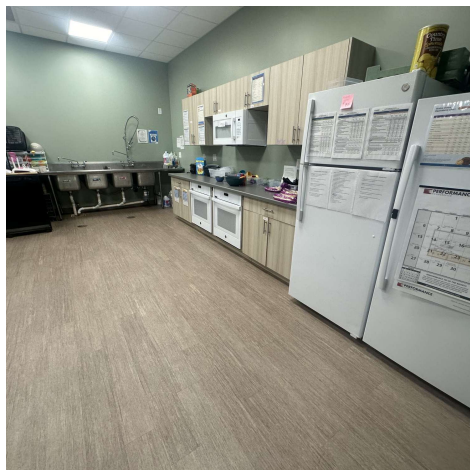
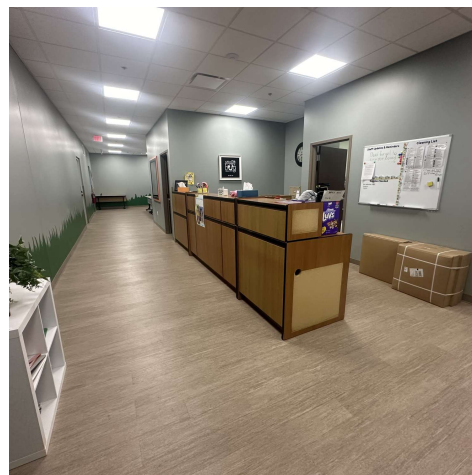
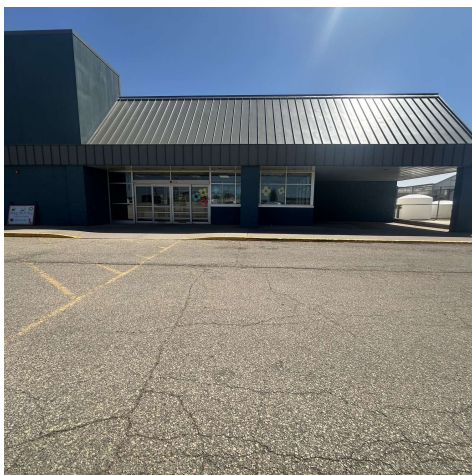


FORMER SHOPKO ON 4.2 ACRE SITE

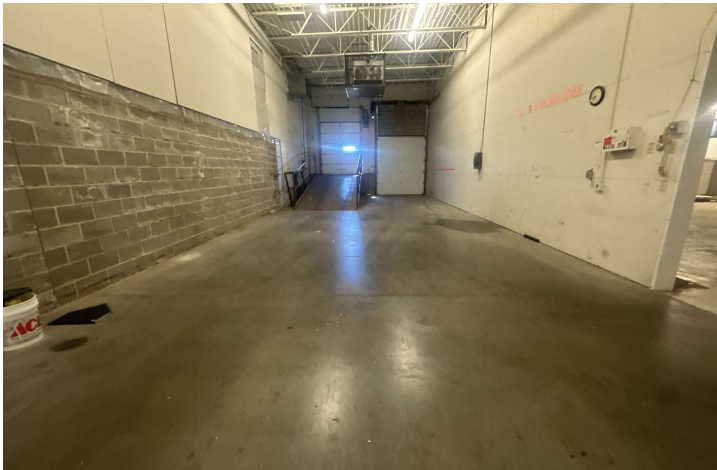
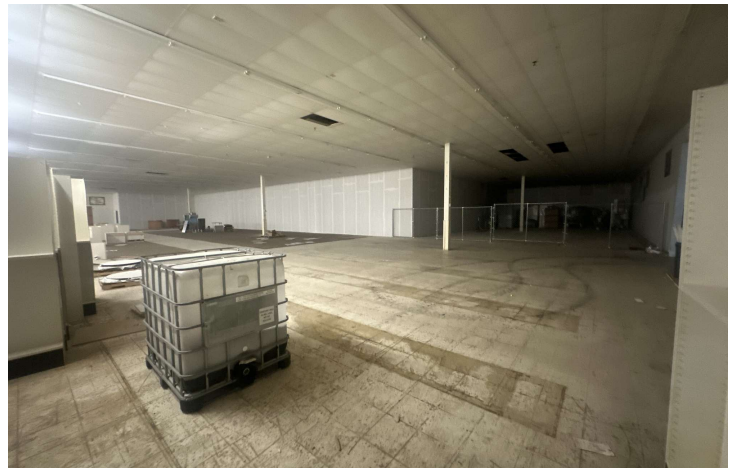
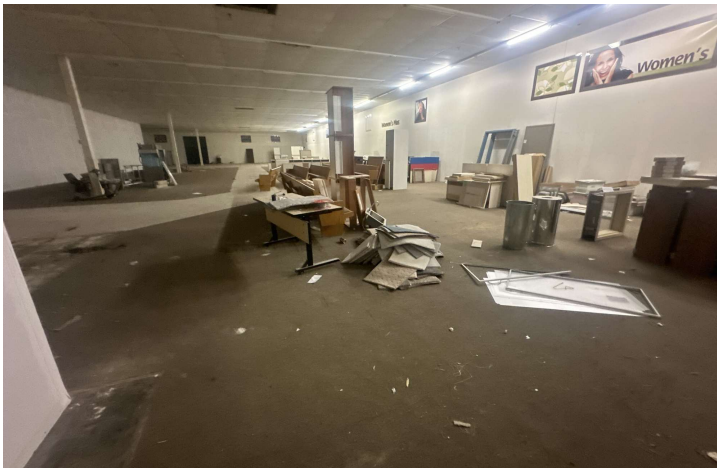
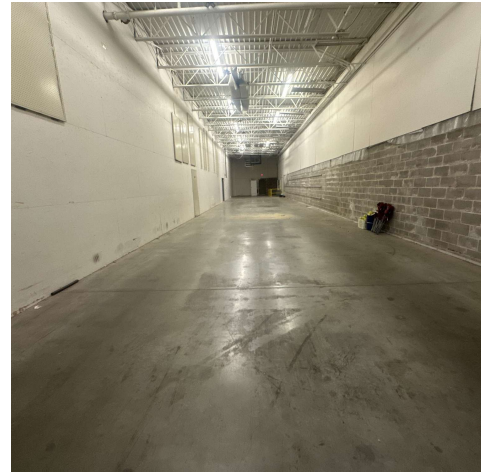


FORMER SHOPKO ON 4.2 ACRE SITE
