Building size is 21,710sf split in 2 areas by an 8' roll-up fire door, with 3 14' overhead doors in different areas. The 14,460sf ~(132' x 100') original building built in 2001 has 18'-22' ceilings, 2 14' overhead doors, and 1,276sf (24' x 53') office space with 3 offices, reception, storage, and a break room, with a mezzanine above. The 7,250sf ~(50' x 145') addition built in 2006 has 1 14' overhead door and a 12' x 50' mezzanine. Successful wood products business, equipment, and inventory is also for sale for \$275k.

17 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the
18 advantages and disadvantages of the proposals.
