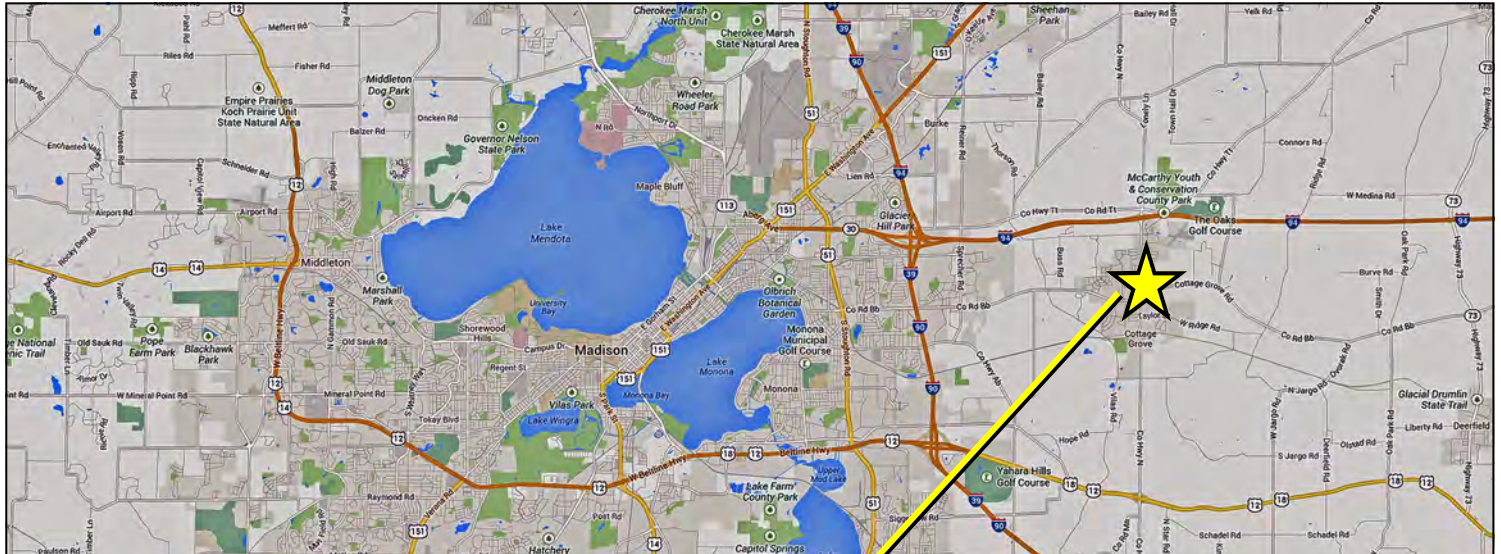

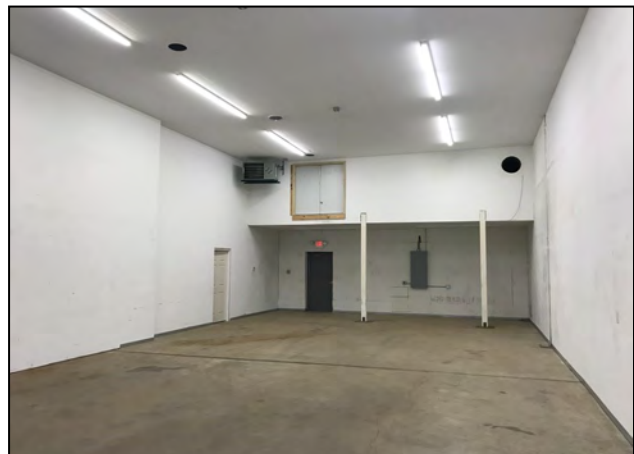

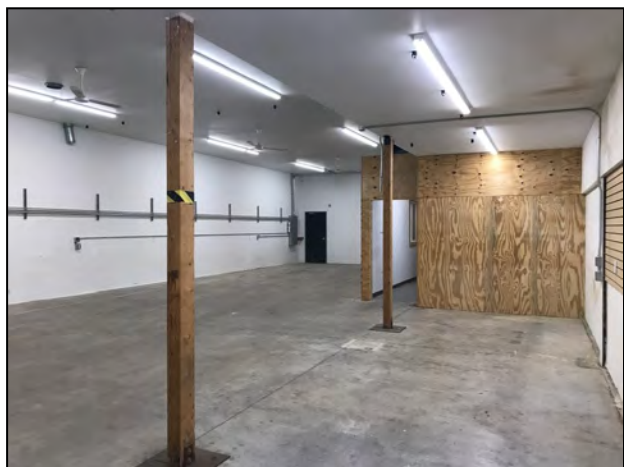
612 North Main Street - Unit 102 (2,737 Sq. Ft.)

17 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the
18 advantages and disadvantages of the proposals.
