Versatile industrial unit featuring 2,500 SF with a 40'x25' air-conditioned office. Warehouse includes 17' peak and 14' eave heights, 10'x10' overhead door, and 8'x10' dock door with edge-of-dock leveler. 3-phase/200 amp power, LED warehouse lighting, and separately metered gas/electric.






LOCATION MAPS

State of Wisconsin - Disclose to Non-Residential Customers

- (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.
