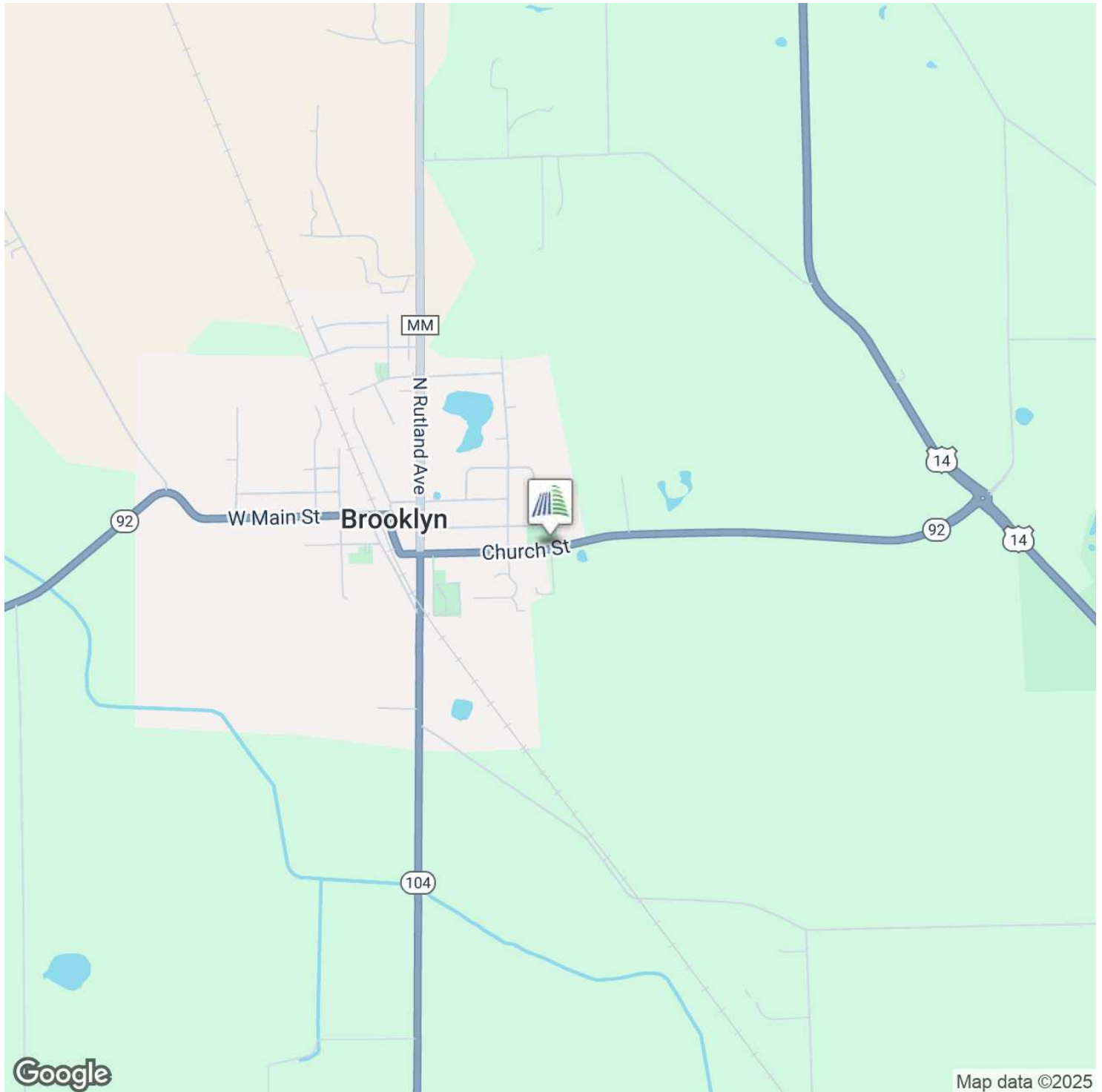

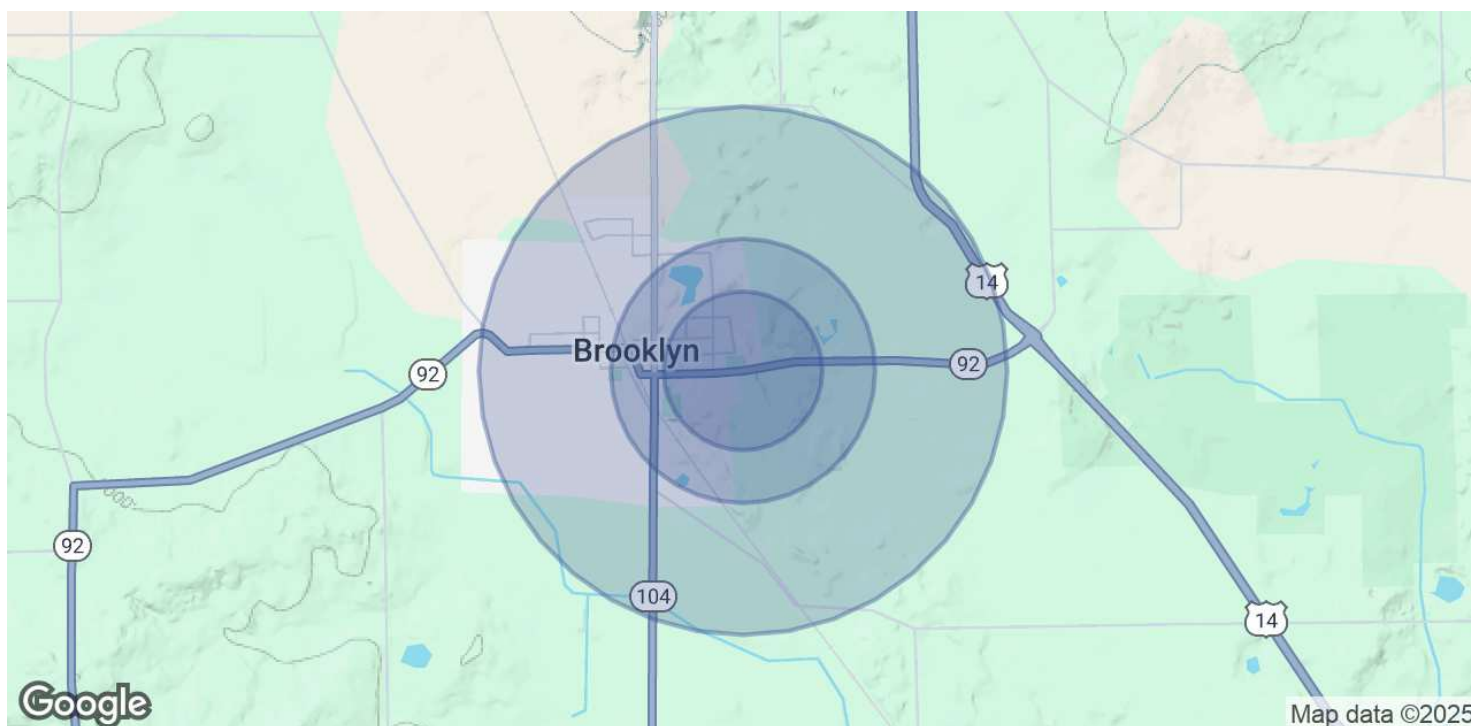
// LOCATION MAP
