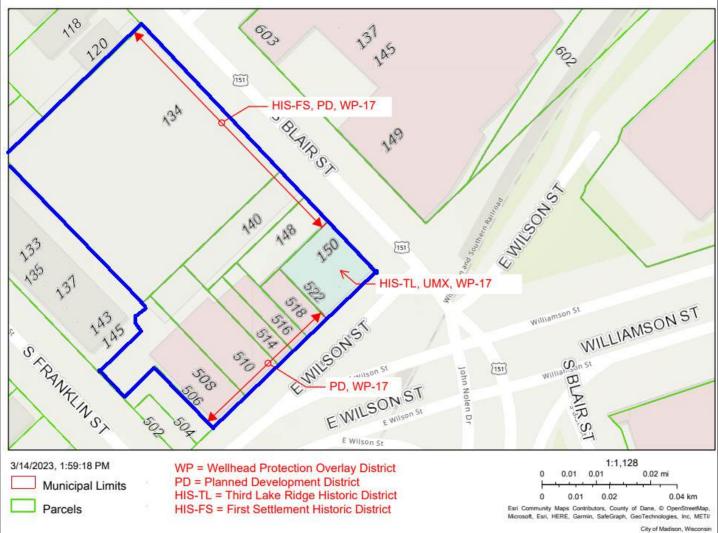

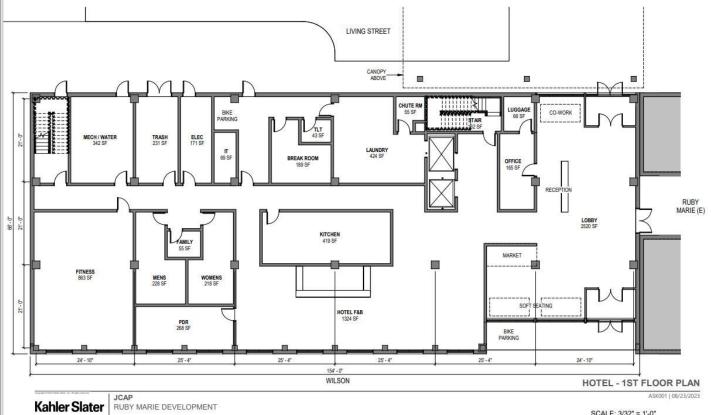




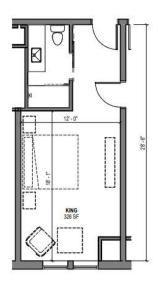
HOTEL - TYPICAL FLOOR PLAN

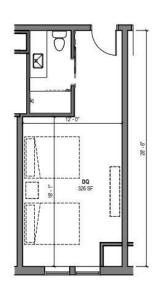

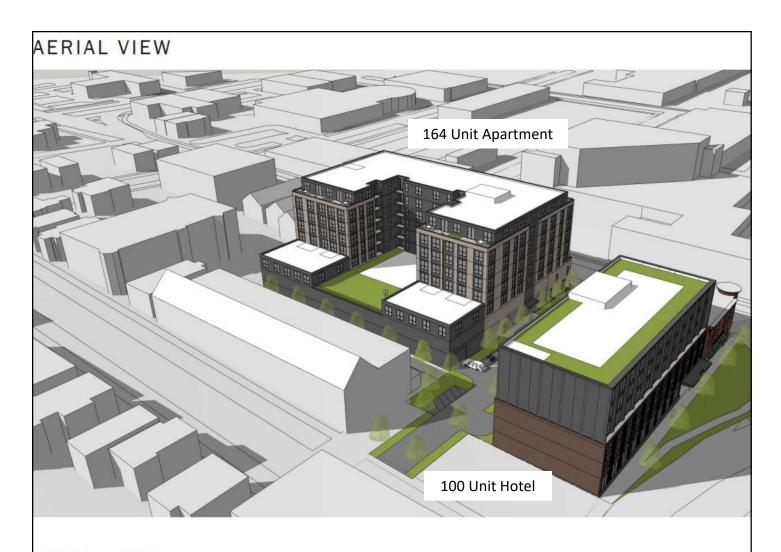
HOTEL - ENLARGED GUEST ROOM PLAN

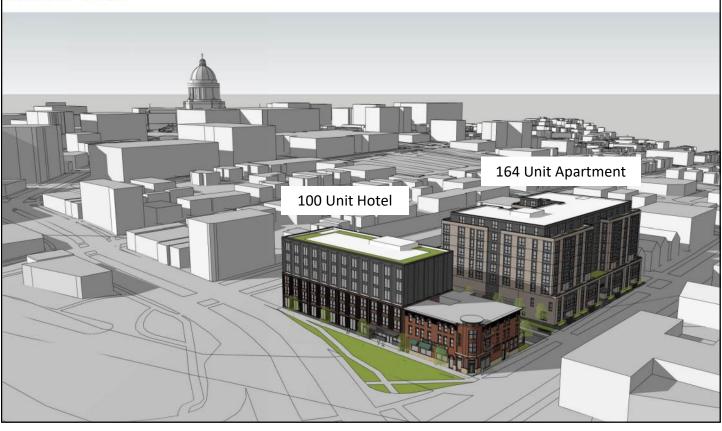

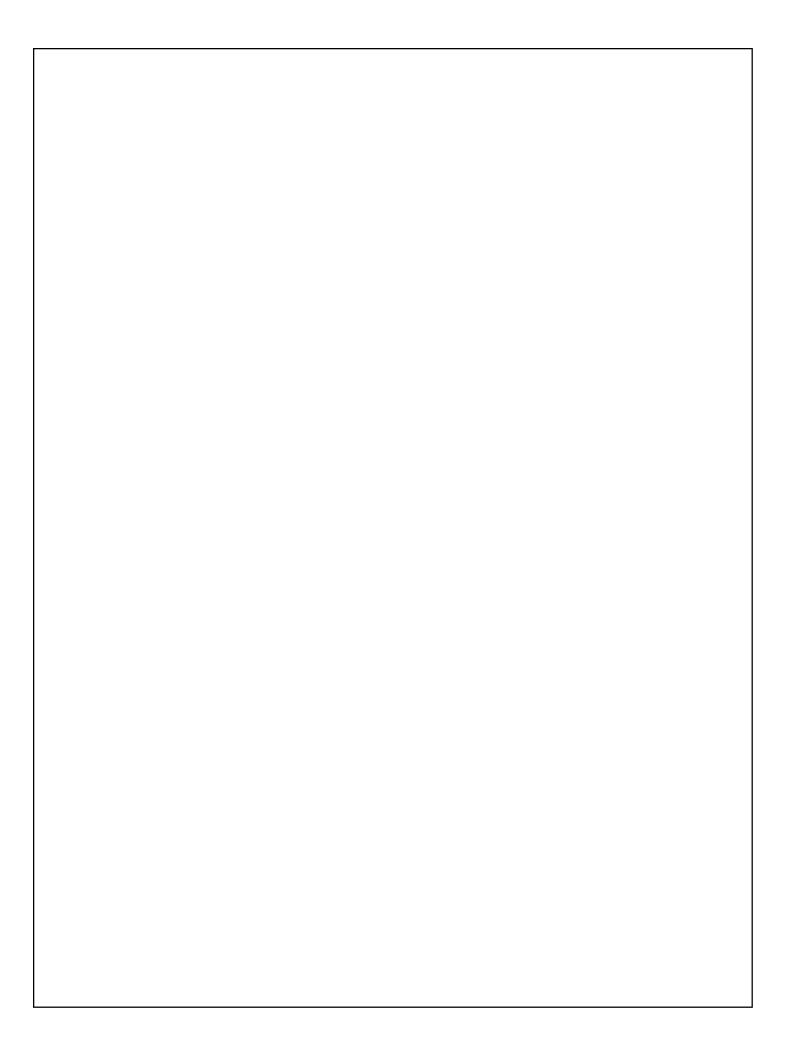


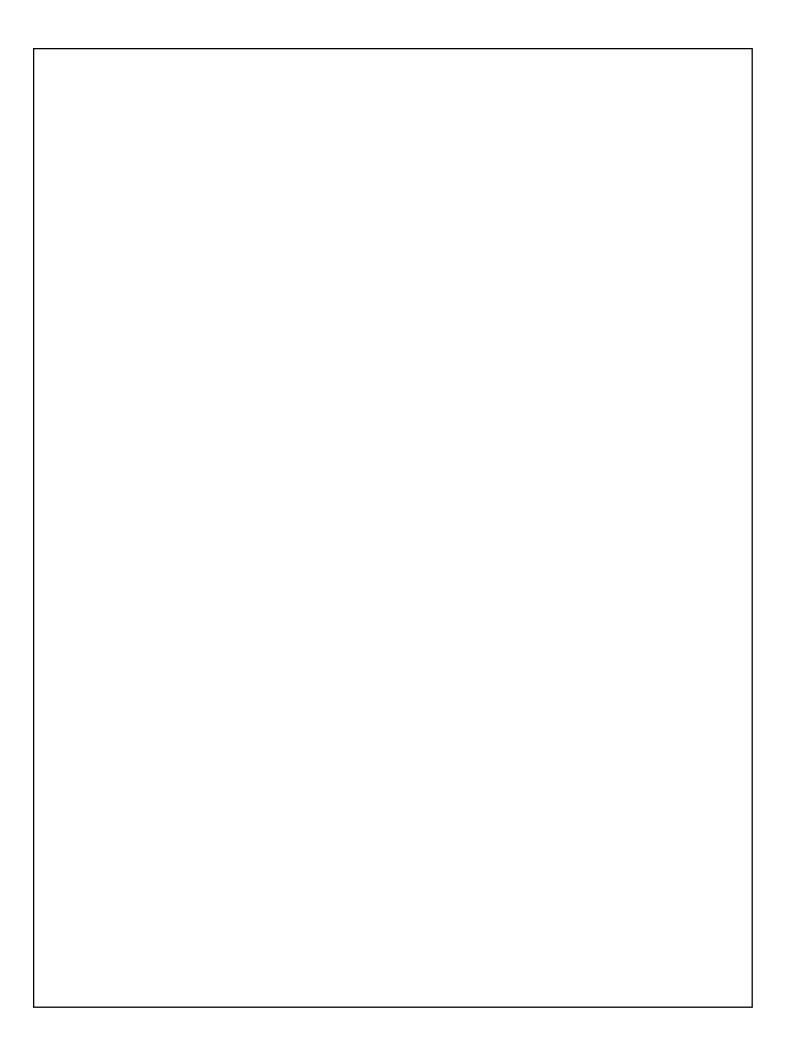
GROUND VIEW OF ALLEY WAY FROM BLAIR ST.
