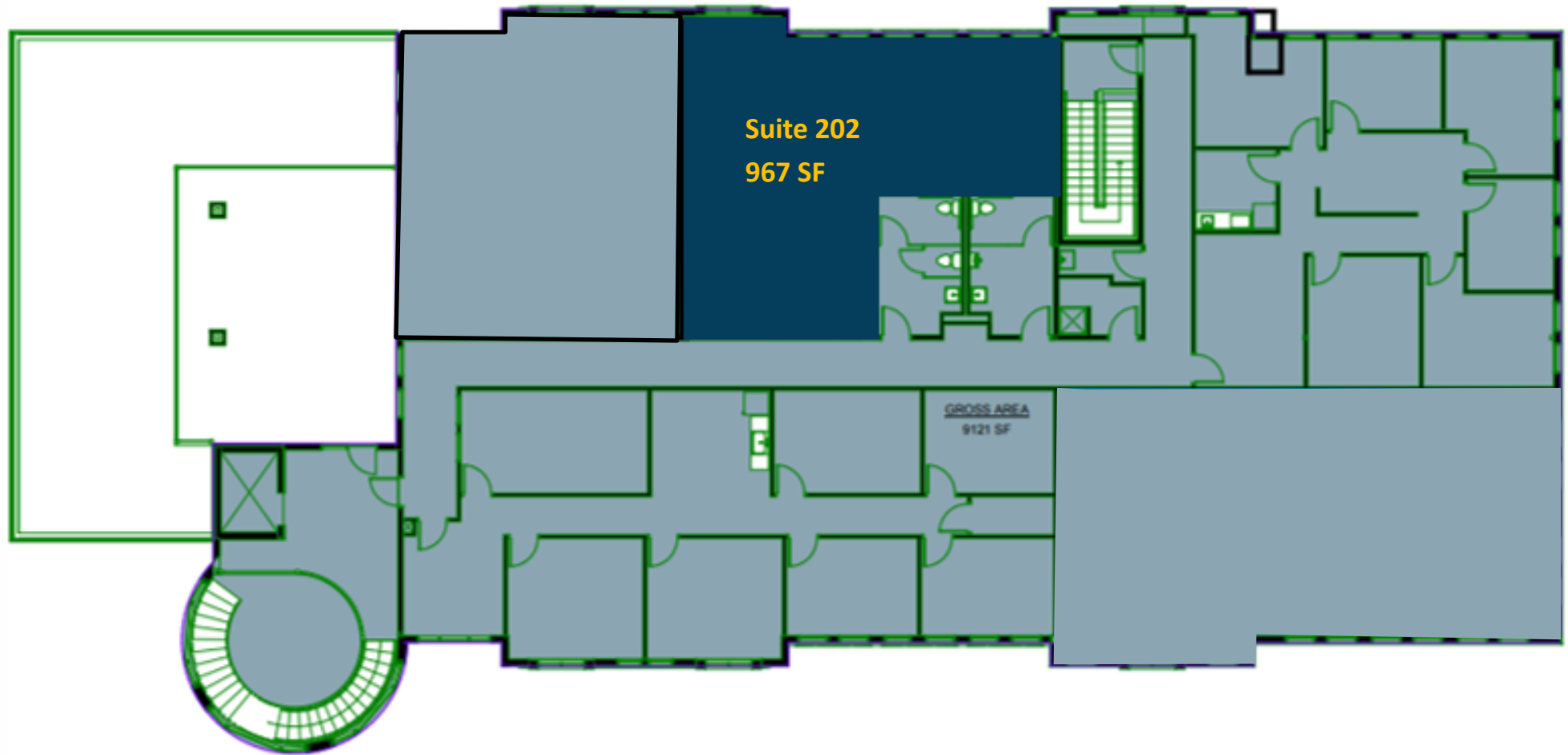

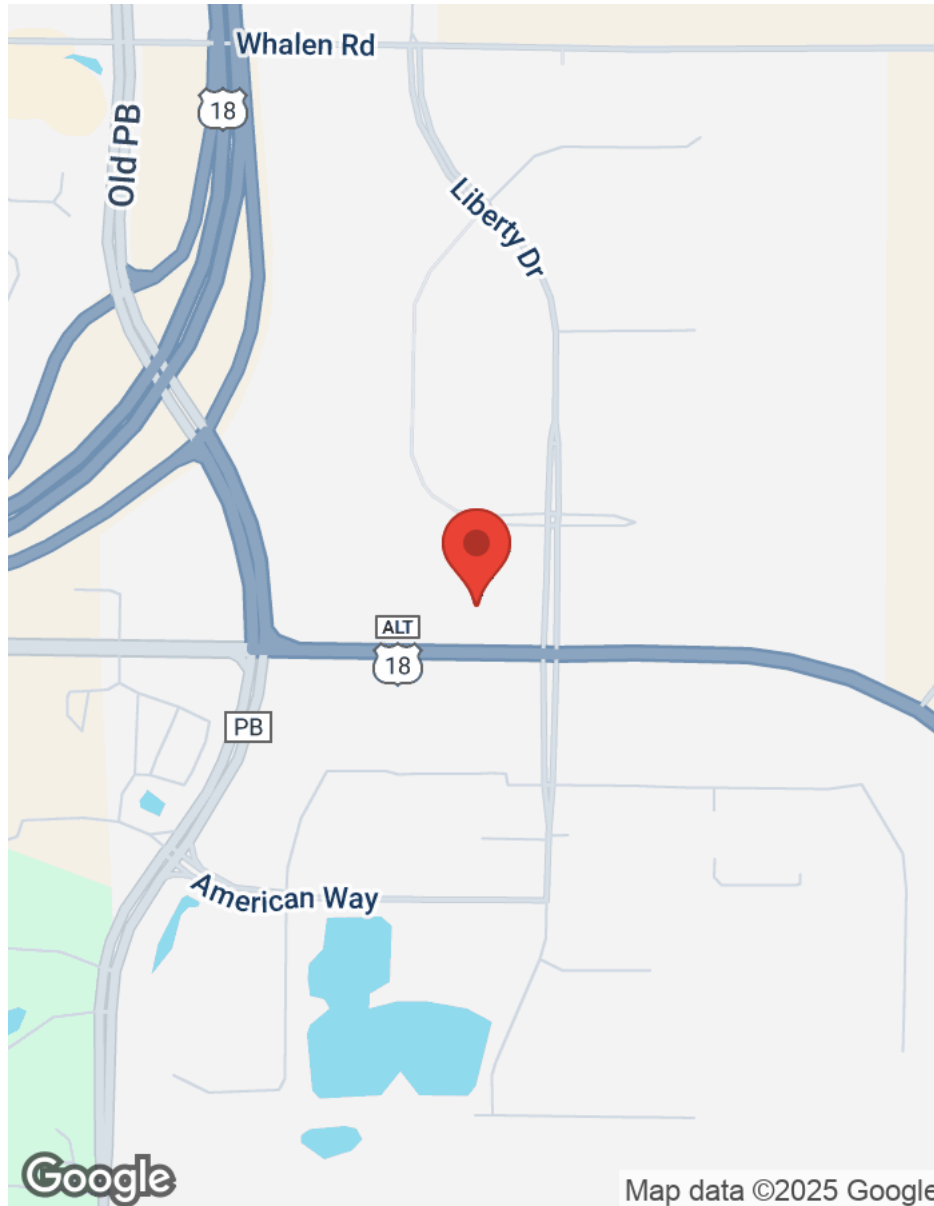

LOCATION MAPS

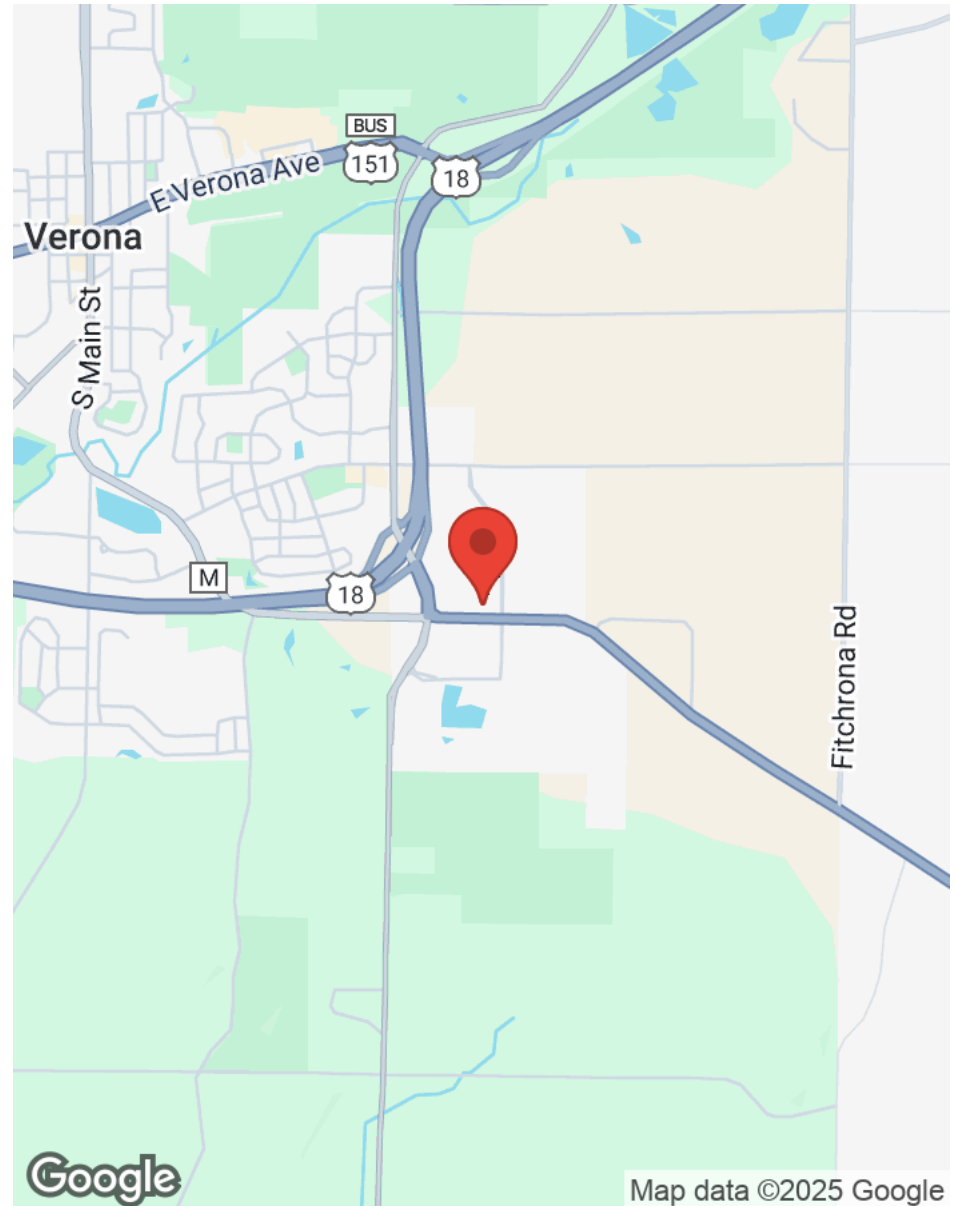

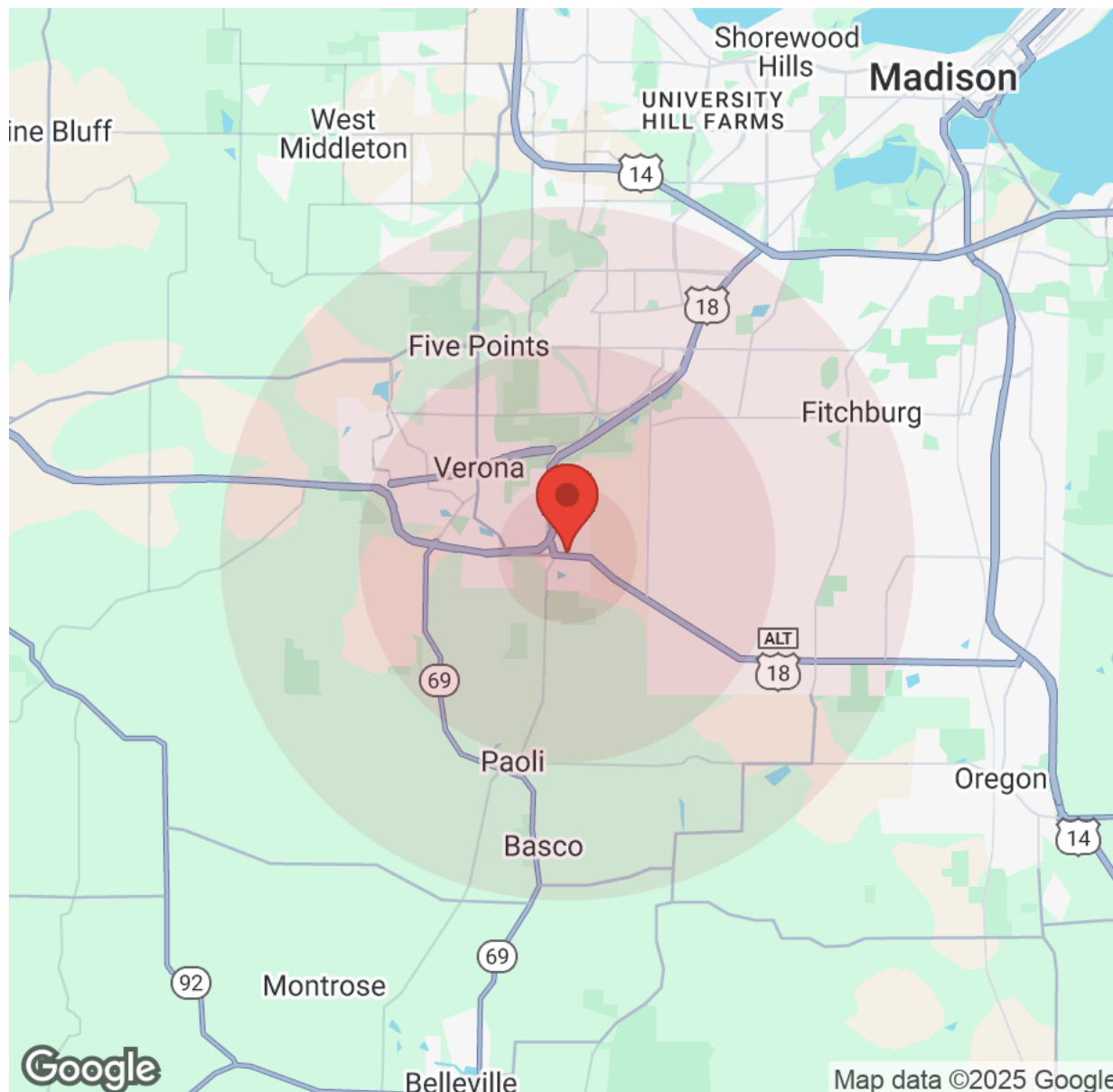
