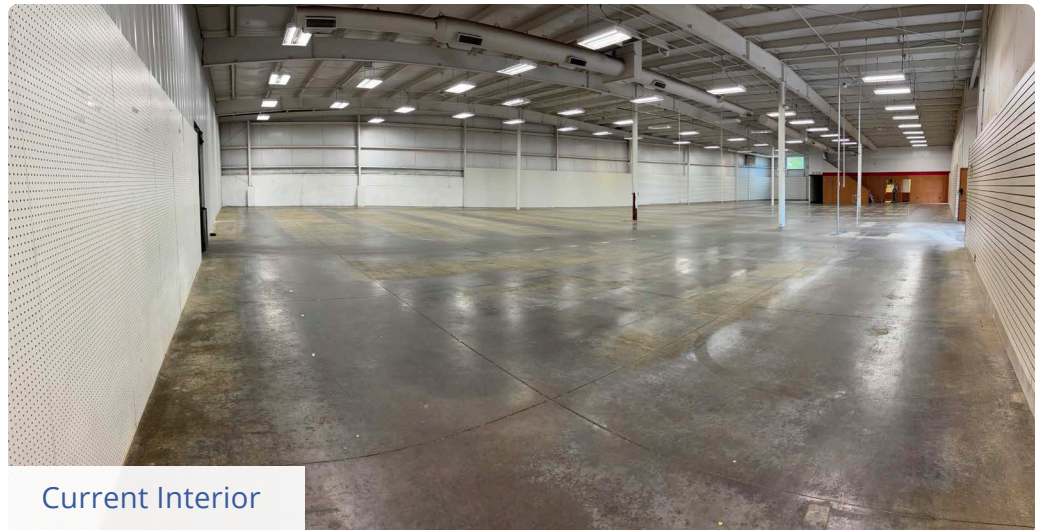

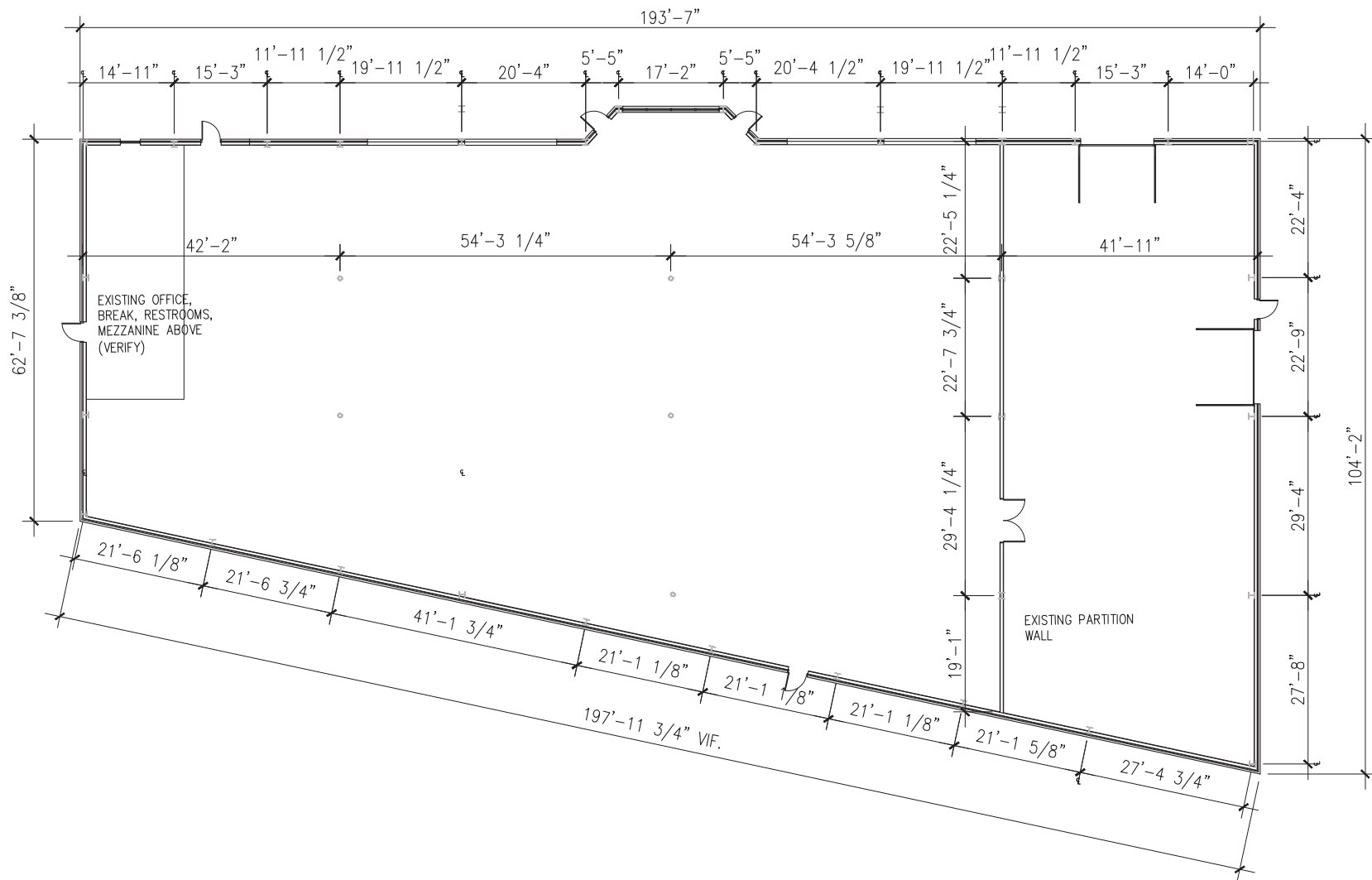

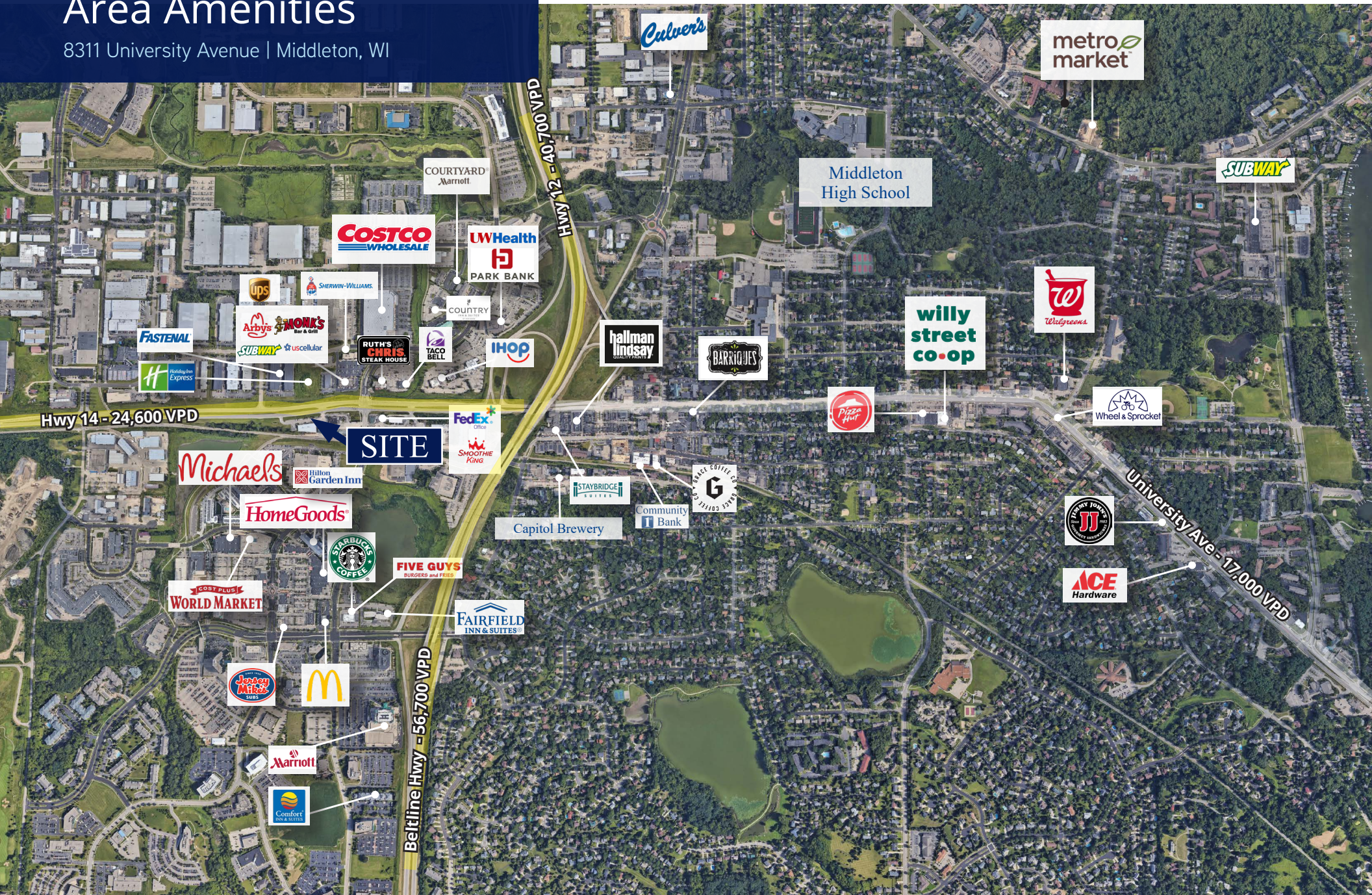
Current Floor Plan

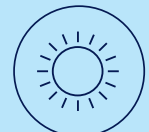
