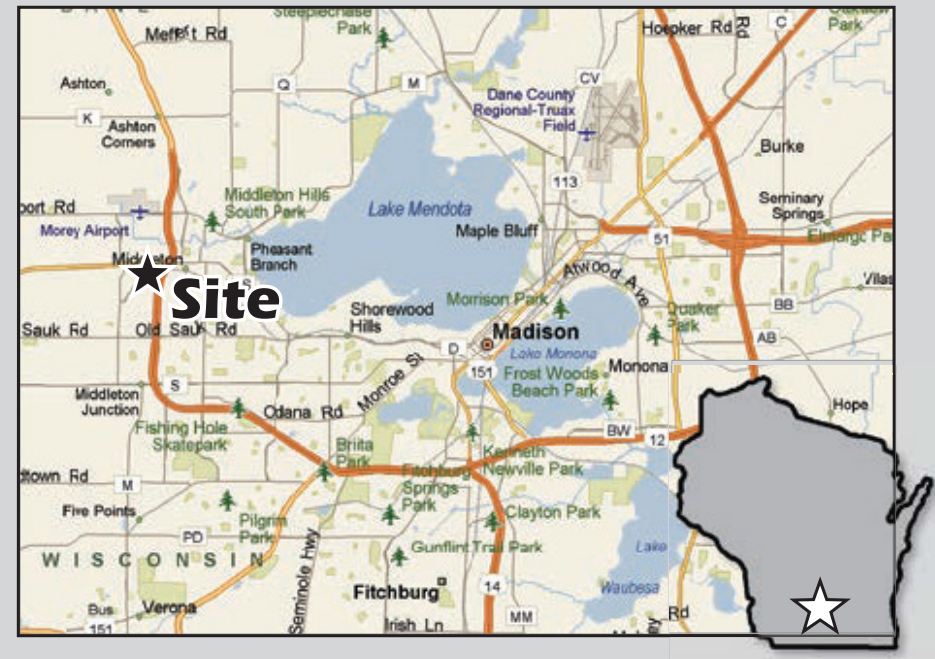

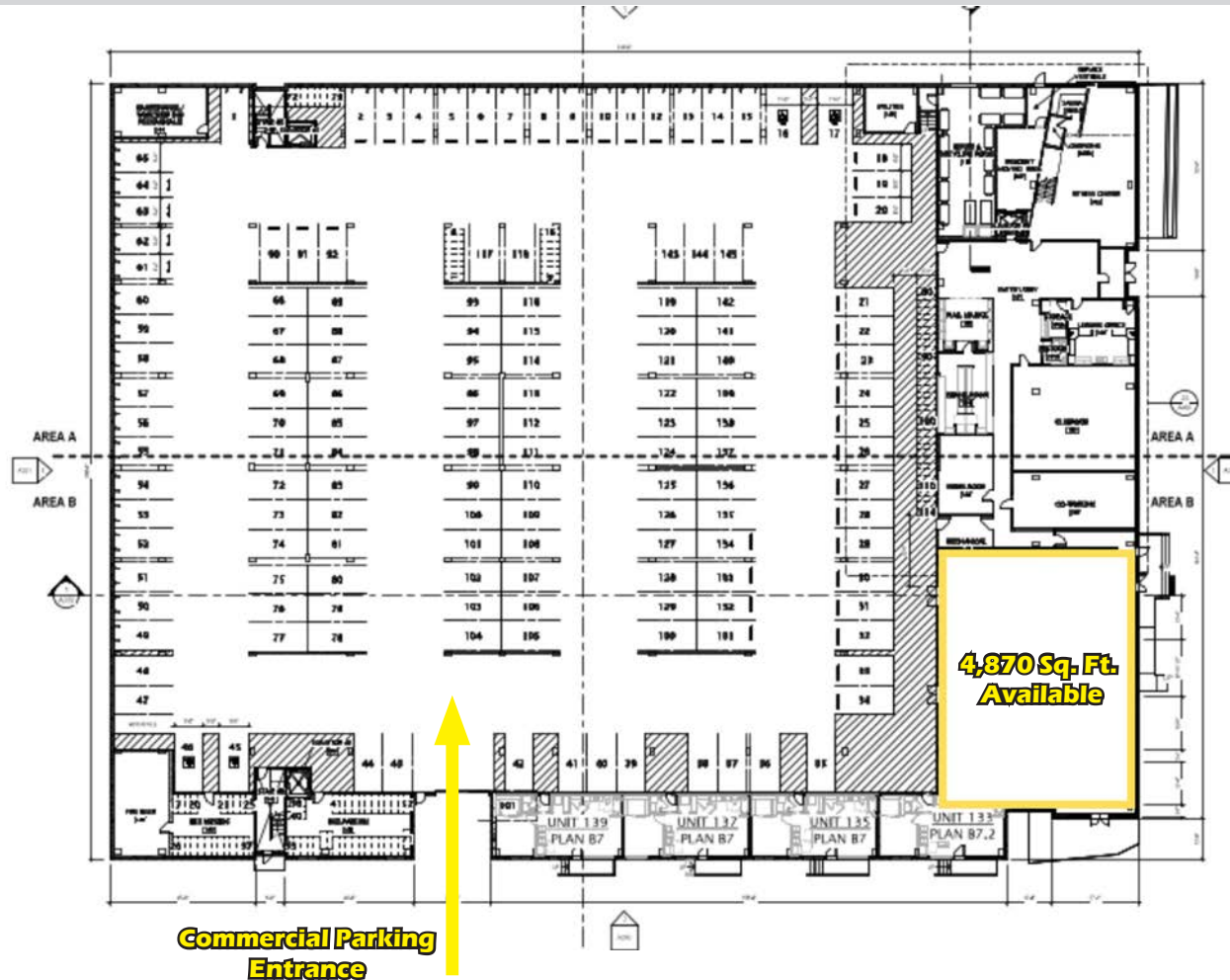

## Site Plan

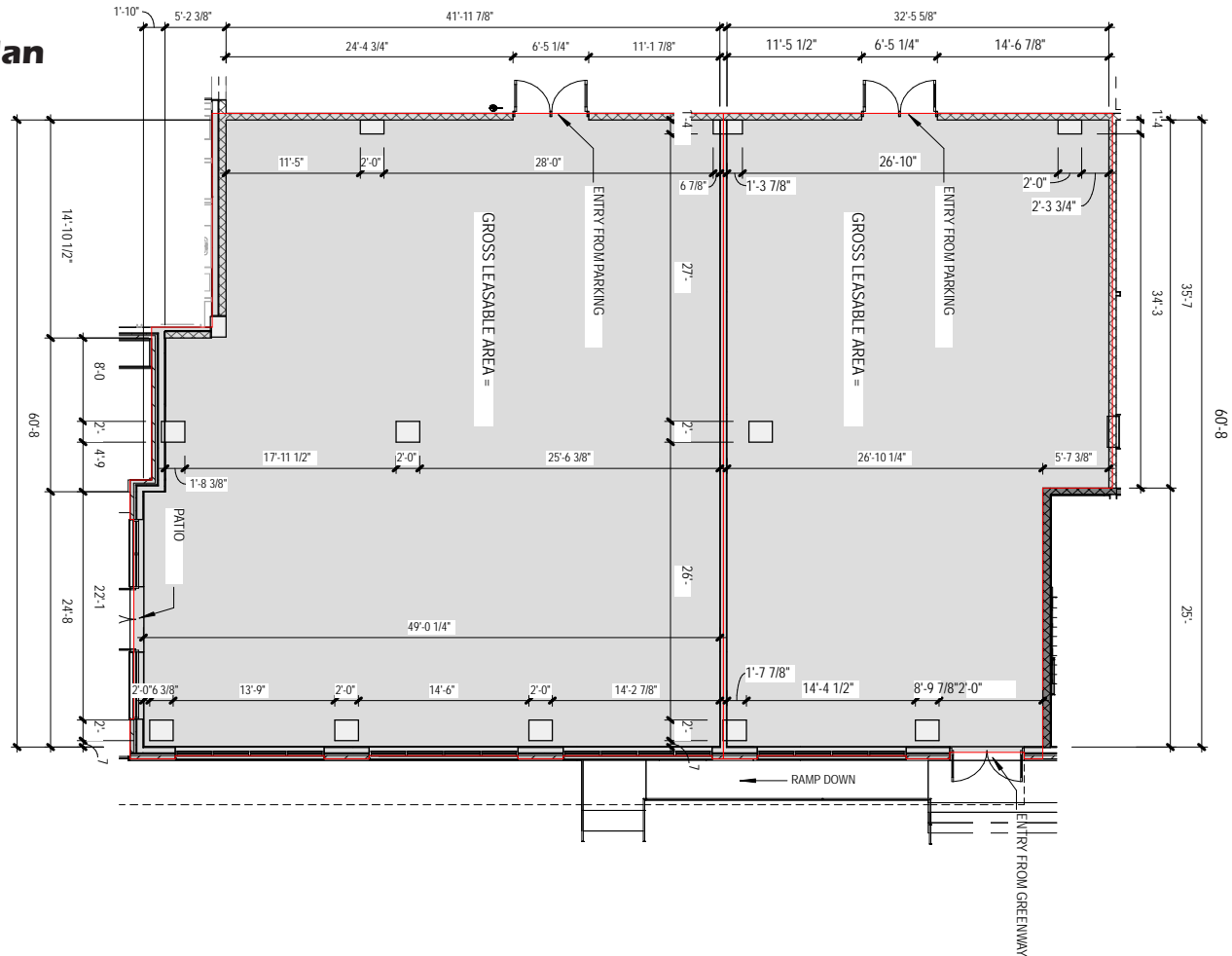
