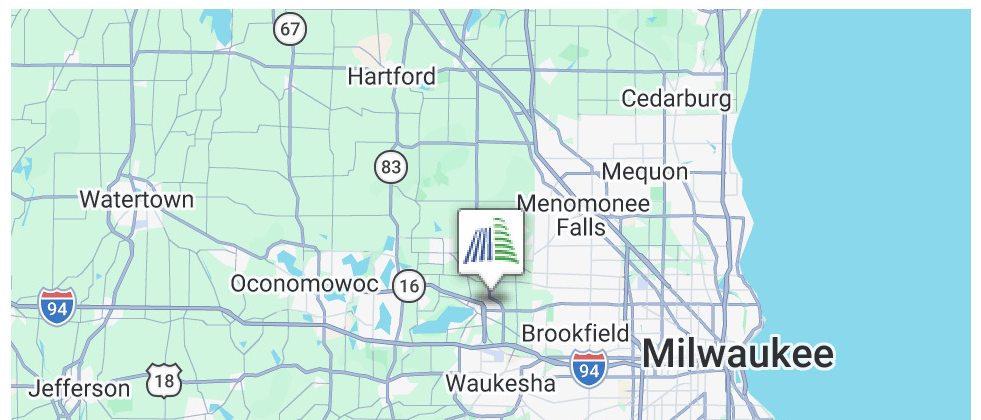

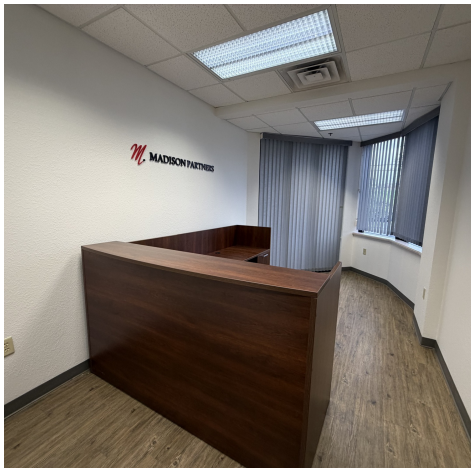
## LOCATION MAP
