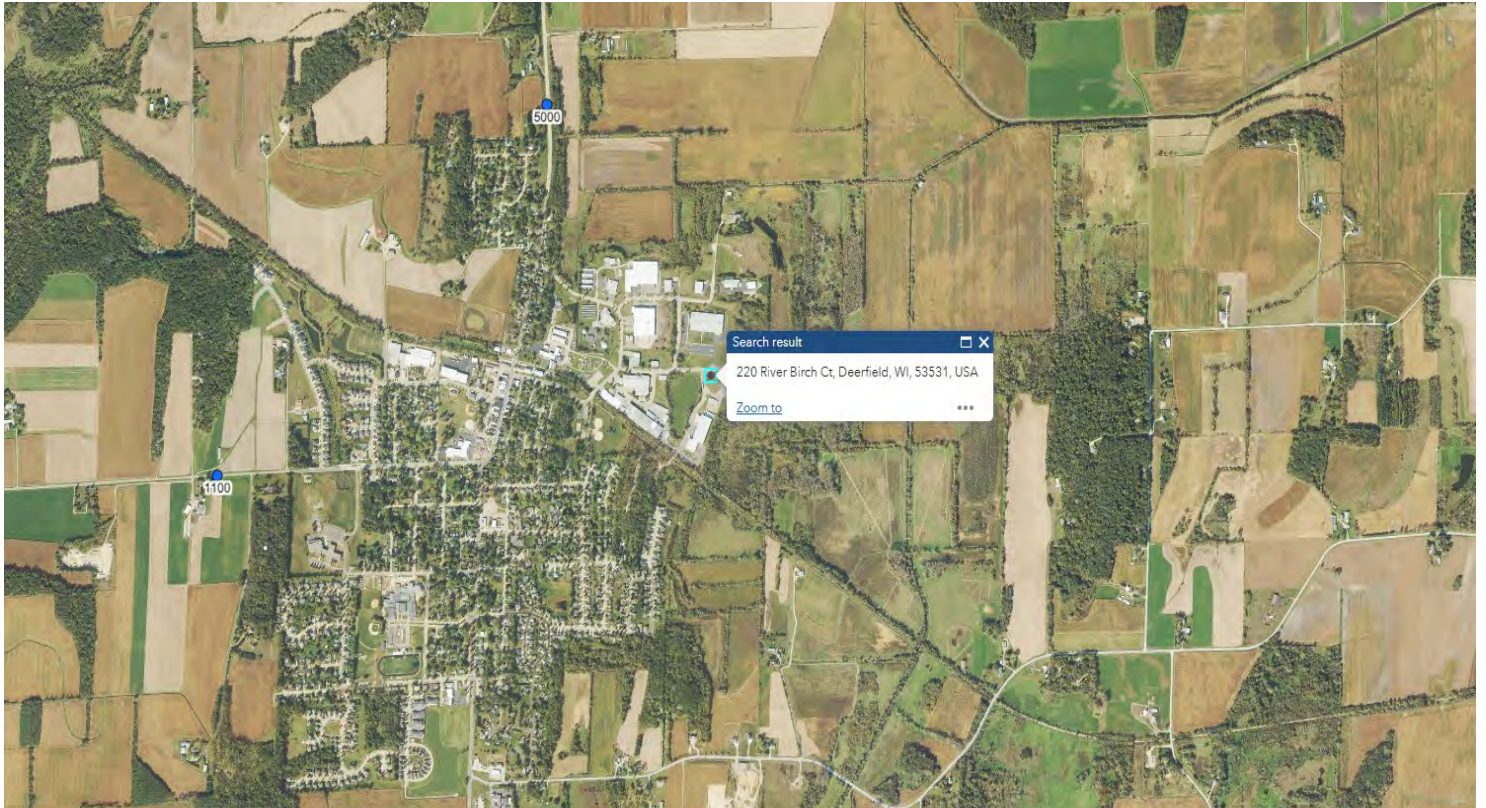




LOCATION / TRAFFIC COUNTS
