Free standing building NNN leased to NASDAQ listed DocGo Inc., DBA Ryan Brothers Ambulance, through 7/31/29 with 2 (1) year options and 3.5% annual increases. 1st floor is 4,850sf with ~2,400sf of nicely finished office space with a mix of open space, offices, and a restroom, and ~2,400sf of clean heated/cooled warehouse space with 15' ceilings, 3 overhead doors, floor drains, water spigots, washer/dryer, and a toilet. 2nd floor has a 1,200sf space with 3 beds, 1 bath, kitchen, lounge/living room area, and a large patio. This could be it's own apartment. Basement has finished office and storage space. Recent updates include a new furnace in 2025, new roof in 2024, ozone sterilization in each HVAC system, cameras (interior and exterior), and remote smart capabilities. 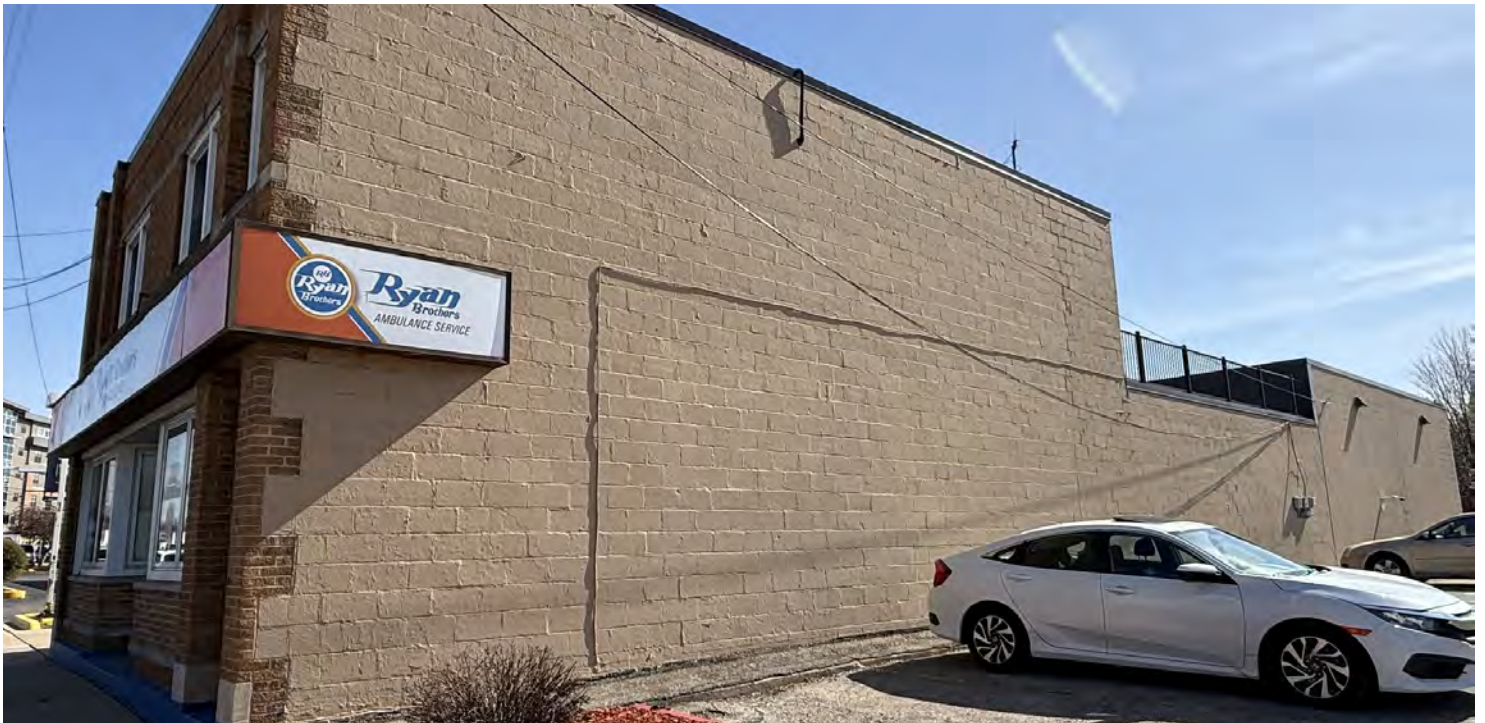

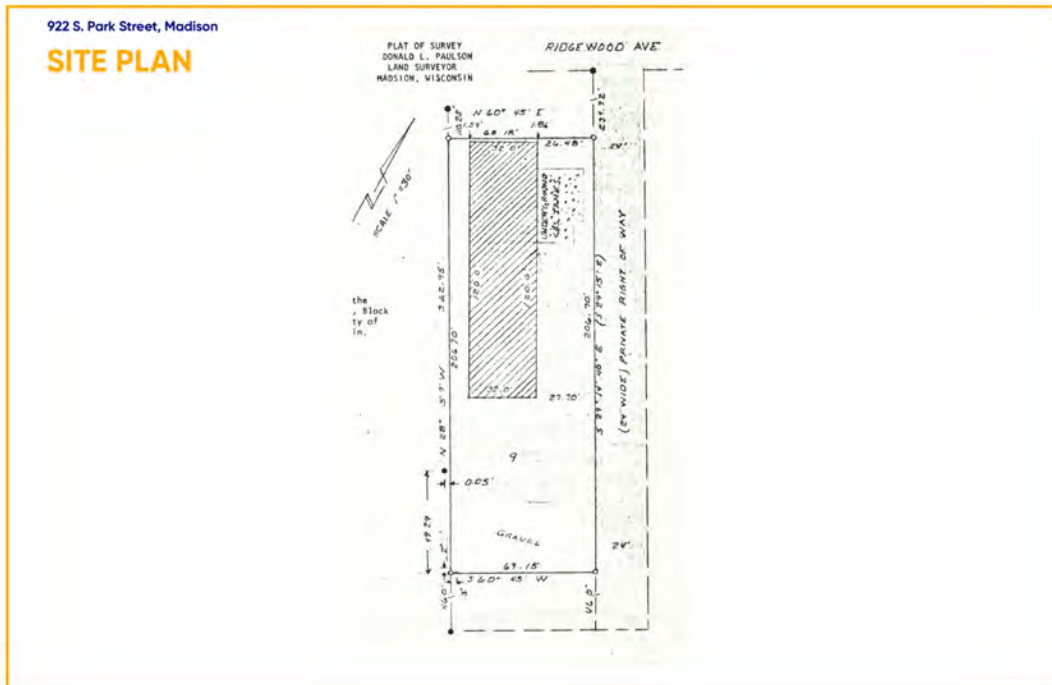
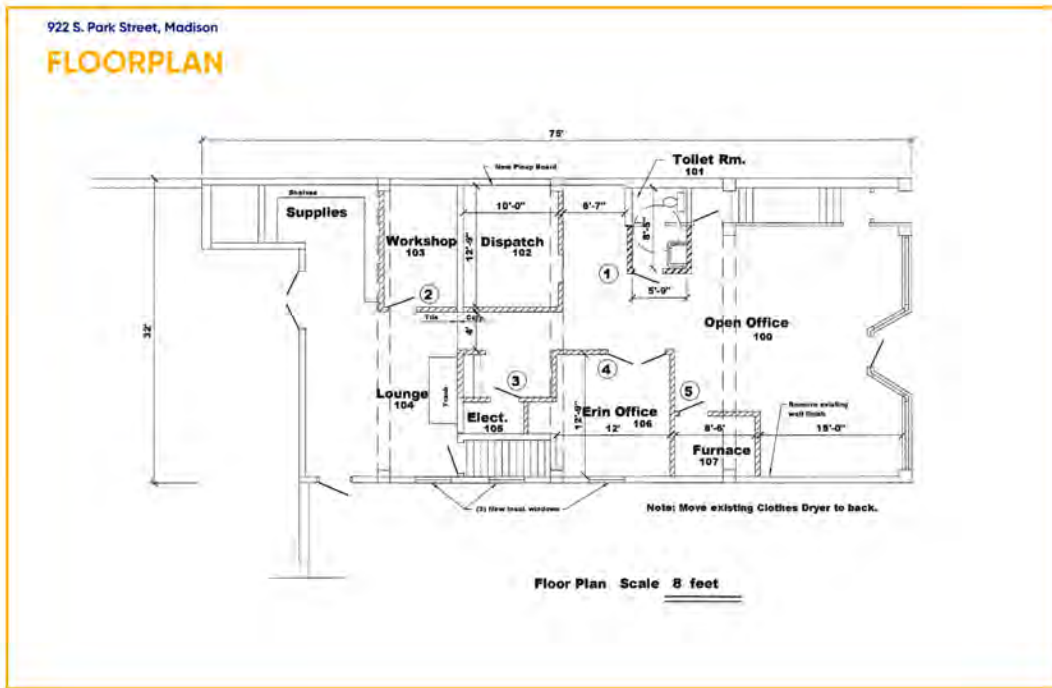


# DOWNTOWN MADISON LOCATION
